Changes elude JS

Negative political culture in one-year-old ninth parliament overshadows timely formation of JS bodies, early good gesture to opposition

Perennial animosities between the ruling and opposition parties have blunted hopes that the ninth parliament would become the main force for change.

Last year, the House saw parliamentary committees formed in the inaugural session and opposition lawmakers given the helm of three standing committees-all for the first time in its history.

But soon the culture of parliament boycott returned and took the shine off those successes.

The main opposition BNP and allies began boycotting the Jatiya Sangsad from the second session in June last year.

First they said they were keeping off the House proceedings to protest the

seating arrangements.

Later, in a departure from the reason they originally cited, the opposition announced they would return to the JS on condition that the government meet their 10-point charter of demand.

The demands include scrapping the decision to cancel the lease of BNP Chairperson Khaleda Zia's cantonment residence, withdrawing cases against Khaleda, her son Tarique Rahman and other BNP leaders, strengthening her security, having two more BNP MPs as standing committee chair, adjourning scheduled business of the House to discuss law and order, price hike of essentials, India's planned construction of Tipaimukh dam and ruling party men's involvement in tender manipulations.

Amid growing public concerns, BNP legislators still remain absent from the House, which steps onto its second year

Similar practice in the past had prevented parliament from functioning effectively. In fifth, seventh and eighth Sangsad, opposition lawmakers boycotted around half the total sittings.

As of Thursday, the ninth parliament had 95 sittings, and BNP-led opposition attended only 23.

In the previous parliament, the then main opposition Awami League joined the House when 70 sittings had already passed.

Jamaat's goals still against constitution

EC asks it to change party charter again to be RPO-proper; Freedom Party to lose registration

The Election Commission (EC) yesterday asked Bangladesh Jamaat-e-Islami to amend its constitution again, as the party's aim and objectives and some other provisions stipulated in it do not conform to the country's yesterday in his office. constitution and RPO.

In a letter to the Jamaat secretary general, the EC pointed out the provisions and asked the party to amend those, said EC sources.

The commission also sent letters to eight other political parties including HM Ershadled Jatiya Party for amending their charters again as well in compliance with the amendits basic structure, they added. Representation of the People Order (RPO).

Freedom Party, formed by a number of killers of Bangabandhu Sheikh Mujibur Rahman, will lose its registration as it failed to submit its ratified amended charter to the EC

within the deadline yesterday.

"We received ratified charters of 38 political parties. Freedom Party did not submit its charter. Therefore, its registration will stand cancelled," Election Commissioner Brig Gen (retd) M Sakhawat Hossain told reporters

Jamaat's call in its charter for establishing the rule of Islam in the country through organised efforts, requires bringing drastic amendments to the basic structure of the country's constitution, said EC officials.

DHAKA RIVER GRABBING

Start demolition within a month

HC asks govt for update every 3 months

The High Court (HC) yesterday directed the government to start within a month demolition of all illegal structures built within the boundaries of four rivers around the capital, so that removal of the debris can be completed by the time stipulated by a previous court order.

The rivers are Buriganga, Balu, Shitalakhya and Turag.

The court also directed officials concerned to submit to it, progress reports of the river reclamation drive through the Supreme Court (SC) registrar every three months, for necessary new court orders.

The HC in June last year issued a set of directives, including one upon the government, to complete by November 30 this year the demolitions and debris removal.

The court issued the June order upon a writ petition in a public interest litigation filed by Human Rights and Peace for Bangladesh (HRPB), an organisation for protecting human rights and the environment. Yesterday's directives were issued by an HC bench of Justice

Syed Mahmud Hossain and Justice Quamrul Islam Siddiqui upon a supplementary petition filed by HRPB President Advocate Manzill Murshed the same day. In December last year, deputy commissioners of Dhaka,

Narayanganj, Munshiganj and Gazipur submitted survey reports on the four rivers to the court.

According to the survey reports, there are more than 8,000 illegal structures in the four rivers and on their banks.

Manzill Murshid yesterday told the HC that the authorities have not yet started demolition of the illegal structures despite the earlier HC directive.

Husband's cruelty forced 15-year-old garment employee Beli to opt for divorce but the separation could not save the teenage girl. Beli is now struggling for life at a hospital as the divorced husband stabbed her brutally in the city's Kalyanpur yesterday.

Doctors stated the condition of Beli Akter, now undergoing treatment at Dhaka Medical College and Hospital, critical with indiscriminate stab injuries. Locals caught the husband, Anisur Rahman, 24, of Kalyanpur

Porabosti where Beli also lives and handed him over to Mirpur police after a good beating. Police recovered the weapon Anis had used for stabbing Beli.

Locals said Anis attacked Beli when she was on her way to workplace NEC Garments on Darussalam Road around 7:30am. "When Beli saw Anis running towards her with a long sharp

weapon in his hand Beli tried to run away but she could not escape," said 23-year-old Monir, who witnessed the incident. "We caught Anis after he had already stabbed Beli several times." Beli's mother Monwara Begum said Anis is a drug addict and often tortured her daughter for dowry and money. Beli divorced

him on December 26 last year.


