#### Multi-donor trust fund to be formed soon

UNB, Dhaka

Bangladesh is going to form a multi-donor trust fund soon for financing schemes for tackling adverse impacts of the global climate change on the country.

State Minister for Environment and Forests Hasan Mahmud said this yesterday after a meeting with Country Representative of Department for International Development (DFID) Chris Austin at his Secretariat office.

"An inter-ministerial meeting will be held on Tuesday to take further step in this regard," he said.

Replying to a question about the Copenhagen Accord capping the recent global climate summit, Hasan said Bangladesh has ratified the accord and decided to take part in further proceedings on the provisional deal.

Meanwhile, the UK has given an assurance of donating £75 million for the multi-donor fund.

## No go-ahead for film archive building

Dhaka City Corporation (DCC) has arbitrarily embarked on road construction across a plot designated for Bangladesh Film Archives in the city's Agargaon administrative zone.

Housing and public works ministry in 1993 allotted the 112.5-katha (1.86 acres) plot in favour of the film archive.

Md Abdul Hai, executive engineer of Public Works Department (PWD), in a letter to the DCC executive engineer (zone-7) on December 20 said the proposed road was shown in an unapproved design and could not be built across the administrative plots.

A Tk 75-crore project funded by Japan Debt Cancellation Fund (JDCF) is awaiting final nod to build a 15-storey archive complex on the plot with modern facilities. But DCC Chief Engineer

Brig Gen Abdul Quadir said the Tk 83.72 crore project of Mirpur Grameen Bank-Agargaon Link Road was approved by Executive Committee of the National Economic Council (Ecnec).

Dr Mohammad Jahangir Hossain, director general of the archive, said he checked with Rajdhani Unnayan

Kartripakkha (Rajuk) and found that the proposed road is not in the Rajuk master plan.

Brig Quadir claimed that Rajuk initially had this road in its master plan but later it nation among the governaltered the plan and did not inform DCC.

SEDITION CASE AGAINST 2 LAWYERS

#### Three more PWs give statements

Three more prosecution witnesses, including the investigation officer (IO) of a sedition case filed against two lawyers on charges of vandalism on the Supreme Court (SC) premises on November 30 in 2006, gave their statements before a Dhaka court yesterday.

The accused lawyers -advocates Subrata Chowdhury and Sheikh Awsafur Rahman -were present in the court during the hearing.

The witnesses who gave their statements are Inspector Akhter Morshed, Sub-Inspector (SI) Nazim Mollah and Sergeant Hossain Shahid Chowdhury. Judge ANM Bashir Ullah of

the Metropolitan Sessions Judge's Court recorded statements of the witnesses and later defence lawyers crossexamined them.

The court also fixed January 31 as the date for the next hearing of the case. The court asked the remaining prosecution witnesses to appear before it on the scheduled date.

During the hearing, Akhter Morshed, also the first IO of the case, told the court that he took over the charge of investigation as per direction from the then officer-in-charge (OC) of Shahbagh Police Station and investigated it till December 11.

Nazim Mollah, the last IO, told the court that he interrogated the complainant, recorded his statements and other witnesses. Later, he submitted the charge sheet against only Subrata Chowdhury and Sheikh Awasafur Rahman on January 6 last year as the charges were found to be true.

He dropped the names of noted jurists Dr Kamal Hossain, Barrister Amir-Ul Islam, Barrister Rokanuddin Mahmud and Barrister Tania Amir from the charge sheet, as the charges brought against them were not proved, the IO said.

#### HC defers hearing till Jan 27

The High Court yesterday deferred till January 27 the hearing on two petitions filed by BNP Chairperson Khaleda Zia and her son Tarique Rahman seeking stay on the proceedings of Zia Orphanage Trust embezzlement case.

The HC bench of Justice Md Abdul Wahhab Miah and Justice Md Abdur Razzaque, which was due to hear the petitions yesterday, deferred the hearing following a time prayer moved by Additional Attorney General AKM Zohirul Hoque.

Khaleda and Tarique, also the senior vice-chairman of BNP, who is now in London for treatment, separately filed the petitions with the HC on November 11 last year to stay the proceedings against them in the corruption case filed by the Anti-corruption Commission.
