Probe to begin in March: Minister

Law Minister Shafique Ahmed yesterday said formal investigation against war criminals would begin by March.

"All infrastructure of special tribunals and the investigation process would be completed by next month," he told reporters at his office at the Secretariat in the city after a meeting with Michael Kozak, senior adviser to the US State Department.

The law minister said all rooms of the old High Court building would be vacated by February 7 to build infrastructure of special tribunals for holding the trial of war crimi-

DISTORTION OF HISTORY

HC directive to stop publishing two textbooks

The High Court yesterday directed the authorities concerned to stop publishing and circulating two textbooks under Bangladesh Open University programme as they contain distorted information on the Liberation War

The books--Sociology 2nd paper and Civics 2nd paper-are on the curriculum for the Higher Secondary Certificate (HSC) programme under the university. The court also issued a rule

upon the government and the related authorities to show cause within a week why the books should not be confiscated and their publications should not be declared illegal.

The HC bench of Justice AHM Shamsuddin Chowdhury and Justice Borhanuddin passed the order upon a writ petition filed as public interest litigation by Supreme Court lawyers Altaf Uddin Ahmed and Mahmud Hossain.

The petitioners stated in the petition that Sociology 2nd paper and Civics 2nd paper of HSC under the Bangladesh Open University described late president Ziaur Rahman as the proclaimer of the independence, although the HC last year in a verdict ruled that it was Bangabandhu Sheikh Mujibur Rahman who declared the independence of

the republic. The books also read that Ziaur Rahman is the greatest son of the country and nation, although the HC termed Bangabandhu the greatest Bangalee of thousand years.

The writ petition stated that the books suppress the historical facts and incorporate false and fabricated information on the declaration of independence.

Advocate Belal Husain Joy appeared for the petitioner.

Hannan Shah threatens movement

BNP standing committee member Brig Gen (retd) Hannan Shah yesterday threatened the government to wage a tough movement against it if it imitates any move to establish one-party rule in the country in line with BAKSAL.

"Bangabandhu Sheikh Mujibur Rahman formed BAKSAL in 1975 to blow up other political parties. In the present time, Awami League is going through the same way and wants to establish its onesided supremacy everywhere by destroying opposition parties. So, we along with our co-minded political parties will take to street to resist them," he said.

Hannan was speaking as a special guest at a roundtable on 'National unity to protect freedom, democracy and constitution' organised by Bangladesh Labour Party at the National Press Club in the city marking 'Bakshal Day'.

The AL government assumed power through placing some false promises behind the people who have understood their tricks. So, the December 29 election is not accountable to the people any more, he said.

About the prime minister's India visit, he said she (PM) had sold out the country's interests to India. "In January 11, when she

signed the deals, BSF had killed one Bangladeshi on the border the same day. But during her talks, our prime minister said nothing about continuous killings of Bangladeshi men by BSF."
