daughter, commits suicide

A young man allegedly poisoned to death his 7-year-old daughter on Saturday night and then killed himself.

At around d 9:00pm Matiar Rahman Moti, 30, poisoned his daughter Mathin at Dharampur Ziladar Para in the town.

Police said goldsmith Moti's wife Sultana, 22, eloped with neighbour Nazmul about 3-4 months ago after an extra-marital affair for several months. Police suspect Moti killed his daughter thinking that Mathin was an illegitimate child.

On the fateful night, a shocked Moti mixed poison with oral saline and asked his daughter to drink it. Later, he also took it and both fell seriously ill.

They were rushed to Bogra Shaheed Ziaur Rahman Medical College and Hospital where they died

Man poisons | 39 injured in bus accident on way to Modhu Mela

Thirty-nine people heading for Modhu Mela, a festival marking the 186th birth anniversary of poet Michael Modhusudan Dutta, were injured in a road accident as their bus overturned on the way yesterday.

The accident occurred on Keshabpur-Sagardari road at noon injuring 10 people critically.

Passenger Shampa said, the recklessly driven vehicle met accident as the driver failed to hold control over the steering wheel near Mojidpur Bridge.

Locals rescued the passengers and sent them to upazila health complex for treatment.

Meanwhile, the weeklong Modhu Mela, organised by Jessore district administration was continuing a Sagardari with different programmes including open stage opera, recitation of poems, children's rally, discussion on life and works of Madhusudan and cultural function.

Traditionally, the fair starts on January 25, the birthday of the famous poet. But this year Modhu Mela opened from January 22 due to SSC examination and other reasons.

There are about 250 stalls at the Modhu Mela ground displaying the famous wooden handicraft of Altapole of Keshabpur mouth-watering Bengal sweets, different types of betel leaves, agricultural tools and many other things

Housewife murdered in N'ganj, 6 killers jailed in Panchagarh, Nilphamari

A housewife was murdered on Monday in Narayanganj while six people got life in Panchagarh and Nilphamari yesterday and day before for killing two housewives.

A correspondent in Narayanganj reports: Jannatul Ferdousi Jenny, 18, a housewife was strangled allegedly by her in-laws in Naluapara area early Monday.

Jenny's in-laws went into hiding after the incident.

Police recovered the body and sent it to Narayanganj General Hospital morgue for autopsy.

Jenny's father Joynal Abedin said, her daughter was married to Badiuzzaman Badsha, son of Badrul Rahman of Naluapara a year ago. Joynal claimned he gave ten tolas of gold ornaments and Tk 4 lakh to Badsha as dowry at the time of the marriage. But after a few days her in-laws started torturing Jenny physically and mentally for more dowry.

He said, Jenny's in-laws called him over cell phone Monday morning saying Jenny was feeling unwell. But Joynal went there only to find his daughter dead.

Joynal alleged that Jenny's in-laws killed her over dowry dispute.
