# Eastern bypass left in cold storage

Work hasn't started 12yrs after approval; estimated cost spirals by Tk 1,000cr

Implementation of the Dhaka Integrated Flood Control Embankment -- Eastern Bypass Road Multipurpose Project or the Eastern Bypass Project -- is yet to start 12 years after it was approved.

According to sources in Water Development Board (WDB), which initiated the project, its estimated cost has over the years risen to around Tk 3,000 crore from Tk 2,000 crore.

The project, okayed by the Executive Committee of National Economic Council in 1998, envisages building a 30kilometre-long dyke-cum-bypass road along the Turag and Balu rivers on the eastern fringe of the capital. The bypass will encompass124 square km of fast-

growing urban and semi-urban areas between Tongi railway bridge and Kanchpur bridge.

Official sources said failing to find a financier for the project, the government recently asked the WDB to break down its components and distribute those among other agencies such as Rajuk, DCC, Department of Environment, and Roads and Highways Department for implementation. The idea is to reduce cost and facilitate financing.

"Almost every year since the project was put into Annual Development Programme in 1998, we have to revise and update it," said a top official of the WDB.

He noted that without the eastern bypass, a vast area on the capital's eastern fringe remains unprotected from recur-


ringflooding.

As per the government's recent decisions, seven ministries with the water resources ministry in the lead will implement the project. Besides protecting a vast area from floods, the project will help expand the city and divert east and southbound traffic from northern region of the

Contacted, WDB Chief Engineer (central zone) Md Humayun Kabir said work on the bypass project began with the help of the Engineering Corps of Bangladesh Armed Forces in 1998 but never got

Initially, the concept was to build embankment by dredging the Balu river. "But it was abandoned when we found

## Govt to seek one more year for tannery relocation

Finds ministry report "not convincing"

A parliamentary body yesterday expressed dissatisfaction over price hike of rice and formed a sub-committee to find out reasons behind it as the explanation of the food ministry was not "convincing".

Ministry officials told the parliamentary standing committee on food and disaster management ministry the hike was temporary as rice mills could not operate in full swing due to dense fog.

"We're not satisfied with the ministry's explanations on the price hike of rice. There is no reason for price hike at this moment after bumper production of IRRI and a healthy stock of rice in the government's granaries," Muhammed Sayedul Hoque, chief of the parliamentary body, told The Daily Star after a meeting.

He said 11 lakh tonnes of food grains including 10 lakh tonnes of rice is in the government granaries and import of seven lakh tonnes wheat and 50,000 tonnes rice is underway.

Oppose changes in vested property return law

In an unprecedented move, a high profile meeting of lawmakers yesterday rejected all proposals approved by the cabinet for amending the Vested Property Return Act 2001, saying if translated into law, it will go against the country's minority community.

Chaired by Deputy Leader of the House Syeda Sajeda Chowdhury, the meeting termed the proposals unnecessary and said if enacted, the law will also destroy the basic spirit of the original act passed by the Awami League-led government in 2001, meeting sources said.

The law and land ministers, chiefs of parliamentary standing committees on law, land and education ministries and senior officials of the land ministry attended yesterday's meeting, an

extraordinary one as such meeting was never held in the country's parliamentary history. The meeting decided to enforce the act of

2001 by bringing some minor amendments to it. A number of senior parliamentarians present at the meeting expressed surprise as to who

drafted the proposals and how they managed to get the cabinet's nod, the sources said. The cabinet approved the Vested Property Return (Amendment) Act last November under


which vested properties of the minority community members are supposed to be returned Incorporating the proposals, a bill was supposed to be placed in parliament on January 11,

but following objections the land minister at the eleventh hour declined to submit it.
