# Nation rids itself of stigma

5 executed killers of Bangabandhu buried at their village homes

The five executed killers of Bangabandhu Sheikh Mujibur Rahman were buried yesterday following the hangings in Dhaka Central Jail in the first hour of the day.


They were buried at their ancestral village homes. Five ambulances, escorted by Rapid Action Battalion and police, transported the bodies to the burial sites.

Sultan Shahriar Rashid Khan was buried at Gopinathpur of Kashba upazila in Brahmanbaria, Syed Farooq Rahman at Marma Mallikpur village in Naogaon, Bazlul Huda at Hatboalia village of Alamdanga upazila in Chuadanga, and AKM Mohiuddin Ahmed and Mohiuddin Ahmed at Neta and Nijkata villages respectively under Golachipa upazila in Patuakhali.

Prime Minister Sheikh Hasina offered shokrana namaz and recited from the holy Quran in her official residence Jamuna after the executions.

Hasina, one of the two surviving daughters of Bangabandhu, expressed deep satisfaction over the executions, and called upon the people as well as her party leaders and activists to resist any conspiracy with patience.

Awami League leaders and activists led by Deputy Leader of the Parliament Syeda Sajeda

The House of the Nation yesterday expressed deep gratitude to the Almighty for the executions of five killers of Bangabandhu Sheikh Mujibur Rahman.


Speaker Abdul Hamid said the nation got rid of a stigma through the implementation of the court verdict in the murder case.


"Now we are relieved. We will now be able to die in peace, without remorse," the speaker said in a brief speech at the beginning of yesterday's sitting of the parliament.

## Green light to explore onshore HC vacates 9-year injunction

The High Court in a verdict yesterday cleared the way for exploration of oil and gas from the country's onshore blocks by vacat-

ing its nine-year old injunction on such exploration. The court also discharged a 12-year old writ petition that challenged the government move to sign production-sharing contract (PSC) with foreign gas and oil exploration companies. The HC judgment paves the way for the government to sign

PSC for oil and gas exploration. The injunction prevented opening any onshore blocks to

international companies for oil and gas exploration under any PSC since 2001. The country had signed several PSCs with some foreign oil

companies in the 90s through two rounds of block biddings. These oil companies now meet more than half of country's gas requirements. Former secretary Shah Abdul Hannan, columnist Sadek

Khan, journalist Amanullah Kabir, and Prof Abdur Rob jointly filed the writ petition with the HC as public interest litigation in

The petition sought HC directive on the government to formulate a National Strategy Policy through parliament before leasing out gas blocks to protect the country's interests.

Following the petition, the HC in 2001 issued an injunction on oil and gas exploration from the country's onshore blocks.

## SEA BOUNDARY WITH INDIA

India and Bangladesh yesterday discussed the appointment of three arbitrators to a five-member tribunal, which would deal with the issue of maritime boundary dispute between the two countries. The over-an-hour-long meeting held at the South Block here

also discussed the disputes and issues relating to Bangladesh's

approaching the UN Convention of the Laws of the Seas (UNCLOS). The meeting was held as a "fulfilment" of the declaration by the two countries in the Joint Communiqué, issued after Bangladesh Prime Minister Sheikh Hasina's visit to Delhi from

January 10 to 13, with both sides pledging to sort out the maritime boundary issue amicably. Both India and Bangladesh have nominated one arbitrator

each and the meeting discussed the issue of three other arbitrators, sources here said. However, the meeting did not discuss the more complex

issue of criteria like "equity" or "equal distance" or a combination of both in demarcating the territorial waters in energy-rich Bay of Bengal, which had given rise to the dispute.
