# Bring to book culprits who attacked Larma: PCJSS

Leaders of Parbatya Chattagram Jana Sanghati Samity (PCJSS) have demanded punishment to the criminals responsible for Wednesday's attack on indigenous leaders in Chittagong Hill Tracts (CHT).

The motor convoys of CHT Regional Council Chairman Jyotirindra Bodhipriya Larma, popularly known as Santu Larma, Chakma Circle chief Devasish Roy and Rangamati Hill District Council Chairman Nikhil Kumar Chakma came under attack at different places on their way to Khagrachhari Circuit House where they were scheduled to attend a meeting of CHT Land Commission.

Santu Larma, also the president of PCJSS, and four of his companions sustained minor injuries as shards of glass from a car windowpane hit them during the attack.

PCJSS yesterday brought out a procession in Rangamati town and held a rally on the premises of deputy commissioner's office in protest against the attack, reports our Rangamati correspondent.

The armed cadres of United Peoples Democratic Front (UPDF), an anti-peace treaty organisation, made the pre-planned attacks on PCJSS leaders on Wednesday, speakers said at the rally.

#### TENGRATILA GAS EMISSION

## 3 families asked to leave home for safety

A Bapex team yesterday visited the areas around the abandoned Tengratila Gas field where emission of gas through leakages has gone up. They advised the inmates of three families near the gas field to stay away from their homesteads

Locals informed the Bapex team that gas emission through the leaks around the abandoned gas field has gone up. A leakage point beside the house of one Emran Hossain caught fire on Thursday night. The fireball leapt about 6 to 7 feet, locals said. However, they extinguished fire after an hour. Emran Hossain and his family members left their house for safety reasons yesterdaymorning.

The team member said they will submit a report to the managing director within a day or two. Doarabazar Upazila Chairman Abdul Quddus was also present at the time of Bapex team's visit.

Bapex MD Golam Martuza Hossain told this correspondent over cellphone that a three-men team had visited a number of private houses near the Tengratila Gas Field. They observed gas emission through several leaks, he added. Receiving gas emission report, the MD had earlier sent a technical team from Sylhet to visit the area.

emission through leaks around any gas field is not unusual. But people should remain alert about use of firebox or any other source of fire, he said. Niko people have also been informed of Thursday's incident, the Bapex chief added. Tengratila Gas Field

exploded with a big bang on the night of January 7 in 2005 when Canadian company Niko was engaged in drilling a well, causing destruction to huge gas and leaving a trail of devastation in the surrounding area.

The huge gas field location now gives a deserted look, except a few guards.

Another serious blow-out took place on the night of June 24 in 2005 as the Canadian company was running a relief well drilling at the remote location in Doarabazar upazila of Sunamganj district. It was being drilled to seal the original one, which had suffered a huge blow-out on January 7 that year.

Trees got burnt, croplands damaged and thousands of people had to be shifted from their homesteads. The huge fireball leapt 150 feet over the gas field and forced thousands to flee their homesteads.

The raging flames at Tengratila Gas Field, which were visible from even 30 kilometres away, took about The Bapex chief said gas two months to go down totally.

#### Youth beaten to death

A youth was beaten to death yesterday morning by criminals at south Khejurbagh in South Keraniganj. Victim Al-Amin, 25, is son of Kiran Mia of Kanapatti Par Gendaria village. Quoting witnesses, police said 7-8 armed criminals including Azizul, Abul, Tuhin and Mujibar abducted Al-Amin from his house at 9:00am. They took him to the south Khejurbagh area and beat him to death after tying up his hands and legs. Later, they also gouged out his eyes. On information, police recovered the body and sent it to Mitford Hospital morgue for autopsy. A case was filed.

#### Fertiliser seized: 2 held

Rapid Action Battalion (Rab) yesterday recovered 46 bags of smuggled Indian fertiliser from a godown at Fatamohammedpur village in Ishwardi upazila. Rab arrested two workers but the owner of the warehouse went into hiding. Acting on a tip-off, a Rab-12 team and police jointly raided Abdul Latif's godown and recovered the banned MOP fertiliser. The arrestees are Md Hatem Ali and Md Abdul Malek. They were repacking the smuggled fertiliser for marketing, Rab sources said.

#### Loan defaulter jailed

A tribunal here on Thursday sentenced a man to one year rigorous imprisonment on charge of loan default. Convict Amir Hossain, owner of Arafat Paints and Hossain Traders in the city, was present on the dock when the judge pronounced the verdict. The court also fined him Tk 36,54,101, in default, to suffer one month more in jail. According to the prosecution, Amir Hossain took an amount of Tk 12,18,033 as loan from the branch of Al Arafa Islami Bank in 2004. But he failed to repay the installments of the loan. Six cheques given against the installments were also dishonoured by the bank. The bank lodged a case against Amir on February 24, 2005.

Manikganj Sadar police on Friday night arrested a life term fugitive convict from his father-in-law's house at east Khalilpur village under Harirampur police station. Acting on a tip-off, assistant sub inspectors Habibur Rahman and Khairuzzaman went to the spot and arrested Salam, 55, son of Wajuddin of Bhararia village in Manikganj Sadar upazila at around 9:00 pm, officer-in-charge (OC) of Manikganj Sadar police station Azizul Haque said. On August 31 in 1996, Additional District and Sessions Judge sentenced Salam to life term rigorous imprisonment (RI) and fined Tk 20, 000, in default, one year more RI for killing his sister's husband and robbery at his house at Baitora village in 1992.

#### Four get life in Habiganj

A court in Habiganj town on Thursday afternoon sentenced four people to life term imprisonment for hurling acid on a housewife. The convicts are: Sazid Miah, Yakub Miah, Nahid Miah and Farid Miah (absconding). The district and sessions judge of Habiganj, Mahbub Ul Alam passed the judgement. Prosecution story, in brief, is that the accused on January 31, 2007, locked in a dispute with Parveen Akhter, wife of Tota Miah, over an approach road at their Paikura village in Chunarughat upazila. The accused later on February 1 entered the house of Parveen by breaking open the doors and hurled acid on her at about 2:30 am injuring her seriously. Victim's son Ful Miah filed a case with the Chunarughat police station the next day.

#### Procession, human chain on campus protesting Friday's attack

Police yesterday filed a case accusing more than a hundred students of Rajshahi University of Engineering and Technology (Ruet) of attacking law enforcers on Friday.

Identifying 11 students, sub inspector (SI) Arifuzzaman filed the case with Motihar police station and stated in it that at least 22 members of law enforcers including officer in charge (OC) of Motihar police station received injury in the attack.
