## Hold UP polls in time

Forum leaders urge govt

Leaders of Bangladesh Union Parishad Forum (BUPF) yesterday urged the government to hold union parishad election in time amending some provisions of the Union Parishad Act 2009.

They were speaking at a press conference at Dhaka Reporters Unity demanding amendment to

Section 73 (1) and Section 34 terming them an insult to people's mandate.

They also stressed the need to demarcate area of wards as per population percentage mentioned in Section 13 before holding the election.

They said development work would be hampered if the government demarcate the area after the election ignoring Section 13 of the Union Parishad Act. They said there is no government move to demarcate the area though four months have already passed since enactment of the law.

Md Mahbubur Rahman Tulu, chairperson of the forum, said Section 73 (1) of the Act authorises local administration to give directive to UP on its activities. It goes against the spirit of empowering the local government body since the UP representatives are elected directly by the people, he added.

Besides, Section 34 of the act contains the provision for suspending a union parishad chairman if a case is filed against him or her, if police submit charge sheet and the caseisacceptedbyacourt, hesaid.

Abdur Razzak, joint secretary of the forum, Jamil Ahmed, Head of Programme at the Institute of Governance Studies, Brac University, Wazed Firoz, Programme Director, Democracywatch were present at the briefing organised by BUPF, Promoting Governance, Accountability, Transparency and Integrity (Progati) in cooperation with USAID.



Afterwards, 1600 warrants that still remained at the refund center were sent to the applicants' addresses through registered post on February 3, 2010 with approval from the SEC. Hence, the distribution process of refund warrant on behalf of Grameenphone has been completed.
