Migratory birds fluttering, twittering at Baikkabeel

A large number of tourists are thronging Baikkabeel, a birds' sanctuary in Hailhaor wetland covering areas in Srimongal and Sadar upazilas in Moulvibazar district, as the sanctuary with immense natural beauty now buzzes with chirping and fluttering of migratory birds.

Management of Aquatic Ecosystem through Community Husbandry, a non-governmental organisation, conducted a survey in 100 acres of land in Baikkabeel in 1999 and declared the water body 'an area rich in biodiversity'.

Bird Life International, another NGO, had included Baikkabil in its international list fruitslike makna. of birds' habitats. Following initiatives of the two

organisations, the Ministry of Land decided to keep Baikkabil as a 'permanent sanctuary of birds and fish' in 2003 and imposed ban on irrigation and fishing with nets in this wetland. Consequently, work to create a

complete sanctuary started and strict measures were taken to check indiscriminate fishing and irrigation in this wetland. Baikkabil, now a safe haven for

birds and fishes, is also resourceful Baikkabil to preserve its resources

with different aquatic flowers including shapla and lotus and aquatic

Over a hundred species of birds inhabit Baikkabil during different periods of the year, says report of a recent survey conducted by eminent bird researcher Dr Enam al Haque, according to sources at Resource Management Organisation (RMO).

In this winter season, about 12 thousand birds of 40 species gathered in the water body from November 2009 to January 2010, says the survey report.

"Measures have been taken to preserve aquatic lives and birds here. A well-equipped observation tower has also been installed with the financial assistance of the USAID. Any tourist can use this tower for bird watching on payment of fees. One can also have a boat ride to see Baikkabil from different points," said Minnat Ali, an RMO worker employed to look after Baikkabil

Judicial probe, arrest of culprits demanded

Indigenous people yesterday formed a human chain in front of the deputy commissioner's office at Rangamati demanding judicial inquiry into the attacks on Santu Larma, Raja Debasish Roy and Rangamati HDC Chairman Nikhil Chakma in Khagrachhari and Rangamati on January 27.

They also demanded immediate arrest of the culprits involved in the attacks, implementation of the CHT peace accord without further delay, formation of a separate land commission to settle land disputes in plain land and constitutional recognition of jummo people, according to

our Rangamati correspondent. Rangamati Sachetan Nagorik Samaj (RSNS) organised the human chain and then submitted a memorandum containing the demands to the home minister through the deputy commissioner.

Chairman of CHT Regional

Council Jyotirindra Bodhipriya Larma alias Santu Larma, Chief of Chakma Circle Raja Debasish Roy and Rangamati Hill District Council Chairman Nikhil Kumar Chakma, came under attacks by unknown criminals at three separate places when they were going to Khagrachhari to attend a meeting of CHT Land Commission on January 27. They also demanded arrest and

exemplary punishment to those who attacked Sanjeeb Drong, secretary general of Bangladesh Adivasi Forum (BAF), in Netrokona districton January 22.

Our Khagrachhari correspondent reported that United People's Democratic Front (UPDF) yesterday demanded permanent solu-

Sixth Additional Sessions Judge Aminul Haq pronounced the verdict acquitting the then top leaders of the charges of abducting Shibir activists Habibur Rahman and Ainul.

The seven student leaders are Ekram Hossain,

Chittagong University unit BCL president Avijit Dhar Bappi and general secretary Mohammad Shamim, Chittagong University Central Students Union vice president and then Bangladesh Chhatra League leader Nazim Uddin, Jatiya

A three-year-old child and a trader were shot as muggers opened fire on two traders in Feni town yesterday noon.

Police and locals said fruit traders Nurul Islam, 45, and Nazrul Islam, 32, of Mohipal in the town were going to National Bank at SSK Road in a rickshaw to deposit Tk 15.30 lakh with the bank. A gang of muggers waylaid

the rickshaw in front of a clinic at SSK Road and tried to snatch a bag containing the money from the two traders. As they (traders) started

running toward a shop, the gang opened fire, injuring Nurul Islam and a three-yearold child on the lap of a woman. The muggers left the scene

as shopkeepers and local people rushed to the spot, hearing gunshots.
