13 killed in suicide bomb attack on Pak police

Helicopter crashes during raid

A suicide bomber attacked police in Pakistan's lawless tribal belt on the Afghan border yesterday, killing 13 people, including seven policemen, officials

"The death toll has risen to 13. Seven are khasadar (tribal policemen) and we are trying to ascertain the identity of six others," Shafeerullah Wazir, the administration chief of Khyber, told AFP.

Rehan Gul Khattak, a local official, also gave a death toll of 13.

In Peshawar, a Pakistani military helicopter crashed while in action against militants in the country's northwest tribal belt on the Afghan border on Wednesday, officials said.

The fate of the two people on board was not immediately clear.

The Cobra helicopter was engaged in

an operation against militants in the Tirah valley of Khyber, a lawless district that straddles NATO supply lines into Afghanistan, said local administration chief Shafeerullah Wazir.

"It was a Cobra helicopter. It crashed during an operation against suspected militant hideouts in the area," he told AFP by telephone.

A military official confirmed that an attack helicopter crashed, but said the fate of its pilot and copilot was not known.

"We are trying to get details about the cause of the accident and fate of the pilots," military spokesman Major General Athar Abbas said.

Wazirdand is a small town near 2007. Pakistan's northwestern city of Peshawar and on the edge of the tribal belt, which lies outside direct government control and has been branded by US officials as the headquarters of al-Qaeda.

Three other vehicles were also damaged by the blast and the shoes and slippers of the victims were scattered across the blood-spattered road, an AFP reporter

Rehan Gul Khattak, a local administration official, initially told AFP that six tribal police were killed and authorities were investigating whether it was caused by a suicide bomber or planted explo-

There was no claim of responsibility, but Taliban and al-Qaeda-linked militants have killed around 3,000 people in bomb attacks across Pakistan, a key US ally in the war in Afghanistan, since July

Last Friday, at least 33 people were killed in bomb attacks targeting a bus of Shiite Muslim mourners and the hospital where the victims were rushed for treatment in Karachi, Pakistan's biggest city.

Lanka's opposition fears for Fonseka's life

Sri Lanka's opposition parties demanded yesterday the immediate release of former army chief and defeated presidential candidate Sarath Fonseka, warning that he faced "assassination" in custody.

In a joint statement, the parties, which had backed Fonseka's failed challenge to President Mahinda Rajapakse in January elections, said they feared for the retired four-star general's life following his

"We have good reason to believe that the extra-judicial

arrest of General Fonseka may be followed up with assassination while in custody," the statement said.

Fonseka was taken into custody by military police on Monday night. The defence ministry says he will be courtmartialled on charges of conspiring against the government while serving as head of the army.

Fonseka's family had been told Tuesday evening that he was being held at the naval headquarters in Colombo. His wife and a lawyer were allowed to visit him.

Fonseka quit the military in

November after falling out with Rajapakse and went on to challenge his former commander-in-chief at the ballot

Shortly after the January 26 vote, which Rajapakse won comfortably, the government accused Fonseka of plotting a coup to overthrow the president and assassinate members of his family.

And earlier this month, Rajapakse sacked a dozen senior military officers described by the defence ministry as a threat to national security. More were arrested from Fonseka's office.

Militants attack US forces ahead of Afghan assault

US Marines came under attack from insurgents armed with sniper guns and rocket-propelled grenades as they geared up yesterday to overwhelm a Taliban bastion in Afghanistan.

Thousands of Marines along with foreign and Afghan soldiers are massing around the town of Marjah in Helmand, which officials say is one of the last areas of the southern province under Taliban control. The flow of residents fleeing the imminent offensive has

Indian forces admit trooper may have shot Kashmir teenager

Indian security forces said yesterday they may have been responsible for the shooting death of a teenage boy in revolt-hit Kashmir that has sparked days of demonstrations.

A senior paramilitary officer said one of his troopers may have been involved in the death of 17-year-old Zahid Farooq, who witnesses say was gunned down after a group of boys refused to leave a high-security area.

Doctors said Farooq, who was the second teenager to be killed in a week, had suffered bullet wounds in his chest.

Education Board, and Madrasa Education Board by March 15, he added.

Nahid said the education ministry will compile the data and hand over the total demand for books to NCTB after March 15, and the textbook board will start printing the books right after that.

He said during printing and distribution of free school textbooks for this academic year the ministry found that the initial total number of students collected in October last year later increased by 16 percent, causing some problems in the distribution.

The government will take actions against those people who created problems through non-cooperation with the government during distribution of books for this year, the minister added. Seeking cooperation from

all, he said, "We want to complete the job more smoothly, and we hope that we will be able to print the books and distribute them before the classes start next year. About updating the curriculum, he said the government

wants to introduce modern

curriculum at all levels of the

school system, but that will take time as it is a huge task. Regarding admission trade in schools, he said the government is taking specific steps to curb the practice.

"We have already launched online admission process, and will expand it next year to tackle such problems," he said.
