ASPHALT PLANT ON KHULNA CITY PARK LAND

Smoke, dust put residents under health risk

The asphalt plant set up on the land meant for a park at Boyra Housing Estate in Khalishpur of Khulna city remains a nuisance for locals as black smoke and dust poses health risk for them.

Over a thousand people of Boyra residential area joined a procession on Monday afternoon demanding immediate shifting of the asphalt plant for recovering the land for a park and saving residents from serious environment pollution.

Local people earlier submitted petitions to former and present mayors of Khulna City Corporation (KCC), offices of Khalishpur Housing Estate and Department of Environment and the environment ministry to shift the asphalt plant to free the park.

The plant was established in 1998 as the then KCC mayor Sheikh Tayebur Rahman remained firm on his decision to construct it although local people on several occasions submitted applications urging not to establish the plant on a land meant for park, sources said.

"The housing estate authorities handed over the land in 1996 to Khulna City Corporation for a park. So, it is illegal to set up an asphalt plant there. The plant is polluting environment of the surrounding area," said engineer Badal Kumar Mandol of Khalishpur Housing Estate.

Former lawmaker Kazi Sikander Ali Dalim said he had also opposed the plan for asphalt plant grabbing land of the park.

"The asphalt plant was constructed occupying land of the park with consent of former mayor Sheikh Tayebur Rahman. We will not allow the city corporation to run the plant in our residential area as it is harmful for health and environment," said Kazi Faizur Rahman, president of Boyra Housing Estate Residents' Welfare Association.

"In response to our last official letter on June 24 in 2008, KCC authorities replied that the plant would be

alternative place is found. KCC Estate Officer Nuruzzaman Talukder said a site has already been selected adjacent to Rupsha bridge for shifting the plant.

KCC Executive Engineer (Mechanical) Abdul Aziz said the proposal for shifting the plant has already been approved at a 'pre-ECNEC level' meeting and it is now awaiting final approval by ECNEC for shifting the plant to the site near Rupsha bridge.

The asphalt plant causes dust and sound pollution that threatens public health, said Ashoke Kumar Biswas, the director of Khulna divisional office of environment department.

Dr Moni Mohan Saha, project director of Sheikh Abu Naser Specialised Hospital, said they are especially worried about the patients as asphalt plant at Boyra residential area is very near to the hospital.

17 shops gutted in Noakhali

Three get life for murder

Three people were yesterday sentenced to life imprisonment for killing a youth at village Horiakhali in Mohammadpur upazila of Magura district in 2005. The convicts are Amjad Hossain, 55, Mahtab Molla, 45, and Nanu Mondol of Salta village under the upazila. Additional District and Sessions Judge Mohammad Nazir Ahmed handed down the verdict. He acquitted seven others as murder charge brought against them could not be proved. According to the prosecution, the convicts attacked Delwar Hossain, 20, of Horiakhali village in the same upazila on March 21, 2005 as a sequel to previous enmity over ownership of a land. They beat up Delwar, leaving him seriously injured. Delwar was admitted to Khulna Medical College Hospital where he died the following day.

DEATH IN CUSTODY

Accused Keraniganj OC submits report to court

Officer-in-Charge of Keraniganj Police Station Mohammad Asaduzzaman, who is also an accused in a case filed for the death of an accused in their custody, yesterday submitted a report on the victim's death to a Dhaka court.

In his report the OC said the victim, Manik Mia alias Lutfar, 38, an accused in a murder case, committed suicide in a toilet at the police station on February 1. The victim was not tortured in their custody.

The OC was asked to submit a report within two days on the victim's death after Manik's father had filed a murder case accusing him and two others on filing of this report as 6:00pm February 8 of killing his son

Adu Mia also alleged that Keraniganj police arrested Manik Mia on January 27 without bringing any allegation against him.

Judicial Magistrate Shahriar Arafat fixed February 15 for hearing on the acceptability of the report.

PBCP threatens to avenge killing of party men

Police stations in SW region on alert

All police stations and outposts in four southwestern districts have been put on alert following violence and threat by outlawed Purbo Banglar Communist Party (PBCP-ML) in Chuadanga on Monday night.

The outlaws distributed leaflets, blasted bombs and fired a number of blank shots in Chuadanga town, creating panic among locals.

Informed that the outlaws blasted several bombs at Daulatdia near Bangaz Biscuit Factory at about 9:00pm, several police teams led by Additional Police Superintendent Moazzem Hossain rushed to the spot and seized a bundle of leaflets and bomb splinters.

In the leaflets, the outfit warned of taking revenge of the killing of leaders and activists including PBCP general secretary Jamal Uddin alias Robi alias Nuruzzaman Sumon.

They blamed 'conspiracy' of a group of Awami League (AL) leaders in the district for killing several of their leaders and activists in the district.

Terming 'crossfire' killing as a 'cold blooded police said.

According to police, a group of PBCP-ML men are trying to get reorganised in Jhenidah, Chuadanga, Meherpur and Kushtia districts under the leadership of Arif, a most wanted outlaw.

Hailing from village Akundubaria in Chuadanga Sadar upazila, Arif fled the area soon after the killing of PBCP top leader Jamal on December 3, 2009.

50 injured as AL, BNP clash in Sirajganj town

At least 50 people were injured in a clash between Awami League and BNP in Sirajganj town yesterday evening.

Of the injured, 30 were admitted to Sirajganj Sadar Hospital and local clinics in the town while the rest given first aid.

Police and witnesses said the trouble began incident. at around 6.00pm as BNP men hurled brickbats at AL district office from a procession. The AL men made a counter attack that led to a fierce clash between the activists of the two rival

political parties.

Both sides equipped with lethal weapons chased each other and hurled brickbats during the clash that continued for half an hour.

Police charged batons on the clashing groups and brought the situation under control. Additional police have been deployed in the town to avert any further

Local AL held BNP activists responsible for the incident while district BNP President and former state minister Iqbal Hassan Tuku blamed AL activists for the clash.

Villagers vow to contain extortion in localities

Several thousand people of 10 villages in Aditmari upazila of the district at a meeting on Wednesday night vowed to prevent extortion in their localities.

They held the protest meeting against extortion on Saptibari Union Parishad (UP) premises where leaders and workers of major political parties also attended.

The meeting was presided over by BNP leader and ex-chairman of Aditmari upazila Abdul Mannan Sarker while organising secretary of district Awami League Sirazul Islam Rana, BNP leader Aminul Islam, Shahadat Hossain, Jatiya Party leader Alhaj Ramzan Ali Master, Alhaj Mohammad Ali, UP chairman Mansur Ali, Alhaj Syed Ali and Alhaj Shamser Ali spoke on the occasion.

They alleged that Kabir Hossain, 30, son of Mostaque Ali of Sarolkhan village in Aditmari

upazila, has formed a gang of 20/25 criminals and the gang members are engaged in snatching, rape, stealing, drug selling, toll collection and other anti-social activities at Saptibari, Sarpukur, Sraolkhan, Kalmati, Anando Bazar, Khuniya Gachh and adjoining villages of the upazila for long.

They said no one dared to protest the activities of Kabir Hossain and his gang.

The speakers also alleged that 10 cases were filed against Kabir Hossain and his gang with Lalmonirhat Sadar and Aditmari thana but police were not taking any action against them due to unknown reason.

They said if police don't take any action, villagers will take step to stop criminal activites in their localities.

Later, a 101-member committee led by Abdul Mannan Sarker has been formed to stop extortion in their areas.
