JS boost for judiciary

Parliamentary body recommends pay, benefit hike for judges; steps to reduce huge backlog of cases

A parliamentary sub-committee has recommended introduction of judicial allowances and increased salaries and other benefits for judges of the Supreme Court and subordinate courts.

It termed their existing salaries "inconsistent" with the socio-economic situation in the country.

Salaries and allowances of SC judges should be increased by more than three times and those of subordinate court judges should also be raised significantly, the House body proposed.

Moreover, it recommended setting up metropolitan sessions judge's courts in four divisional headquarters-- Rajshahi, Khulna, Sylhet and Barisal, and metropolitan magistracy in Sylhet and Barisal to reduce the huge backlog of cases.

The sub-committee suggested that women and children repression prevention tribunals be set up at 32 district headquarters still without such tribunals, and creation of the posts of 64 more additional district judge, 64 joint district judge and 100 assistant judge.

"Without increasing the number of courts and appointing more judges, it is not possible to reduce the huge backlog of cases," observed the sub-committee formed by the parliamentary standing committee on the law ministry.

The sub-committee, in its report placed before the standing committee recently, said over 15 lakh cases remained pending with the subordinate courts till January this year.

Of this, 8.07 lakh cases were pending with the tribunals, district and sessions judge's courts and metropolitan session judge's courts, and another 7.18 lakh

cases with the judicial and metropolitan magistracy.

The five-member sub-committee is also drafting proposals for enactment of a law specifying qualifications for appointment of SC judges to end controversy over their appointment. The country's constitution asks for enactment of such a law but it was not done in the last 38 years since independence.

Substantiating the proposed increase in salaries and allowances of judges of the SC and its subordinate courts, the report said salaries of SC judges in India and Pakistan are several times that of judges of the apex court in Bangladesh.

And salaries of the judges of subordinate courts in Bangladesh are much less than salaries of those in Pakistan and Sri Lanka.

Tarique's cases against Hasina, Quader dismissed COURT CORRESPONDENT

Two defamation cases filed by Tarique Rahman against Prime Minister Sheikh Hasina and her party colleague Obaidul Quader were dismissed last year upon a judicial inquiry. It however could be known only recently.

Tarique, now senior vice-chairman of BNP, filed three defamation cases against Awami League President Hasina, the then AL general secretary Abdul Jalil and Obaidul Quader on November 19, 2006.

Chief Metropolitan Magistrate AKM Enamul Haque dismissed the case against Hasina on August 16 last year, while Metropolitan Magistrate Kanika Biswas rejected the charges against Quader on November 22 the same year. They cited that the complainant and witnesses were not

interested in proceeding with the cases. The case against Jalil is still pending with a Dhaka court, which has granted several time prayers by Tarique's counsel

since December 2006. The chief metropolitan magistrate's court in Dhaka had ordered judicial inquiry into all the three cases without taking SEE PAGE 15 COL 6
