BDR MUTINY

4 give depositions in Rangamati

Four witnesses out of 25 yesterday gave depositions against 75 accused mutineers of 9 Rifle Battalion of Marishya to the BDR special court-4.

The three-member court, headed by Director General of BDR Maj Gen Md Mainul Islam, Lt Col Md Abdur Rouf and Maj Golam Mostafa Al-Mamun adjourned the proceedings till 8:30am today.

The court started at 9:00am

Prosecutor Lt Col Shamimur Rahman produced the witnesses -- former battalion commander of Marisya Lt Col Hafizur Rahman, Maj Kabir Ahmed, Maj Iqbal Usuf and Lieutenant Mahmudur Rahman -- in the court for giving depositions.

All the jawans pleaded not guilty when they were taken to

the court from Rangamati jail. They were sent back to the same jail after the proceedings.

Deputy Attorney General Md Sohrawardy, on behalf of attorney general, aided the court. Mosarraf Hossain Kazal and Md Mohiuddin Dewan were present as senior public prosecutors on behalf of the state.

Advocate SM Abdur Rouf, Kazi Bshir Ahmed and Maj Enamul Karim provided legal assistance to the mutineers in the court.

RU to pay tribute to Dr Zoha today

Commemorating the 41st anniversary of martyrdom of Dr Shamsuzzoha, the Rajshahi University authorities will observe 'Zoha Day' today.

On the occasion, the authorities have chalked out elaborate programmes on the campus including placing of wreaths at the grave and monument of Dr Zoha, hoisting of black flag, rally, quran khwani and memorial speech. Prof Dr Shamsuzzoha was

shot dead by Pakistani military junta in front of the main gate of Rajshahi University (RU) on February 18, 1969. On the day, Dr Zoha rushed

to the university main gate to protect the students who marched towards the town by breaking Section 144. His martyrdom accelerated

the ongoing mass movement against Pakistan army for withdrawal of historic Agartala Conspiracy Case.

The agitation started in Rajshahi and elsewhere in the country on February 15, 1969 when Sergeant Zahurul Haque, an accused in the case, was killed by Pakistan army personnel after his arrest.

According to Prof Abdul Khalegue, former vice chan-



cellor and a witness to the incident, Dr Zoha was talking with two Pakistani army officers, Captain Hadi and Lt Khadem Shah. He requested them not to go for action against the students. At one stage of hot exchange of words, Lt Khadem ordered a Bangalee army personnel to shoot him but they refused to comply with his order. An agitated Shah then killed Zoha using his own revolver.

Dr Zoha was the then proctor of the university and a teacher of chemistry department.

His death sparked violent protests across the then East Pakistan leading to fall of the Ayub regime. Since then, the day is being observed as Zoha Day. RU vice-chancellor and

hold discussions and offer

prayers for the martyred soul. **RU** chemistry department in association with university administration will organise Zoha Memorial Speech with department chairman Prof Dr Basudev Kumar Das in the chair.

Former member of the caretaker government and executive director of Ain O Salish Kendro Advocate Sultana Kamal will read out the keynote paper at Kazi Nazrul Islam auditorium of the university.

RU vice-chancellor (VC Prof Abdus Sobhan and provice chancellor Pro Muhammad Nurullah will attend the programme as chief and special guests.

Chemistry department will also bring out a silent procession on the campus to mark the day.

Black flag will be hoisted atop all administrative buildings, VC's residence, library, chemistry department and student halls.

Char Fashion court active again after 17 years

Activities at Char Fashion upazila civil and criminal court resumed Tuesday, nearly 17 years after transferring the court to district headquarters.

Upazila chairman Nurul Islam VP, UNO Mohammad Mostafa Kamal and local people were present.

A large number of people after taking part in a doa mahfil were seen rejoicing over resumption of the court, 70km away from the Sadar upazila.

The documents of 2,200 cases were sent to the court for disposal and on the first day hearings of 45 cases were held.

Established during the rule of HM Ershad, the court was transferred to district headquarters in 1993.

After assumption of power by the present government, local lawmaker Abdullah Al Islam Jacob sent a proposal to the law ministry for shifting the court to Char Fashion upazila citing the sufferings of local people.

On the basis of the proposal, the President in an order on January 5, transferred the court to the upazila of 5 lakh people, said local sources.

BDR, BSF discuss | BSF kills farmer in irritant issues

Bangladesh Rifles (BDR) and Indian Border Security Force (BSF) at a deputy director general level meeting at Tamabil check post yesterday agreed to maintain status quo on the disputed farmlands along the border until the joint survey is done.

BDR Deputy Director General Brigadier General Obaidul Haque led a nine-men team while BSF Inspector General of Shillong Prithvi Raj led a seven-member team at the talks that continued for five and half an hours from 11:00am.

After the meeting, Major Kohinur Alam of BDR Sylhet sector, told this correspondent that they raised the issues like abduction of BDR nayek Mujibur Rahman by BSF men from Jaintapur border on February 4, BSF firing on innocent villagers on February 14 and an attempt to catch fish in a water body inside Bangladesh territory at the talks.

The BSF expressed sorrow for the incidents and assured its Bangladesh counterpart of taking necessary measures to contain such incidents, he said, adding that BDR officials
