# BSF kills two Bangladeshis

### Returns bodies after flag meetings

Indian Border Security Force (BSF) killed two Bangladeshis along Panchagarh border yesterday and the day before.

An elderly man was beaten to death at Amarkhana point early yesterday while a farmer was shot dead in Madhupara area of the border on Wednesday.

BSF however returned the bodies yesterday afternoon after company commander-level meetings with Bangladesh Rifles (BDR).

After a meeting held on zero line on Madhupara border under Sadar upazila, the body of Islam Miah, 38, son of late Afiz Uddin alias Sarbatu of Madhupara village was handed over to BDR. Islam was shot dead by BSF members of Shingimari camp on

Madhupara border Wednesday afternoon at about 3:00pm while he was cutting grass for his cattle. The BDR members of Vitorgarh camp later handed over the

body to Panchagarh police who later sent it to the victim's family members. Meanwhile, the body of a mentally impaired elderly man was

returned by BSF yesterday afternoon after a company com-

mander-level flag meeting between the border guards at Omorkhana point under Sadar upazila. Victim Anwar Hossain, 60, was son of late Haji Abul Kashem of Nordebpara village under Sadar upazila of the district.

Anwar was allegedly beaten to death by the BSF men of Khalpara camp early yesterday as he entered Indian territory by

After receiving the body, BDR gave it to police who later handed it over to the victim's family members.

#### Fugitive JMB man held

A fugitive militant of outlawed Jama'atul Mujahideen Bangladesh (JMB) was held in Birampur upazila on Wednesday evening. The arrestee was identified as Md Dabirul Islam 28, son of Moin Uddin Moyen under Ayra village under the upazila. Sources said, a Rab team from Joypurhat raided Ayra village at 6:30pm and arrested Dabirul who allegedly came to meet the members of JMB there. Dabirul was chargesheeted in a case in Jaldhaka upazila of Nilphamari district in 2008.

#### One to die for killing wife

A court here on Wednesday awarded capital punishment to a man for killing his wife in 2004. The condemned was identified as M Nizamuddin, 50, son of late Haji Kutub Ali of Ajor village in Jakiganj upazila. According to the prosecution, Nizam picked up a quarrel with his wife Kulsuma Begum on January 21, 2004 night over a trifling matter and at one stage stabbed her to death. Later, hearing the hue and cry, neighbours rushed in and caught the killer red-handed and handed him over to police.

#### Touchstone statue recovered

A touchstone made statue of Lord Krishna worth Tk 3 crore was recovered at Nischintapur village in Sapahar upazila early Wednesday. Acting on secret information, BDR jawans recovered the statue from a pond of the village at about 3:00am. The border guards suspected that the statue weighing 300kg was kept in the pond for smuggling out to India later at a convenient time.

### **Body found**

UNB, Barisal

Body of an unidentified middle-aged man was recovered from a ditch adjacent to intern doctors' hostel on Barisal Sher-e-Bangla Medical College and Hospital campus on Wednesday morning. Police said, the body bore injury marks. It was sent to SBMCH morgue for autopsy. With this, five bodies, including of two women, were recovered from Barisal city, Muladi and Wazirpur upazilas in three days since Monday.

### 9 children enslaved by dry fish trader rescued

Coastguards rescued nine children aged between 11 and 15 from a remote fishermen's village at Dubla under Sharankhola range of the Sundarbans early yesterday.

The children were forcibly employed in fish drying work at Meher Ali's Char at Dubla fishermen's village.

The rescued children are Md Ibrahim, 15, son of Nurul Islam, Md Nur Nabi, 15, son of Monir Ahmed, Md Alauddin, 11, son of Md Mostafa of Hatia in Noakhali district; Md Ibrahim, 14, son of Kala Miah of respective homes, the sources said. Sitakunda, Md Sohel, 14, son of Md Selim of Rangunia in Chittagong district; Mostafa Sheikh, 12, son of Ali Ahmed of Burichong in Comilla district; Md Ripon, 13, son of Abul Hossain of Gazipur; Md Faruque alias Babul, 12, son of Abdul Kader cancelled, he added.

Md Fayekuzzaman, son of Munshi Rohan Uddin of Fukra village under Kashiani upazila of Gopalganj district, filed the case with Judicial Magistrate's Court, Satkhira.

The martyred freedom fighters are Saheb Ali Munshi Mohammad Mahsin, Subhas Chandra, Shishir Chandra and Monoranjan Kumar of Fukra village under Kashiani upazila of Gopalganj district.

In the case statement, the complainant said the collaborators caught the five freedom fighters at Kalaroa while they were going to India for higher training on May 17, 1971.

He further stated that the accused beat up the freedom fighters severely, took them to Kalaroa football ground and killed them the same

Judge Md Masuduzzman accepted the case and asked the officer-in-Charge (OC) of Kalaroa Police Station to take legal action against the accused.

## Two to die, 3 get life for abducting schoolboy

Two people were sentenced to death and three others to life term rigorous imprisonment (RI) here yesterday for abducting a schoolboy in the

Additional District and Sessions Judge Mohammad Nazir Ahmed also fined each lifer Tk 50,000, in default, to suffer one year more RI.

Those sentenced to death are Sijanur Rahman Sohag, 20, and Majnu Sheikh, 25, and the lifers Alek Rahman, 52, Atiar Rahman, 40, and

Insar Ali Sabuj, 30. Sohag hailed from

Bilnathur village in Sreepur upazila of Magura district while the rest four convicts from Abaipur village in Shailakupa upazila under Jhenidah district. According to prosecution,

Six witnesses yesterday gave deposition in the court. Earlier one witness gave statement on Tuesday and four on Wednesday against the 75 accused jawans. All of the 75 accused jawans from Rangamati

jail were produced before the court yesterday and they were sent back to the same jail after adjournment of the proceedings.

All the 75 jawans claimed in the court that they are not guilty.

The mutiny in Rangamati took place at three of the sector's five battalions. The three battalions are 12 Rifles Battalion at Rajanagar in Longudu, 9 Rifles Battalion at Marishya in Baghaichhari and 18 Rifles Battalion at Chhotohorina in Barkal upazila.
