Portugal floods kill 42

Rescue workers dug through heaps of mud, boulders and debris yesterday in Madeira, searching for victims buried by flash floods and mudslides that already killed at least 42 people on the popular Portuguese More than 120 others were

injured and an unknown number were missing, possibly swept away or smothered, authorities said, adding that the death could still rise. Another 250 people were forced to flee their homes and go to shelters.

The worst storm to hit the Atlantic Ocean island since 1993 lashed the capital of Funchal on Saturday, turning some streets into raging tor-

rents of liquid brown mud, water and debris. "We heard a very loud noise, shook and then we realised it

Zardari didn't ask for Swiss case reopening Says Pak spokesman

Pakistan President Asif Ali Zardari's spokesman Farhatullah Babar has rejected reports that he (Zardari) has asked the law ministry to reopen the cases against him that are pending in Swiss courts. Babar said the issue was

not discussed during the Pakistan People's Party (PPP) core committee meeting, which was held on Saturday.

Earlier, a private television channel had claimed that Zardari has given a green signal to the Law Ministry and the Attorney General (AG) to proceed with process of reopening of the cases. The channel also claimed

that the government would formally request the Swiss government to allow Pakistani officials start the procedure for reopening of the cases on Monday, The Daily Times reported. It said that Zardari has told

his close associates that he is ready to face the Swiss courts and has directed the concerned authorities not to create hurdles in the implementation of the Supreme Court's verdict. It may be noted that in

November last year the apex court had rendered the controversial amnesty law the National Reconciliation Ordinance (NRO) as 'unconstitutional' following which speculations regarding Zardari being tried in the court of law on corruption charges increased manifold. However, some legal

experts argue that Zardari can not be prosecuted as he enjoys special immunity according to the Constitution. Meanwhile, former Prime

Minister and Pakistan Muslim League-Nawaz (PML-N) chief Nawaz Sharif has said he would continue his struggle to bring back the looted money from the national exchequer.

During a meeting with Member National Assembly (MNA) Abdul Qadir Baluch, Sharif said he would continue to fight to ensure that the money, which is currently stocked in Swiss banks, comes back to the country.

"If we get such instructions from the government,

we will take action against the bail and other orders in favour of the fugitive convicts," Attorney General Mahbubey Alam told The Daily Star. He said anybody convicted in absentia in any

criminal case has to come under trial first, and then they can seek bail.

A few of these 50 fugitive convicts are still in foreign countries while most of them have returned after obtaining bail or stay orders from the HC, which also instructed the authorities not to harass or arrest them.

If fugitive convicts are granted bail in this way, they will be "emboldened" to defy the court, and "the administration of criminal justice will be crumpled", the apex court said in its observation on the case of HBM Iqbal.

The ACC and NBR are yet to know the exact number of such cases. Lawyers dealing with such bail and stay orders estimate the number at around 50.

These graft-convicts

include Jalal Alamgir and Joy Alamgir, HBM Iqbal's wife Dr Momtaj Begum Dolly, former home minister Mohammad Nasim's wife Laila Arjumand Banu, Orion Group Chairman Obaidul Karim-all in connection with cases filed by the ACC, and former housing minister Mirza Abbas' wife Afroza Abbas, Bashundhara Group Chairman Ahmed Akbar Sobhan (Shah Alam)--in connection with cases filed by the NBR.

"We failed to understand in the backdrop of the case [against HBM Iqbal] how the learned judges of the Division Bench could even entertain the writ petition on behalf of a fugitive from justice, ignoring the long settled principles being

followed by the courts," the apex court observed in its judgment.

ACC lawyers said although the commission has been trying to bring the matter into notice of the HC judges for over a year, the plea remains unheard.

Overwhelming majority of the demonstrators were young students who were protesting the then Pakistan government's evil design for forcing Urdu on the Bangalee people of East Pakistan as their state language.

They were breaking the curfew to advance towards what was the State Assembly Building back then near where the Central Shaheed Minar is now, to place their demand for Bangla as a state language, to the then assembly members. But police bullets stopped their advance killing the language martyrs. The stopping of the

advance however proved to be only temporary as the killings pushed the movement into a higher gear, which ultimately forced the Pakistani government to accept Bangla as a state language in 1956. In 2000 Unesco declared February 21 as International Mother Language Day. Yesterday, actors recreated

the historic 30 minutes at equally historic Amtala on a well made stage, depicting the build up of the historic struggle and its crescendo, through nicely choreographed physical acting with accompanying music, for several thousand emotion gripped audience. The event started at
