## Half of doctors' posts vacant, shortage of staff acute

A staggering 148 of the 257 posts of doctors are lying vacant at 14 health care units in Pabna district, hampering healthcare services in the district.

Only 109 doctors are now working to provide healthcare service to some 2.6 million people in nine upazilas of the district, sources in the district health department said.

In 2005, the then 120-bed Pabna General Hospital was upgraded to a 250-bed one but

there is hardly any development in its facilities. Treatment of patients is greatly hampered at Pabna General Hospital, as the authorities concerned did not appoint sufficient manpower for the specialised hospital in last four years, said Dr Md Tariqul Islam, the RMO (resident medical officer) of the hospital.

Only 30 doctors are working in Pabna General Hospital although there are 57 sanctioned posts, official sources said.

The hospital does not have any senior consultant for medicine and consultants for cardiology, pathology and anaesthesia.

"The list of vacant posts is usually sent to the higher authorities twice a month. But the health directorate is unable to provide required manpower due to shortage of physicians across the country," Pabna Civil Surgeon Dr Khairul Alam Chowdhury told The Daily Star recently.

Shortage of manpower, mainly doctors, is also acute in upazila health complexes includ-

ing 50-bed ones in Santhia, Sujanagar and Chatmohar upazilas.

Sujanagar and Santhia upazila health complexes are running with seven doctors each although there are 29 and 31 posts in the two health care centres.

Eleven doctors are working at Chatmohar Upazila Health Complex while it has posts of 31 doctors.

Faridpur Upazila Health Complex is running with only four doctors although there are 25 allocated posts following its recent upgradation to a 50-bed one.

"Officially four doctors are working at Faridpur Upazila Health Complex but practically we are getting service of three doctors there. Health assistants often provide health service to patients due to lack of doctors. Quality of treatment cannot not be maintained due to the situation," said Dr Md Khalilur Rahman, Faridpur upazila health and family planning officer.

Three out of 13 posts of doctors are lying vacant in Pabna Sadar Upazila Health Complex, said sources at Pabna Civil Surgeon's Office.

The numbers of vacant posts are seven in Ishwardi upazila, eight in Atghoria upazila, five in Bhangura upazila and nine in Bera upazila health complex while the sanctioned posts are 16, 14, 14, 17 respectively.

Besides, two posts of doctors have been lying vacant at Pabna Civil Surgeon's Office and the chest disease hospital.

# Monimala 'set afire for dowry,' fighting for life

A young housewife, set afire allegedly by in-laws, is fighting for life at the burn unit of Mymensingh Medical College Hospital (MMCH).

The victim, Monimala, 20, got more than 40 percent of her body including face and chest burnt during the incident on February 22 afternoon at her husband's house at village Kalibari in Jhenaigati upazila under Sherpur district.

In the evening the same day, her in-laws took her to Jhenaigati Upazila Health Complex from where she was referred to Sherpur Sadar Hospital. As her condition deteriorated, she was admitted to MMCH on Saturday night.

Following the incident, a case was filed against five people including her husband Ali Hossain, mother-in-law Hujura, sisters-in-law Rubia alias Chikani and Minara and maternal uncle-in-law Abdul Malek Member and police arrested Ali Hossain.

Monimala was married to Ali Hossain, a day labourer of the neighbouring village, two years ago. Monimala lost her father at an early age and her mother is a mental patient, said family members.

Monimala's brothers, who work as day labourers, gave Tk 35,000 as dowry during and after the marriage but the inlaws led by her mother-in-law Hujura used to torture her physically, they said.

"Around 15 days ago, Monimala came to our house following a quarrel with her sister-in-law Chikani. Later she returned to husband's house. On February 22 afternoon, the accused set her on fire after pouring kerosene," Monimala's elder brother

In the evening, the culprits took Monimala to Jhenaigati Upazila Health Complex from where she was referred to Sherpur Sadar Hospital at night. Before taking her to hospital, Abdul Malek Member forced Monimala to say that the incident occurred while she was cooking food and Malek Member recorded it with his mobile set, alleged Hurmoz Ali.

We caught Monimala's husband from the hospital area and handed him over to police," said Abdus Sobhan, another elder brother of the MMCH. victim.

He denied any attempt by police to save Abdul Malek Member from the case.

"The victim is under risk as 40 percent of her body got burnt. She needs proper treatment for two or three months for her cure," said Dr KM Nahidul Haque of burn unit of

The body of the victim was later handed over to his relatives in presence of Shibganj police. Cattle trader Mukul Mia, 28, son of Faring Mia of Bahalabari village under Shibganj upazila was shot dead by BSF early Thursday, BDR sources said. BSF personnel at Sabghati camp shot dead Mukul when he entered the Indian territory opposite to Wahedpur border outpost in Shibganj upazila and ook away the body.

#### Teenage boy electrocuted
