Deep-sea port likely by 2015

The first phase work for construction of the deep-sea port in Sonadia Island is likely to be completed by 2015 with an estimated cost of Tk 15,000 crore, Shipping Minister Shahjahan Khan told the House yesterday.

"Bangladesh will earn over Tk 1,000 crore in 2016 as revenue from the port and it will be double in 2020," he said in scripted answer to lawmakers' queries.

He said exploration of foreign fund and preparation of detailed design for construction of the seaport are underway.

The government has taken a master plan to bring back navigability in 53 waterways and almost dying rivers at a cost of Tk 11,500 crore, the minister said adding the project is likely to be completed by 2018.

He said Bangladesh Inland Water Transport Authority has moved to procure three dredgers and other water vessels and equipments for carrying out dredging in 53 waterways and nearly dead rivers.

"Seventeen more dredgers will also be purchased by 2015," he added.

The shipping minister said works for extraction of waste from the bed of Turag River would be completed by the end of next year.

Opposition walks out of JS again

Protests branding BNP-Jamaat as militant patrons

BNP-led opposition lawmakers stormed out of the Jatiya Sangsad yesterday protesting against a senior ruling party lawmaker's remark labelling BNP and Jamaat-e-Islami as patrons of militancy in Bangladesh.

Taking floor on a point of order, Awami League lawmaker Suranjit Sengupta cited arrest of a Pakistani national reportedly involved with Pakistan-based militant group Jaish-e-Mohammed (JeM).

BNP-led opposition MPs stood on their feet and started shouting as soon as Suranjit started reading out newspaper reports on the arrest. The reports said a former

Jamaat leader, who joined BNP in last caretaker government regime, had provided shelter to the Pakistan national. He went on blasting the

BNP-Jamaat alliance for patronising militants.

The opposition tried for a minute to shout Suranjit out and walked out of parliament around 7.50pm and did not

As they left, Suranjit said the opposition could have replied if they had anything to say on the matter.

NBR sues Koko, Patal

BNP Chairperson Khaleda Zia's younger son Arafat Rahman Koko and former BNP state minister Fazlur Rahman Patal were yesterday sued for dodging income tax. Another Dhaka court yesterday cancelled bails of Khaleda

Zia's elder son BNP Senior Vice-Chairman Tarique Rahman and his business partner Giasuddin Al Mamun and issued arrest warrants against them in a Tk 10-crore extortion case.

Judge ANM Bashir Ullah of the Senior Special Judge's Court issued arrest warrants against Koko and Fazlur Rahman after the National Board of Revenue filed the cases against them in connection with evading income tax in different fiscal years. The court also directed Cantonment, Natore and Rampura police stations to submit reports by March 10 and 11 on the execution of the arrest warrants. In the complaint against Koko, Deputy Tax Commissioner of

the NBR Shahin Akhter Hossain said Koko evaded income tax on his income of Tk 52.39 lakh between 2002-2003 and 2006-2007 fiscal years.

Primary edn in 'leave' problem

Govt to create pool of 20,000 primary teachers for filling in leave vacancies

The government plans to create a pool of 20,000 primary school

teachers to tackle teacher shortages due to leaves of absence. A vast number of teaching posts fall vacant for a temporary but significant amount of time due to maternity leave, professional training and medical leave.

Secretary in Charge of the Primary and Mass Education Ministry, Abu Alam Mohammad Shahid Khan, said, "In each primary school there is an average of three to four teachers.

"If a teacher attends training, falls sick or goes on leave for some other reason, the teacher's classes may be cancelled for months and this is hugely disruptive to the children's educa-

Officials from the ministry said that every year, an average of 18,950 teachers from government, registered and community primary schools take part in the year-long C-in-Ed training.

Over 5,500 female teachers take maternity leave each year and around 5,500 teachers take leave for medical reasons, or to attend religious festivals such as the hajj. Between 5,000 and 6,000 teaching assistant posts and head-

masters of government primary schools also fall vacant and it can take several months to fill the posts on a temporary basis.

Around 40 teachers in each of the 481 upazilas will be appointed on the basis of "No work no pay". Officials from the Ministry of Primary and Mass Education

said teachers will receive a monthly salary of Tk 1,500.

Ministry officials said that a policy regarding the pool will be

sent to the establishment ministry shortly. The appointment process will begin after receiving approval

Cabinet okays bill with death penalty clause

6-member body to submit report after detailed analysis

The cabinet yesterday approved in principle the Border Guard Bangladesh Bill 2010, keeping a provision of death penalty for offences like mutiny, killing, and arson within the country's frontier security force.

It also formed a six-member high-powered committee for a detailed analysis of the bill, and asked the committee to submit a report in the next cabinet meeting, with suggestions for modifications in the bill if necessary. The committee comprises prime minister's advisers HT

Imam and Moshiur Rahman, Cabinet Secretary Abdul Aziz, the premier's Principal Secretary Abdul Karim, Home Secretary Abdus Sobhan Sikder, and Law Secretary Anwarul Haque. The cabinet meeting was a regular one held in Bangladesh

Secretariat with Prime Minister Sheikh Hasina in the chair. Highly placed sources in the government told The Daily Star

that the bill will be submitted to the parliament in the current session, for making it into a law which will also change the name of Bangladesh Rifles (BDR) to Border Guard Bangladesh (BGB).
