

Madrasa student brutally tortured by teacher

A madrasa teacher tortured a student, confining him to a room of the madrasa for two days since Sunday afternoon in Dinajpur town while police recovered the decapitated body of a madrasa student from a char under Narsingdi Sadar upazila yesterday morning. According to our Dinajpur correspondent, Iqbal Hossain, 15, a resident student of Chawliapatty Nurjahan Madrasa, managed to escape from captivity at around 1:30pm yesterday and came to the local press club along with his father Yasin Ansari of Bahadur Bazar in the town.

The boy alleged that a teacher of the madrasa confined him to a room of the madrasa hostel over a trifling matter Sunday afternoon and tortured him physically.

He showed the journalists the injury marks on his back, but did not mention the name of the teacher.

Iqbal's father Yasin said he will file a case against

the teacher with Sadar Police Station.

He alleged that the teacher had earlier tortured several other students of the madrasa the same way.

Contacted, the madrasa authorities declined to comment on the issue.

In Narsingdi, the decapitated body of a 15-year-old madrasa student was found at remote char area at Nabipur under Narsingdi Sadar upazila yesterday morning, reports a correspondent.

Police quoted family sources as saying that an unidentified gang called Sumon Miah, a student of local Battoli Alia Madrasa, out of his house at Nabipur village early yesterday.

Locals found his decapitated body on a paddy field in the morning and informed the police. Police went to the spot at noon, recovered the body and sent it to Narsingdi Sadar Hospital for autopsy.

Suman's father Manuallah Miah filed a murder case with Narsingdi Sadar Police Station.

Under trial prisoner dies in Satkhira

An under trial prisoner of the district jail died at Sadar hospital on Monday evening.

The deceased was identified as Abdus Sattar, 45, son of Hossain Ali of Hetalkhali village in Shyamnagar upazila.

Police said locals caught Abdus Sattar and Amjad Hossain while

they were preparing for robbery at Srifolkati village in Shyamnagar upazila and handed them over to police after giving them a good beating on February 20.

Jail Superintendent Nurannabi Bhuiyan said Sattar and Amjad were sent to jail by a court in a robbery case on February 21.

Both were admitted to jail hospital on that night as their condition was not good due to physical torture. Later, they were shifted to Sadar Hospital on February 24 as their condition deteriorated. Sattar died in the hospital at 5:45 pm.

RMCH ASST DIRECTOR

Probe into graft charges begins

Rajshahi divisional health directorate on Monday started investigation into allegations of power abuse and irregularities against an assistant director of Rajshahi Medical College Hospital (RMCH).

Following a ministerial order, the divisional health Director Dr Abdur Rashid Mridha called RMCH Assistant Director Dr Muhibul Hasan to his office and enquired him about the allegations.

Dr Muhibul is general secretary of RMCH chapters of Bangladesh Medical Association and Swadhinata Chikitsak Parishad, a doctors' forum backed by the ruling Awami League.

Some 14 doctors who were

allegedly victimised by Muhibul were also enquired.

The investigation was initiated following an anonymous letter that was sent to the health ministry alleging that Dr Muhibul forced some 14 doctors to give him money by threatening them of transfer.

Talking to The Daily Star, health Director Dr Abdur Rashid Mridha confirmed the investigation but declined to give details.

When contacted, Dr Muhibul Hasan said the allegations against him are false.

"The health director interviewed me over the allegations that came through an anonymous letter. Those who are envious at the development works under my leadership are circulating propaganda against me," he said.

KILLINGS OF KHULNA JOURNALISTS Fresh probe to punish real culprits demanded

Khulna journalists yesterday demanded reinvestigation into the cases for murder of journalists, including Sheikh Harun-ar-Rashid Khokon, senior crime reporter of Dainik Purbanchal.

They raised the demand at separate discussion meetings organised by Khulna Press Club and Khulna Union of Journalists (KUJ) at the club in observance of the eighth death anniversary Harun-ar-Rashid khokon.

The speakers also demanded immediate arrest

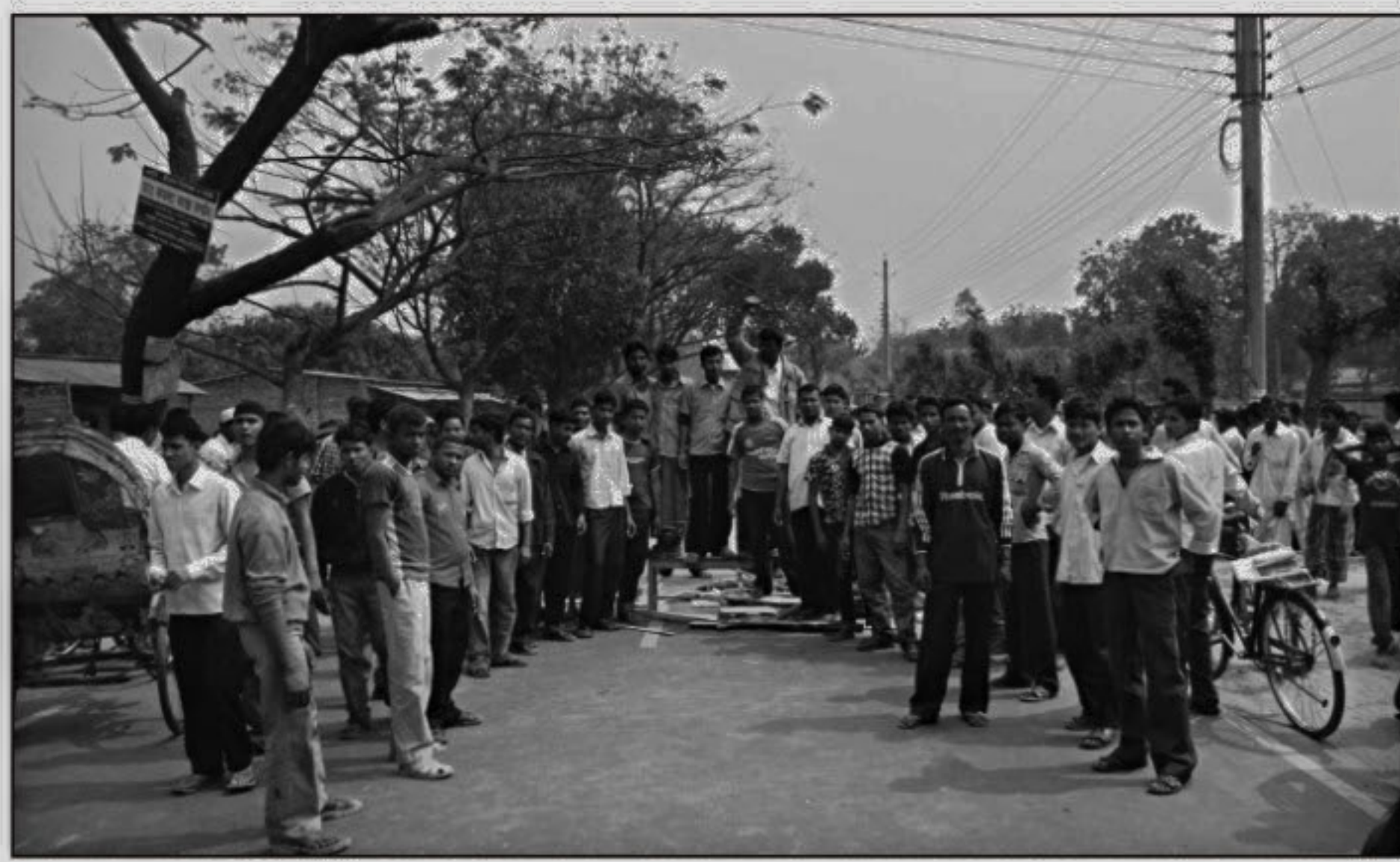
of the godfathers who planned the killing of Journalists Khokon, Nahor Ali, Manik Saha, Humayun Kabir Balu and Sheikh Belaluddin.

They alleged that the godfathers were left out of the charge sheets submitted to courts by the investigation officers due to political influence.

Khulna Press Club held the discussion meeting at VIP lounge with club President Ahmad Ali Khan in the chair while KUJ President Sheikh Abu Hasan chaired their discussion held at the

union office at the press club. Khokon was gunned down by extremists at Mujgunni under Khalishpur Police Station on March 2, 2002.

Earlier in the day, journalists placed wreaths at the memorial for slain journalists on Kuhulna Press Club premises. They visited Khokon's grave at at Galkhali under Khalishpur Police Station at 8:00am and offered special prayer seeking salvation of the departed soul. Later, a Qurankhaani and milad were held at his residence at Daulatpur.
