### BSMMU employee commits suicide

An employee of Bangabandhu Sheikh Mujib Medical University (BSMMU) committed suicide yesterday jumping from the top floor of the C

Mohammad Hafizuddin, 35, had been working at the Department of Urology for the last five years as a peon.

Hafizuddin, who hailed from Kamaura village of Ashuganj in Brahmanbaria, had been suffering from depression for the last three weeks that forced him to commit suicide, said the hospital authorities.

While talking to The Daily Star, Prof SAM Golam Kibria said, "Hafizuddin used to work under me and he was depressed for the last few weeks because of uncertainty

about his job." Sources at the hospital said Hafizuddin was appointed on a daily basis and it was during the period of Prof Hadi. But recently a group of pro-Awami League leaders of the employees had been threatening to oust him from the job, which made Hafizuddin upset.

Finally he went to talk to the chairman of the department Prof MA Salam who said they have nothing to do with Hafiz's job.

It proved to be the last straw, which made Hafizuddin jump from the fourth floor of the building.

Monir Hossain, a cousin of Hafizuddin told reporters that two days ago Hafizuddin called him over telephone and said a laptop had been stolen from Dr Kibria's room a few days ago and he was suspected and tortured for this. Perhaps it forced him to commit suicide, he said.

However, when contacted, Dr Kibria said that it is a false allegation.

Director of BSMMU Abdul Majid Bhuiyan also said that the laptop issue is a false one.

"Hafizuddin had been suffering from depressive illness and sought treatment at the psychiatry department of the outdoor. Recently one of his sons was run over by a bus and made him more upset," he said.

### Extramarital affair behind suicide of Konika

Extramarital affair with the employer led to the suicide of Konika Parvin, an employee of Brilliant Hira Ltd., police said vesterday.

Konika, 25, office manager of the company at Gazipur, committed suicide by hanging herself from the ceiling fan at her Uttara residence in the city on Monday.

Later, the police recovered her body and also arrested her employer Anu Jaigirdar, who is now on a two-day remand at the Uttara Police Station.

During interrogation in the remand, Anu confessed that he had an extramarital affair with Konika, the police said.

Officer-in-charge (OC) Khandaker Rezaul Hasan said Anu appointed Konika as an office manager in his office but developed an illicit relationship with her with the promise of marriage.

Anu did not marry her after

her repeated requests for marriage, the OC said quoting Anu. The OC also said one of Anu's friends introduced her to

Anu for appointing her at Brilliant Hira Ltd. Investigation officer (IO) of the case Mohammad Selim told The Daily Star that Konika had

been working in Anu's office for the last four years and she also made a trip to France during this period. The police are now trying to find out whether Konika com-

### Changes in GPA-division equivalence system

The government has determined anew the equivalence between the GPA system and the division system in the public examinations.

has issued a gazette notification to this effect, says an official handout yesterday.

The ministry has amended the earlier notification issued on June 2 last year and set separate criteria equivalent to the grading system for Secondary School Certificate (SSC) and Higher Secondary Certificate (HSC) levels to reintroduce 1st, 2nd and 3rd divisions in proportion to grade point average (GPA) marks.

The decision came in the wake of movements from students who claimed that the earlier adjustment of the

grading system with division system was discriminatory.

From now on, GPA 3.00 or above is equivalent to first division while GPA less than 3.00 to 2.00 is second division and GPA less than 2.00 to 1.00 The education ministry is third division for the students of SSC and equivalent exams and HSC and its

equivalents. According to the earlier notification, GPA 3.50 or above was equivalent to first division while GPA less than 3.50 to 2.50 was second division and GPA less than 2.50 to 1.00 was third division for the students who passed SSC and equivalent exams during 2001-2003 period and who passed HSC and its equiva-

lents in 2003. The new notification will be in effect until issuing another notification, the handout mentioned.

## Khaleda blames govt for politicising judiciary

Leader of the Opposition Khaleda Zia blamed the government for politicising the judiciary where the judges feel disappointed in administering justice, resulting in what she said lawlessness.

"There is nothing called the rule of law in the country. The behaviour of attorney general is unfortunate. The judges feel frustrated," she said this while she was addressing the newly elected pro-BNP office-bearers of Dhaka Ainjibi Samity at her Gulshan office.

The BNP chair said the country is passing through a difficult time. Terrorism, extortion and killings became order of the day while soaring prices of commodities, scarcity of electricity, gas and water aggravated the plight of the public life. Khaleda alleged that the

installed in power by external forces to serve their interests. "The only way to salvage the country from this repressive

regime is launching a united movement," she told the lawyer leaders. Refuting allegation of

corruption against her government, she said a false campaign is being carried out against BNP. Had BNP resorted to corruption, the country would not have so many development works done during her rule.

In a counteroffensive Khaleda brought charges of corruption against the present government, saying that the people in power are busy making quick bucks.

"Even the ruling party people are saying small thief, medium thief and big thief (MPs, ministers, prime minister) have plunged into corruption. People cannot expect anything if the country government has been remains in the hands of big

thief," she said in metaphoric

Khaleda said despite a peaceful atmosphere in absence of the opposition movement, the government has failed to fulfil any of its election pledges.

Instead of giving job, she said, the people are being made jobless. Good officers in the police department and the armed forces are losing jobs because of politicisation, she alleged, adding that the government is trying to introduce one party rule that cannot be accepted anyway.

Stressing united movement to get rid of the situation, Khaleda said once the movement could be started, people would join it as they did not get anything from this government.


