## Updated draft voter list to be published

today

The Election Commission (EC) will begin publishing updated draft voter list in three phases across the country from today, excepting Dhaka district.

In the first phase, the EC will publish the draft voter lists of 17 districts, including Barisal, Patuakhali, Pirojpur, Barguna, Jhalakathi, Khulna, Satkhira, Bagerhat, Noakhali, Habiganj, Sunamganj, Sylhet, Chandpur, Feni, Laxmipur, Cox's Bazar and Chittagong, EC sources said.

The EC will accept petitions containing demands, objections and amendments related to the voters' list until March 23, and those will be resolved by March 30.

In the second phase, draft voter list of 20 districts will be published on March 15, while draft the voter list of 26 more districts on March 22.

The final voter list will be published on April 29.

## Schoolboy burnt to death in Ctg

An 11-year-old boy was killed and 13 houses were gutted in a fire at Fateyabad village in Hathazari upazila of Chittagong early vesterday.

The victim, Omker Das, 11, was a class-six student of Fateyabad High School and son of Kajal Das.

An electrical short circuit started the fire in a thatched house at around 2:30am and soon engulfed 12 adjacent houses, fire service sources said.

Omker was burnt to death as he could not come out of the house. At least 12 domestic animals were also killed in the blaze put

out by two fire brigade units at around 3:00am.

## Hearing on Hasina's petition begins

The High Court yesterday adjourned until today the hearing on a writ petition filed by Prime Minister Sheikh Hasina challenging the proceedings against her in the MiG-29 purchase scam case filed during the BNP-led four-party alliance rule.

The HC bench of Justice AHM Shamsuddin Chowdhury Manik and Justice Borhan Uddin started the hearing on the petition yesterday. More hearing will be held today.

The same bench on March 4 quashed all proceedings against the Awami League president in three corruption cases involving Bangabandhu Novo Theatre.

During the hearing yesterday, Barrister Sheikh Fazle Noor Taposh argued that the divisional special judge's court violated the Code of Criminal Procedure by framing charges against Hasina in her absence on August 20, 2008.

As per section 242 of the

Code, the court must frame charges against defendants in their presence so that they can plead guilty or innocent, he said, adding that Hasina had filed an application requesting the trial court not to indict her in her absence, but to no avail.

The now-defunct Bureau of Anti-Corruption (Bac) had filed the case with Tejgaon Police Station on December 11, 2001.

Seven persons, including Hasina, were accused of causing a loss of Tk 700 crore to the state exchequer for corruption in the purchase of eight MiG-29 fighter planes. Hasina was also the prime minister when the purchase was made.

Following the petition filed by Hasina, the HC on September 18, 2008, stayed trial proceedings against her, and issued a rule on the government, the Anti-Corruption Commission (ACC) and the trial court to explain why framing charges against Hasina in her absence should not be declared illegal.

## Azam Reza to serve life in jail

The Supreme Court yesterday upheld a High Court verdict that commuted death sentence of banker Azam Reza to life imprisonment in a case filed against him for killing his wife Jayanti Reza.

A four-member bench of the Appellate Division headed by Chief Justice Mohammad Fazlul Karim pronounced the order after dismissing two separate leave-to-appeal petitions filed by the government and Azam Reza against the HC verdict. In 2005, a speedy trial tribunal in Dhaka convicted and

The government and Azam Reza later filed separate leaveto-appeal petitions with the SC against the HC verdict.

The government in its petition prayed for upholding the trial court judgment that sentenced Azam Reza to death, while Azam Reza in his petition prayed for his acquittal. After holding hearing arguments from the counsels for the

petitioners, the apex court yesterday passed the order. On January 9, 2004, the police recovered the body of Jayanti hanging from the ceiling fan in their Banani house.

Azam Reza was arrested the next day after Jayanti's mother Lusil Sadekin had filed a case with Gulshan Police Station.

Advocate AK Badrul Huq appeared for Azam Reza, while Deputy Attorney General SM Abdul Mobin and Assistant Attorneys General Khandaker Diliruzzaman and Fazilatunnesa Bappi stood for the government.
