Alarming rise in murders, other crimes in Khulna

Alarming rise in the number of murders and other serious crimes, mostly involving extortion and drug trafficking, has become a matter of concern for people in Khulna city and district.

Thirteen people were murdered in Khulna city and other places in the district in last two months while the number of murder victims in the district during the 12 months from January to December last year was 14.

Incidents of robbery, rape, theft and eve teasing have also risen in Khulna city recently.

Chhatra Dal activist Raihamul Islam Rabbi was killed on January 4, mason Shahidul Islam was killed by slitting throat on January 11, housewife Hosne Ara was strangled in her Khulna house on January 30, fish vendor Omar Ali of Bagmara under Rupsha upazila was killed the same day, schoolgirl Munira was killed after gang rape at Labonchora and day labourer Yasin Rahman Shuvo was beaten to death at Mujgunni in Khulna city on February 2.

Feroza Begum of Tootpara in Khulna city was beaten to death by her husband on February 16, Abu Musa of Baniakhamar of Khulna city was gunned down by his son and fish exporter Azad Gazi of Phultala upazila of Khulna district was killed in a bomb attack on February 26, Haider Ali and his brother-in-law Tarikul Islam Piku of Banargati in Khulna

Journalist Khalilur Rahman Sumon of local Dainik Probaho, Joint Secretary of Khulna city Chhatra Dal Abdullah-el-Kafi, leader of Khulna CSD Godown Workers Union Md Babul Khan and Chhatra Shibir activist and student of Daulatpur Government BL College Kamrul Islam were seriously injured in separate attacks by rivals since February 23.

The injured are not yet out of danger, said sources at Khulna Medical College Hospital.

Asked about the increasing number of murders and other crimes, Khulna Metropolitan Police (KMP) Commissioner Helaluddin Badri said, "We cannot stop any targeted murder, especially the ones committed due to family feud and interest over financial matters. My forces are working hard to arrest the accused."

Khulna Police Superintendent Tanvir Haider Chowdhury said, "Law and order in the district has not yet gone beyond control. Police is actively working to control crimes. I have no information from any source that outlaws who had gone into hiding during the emergency rule have reappeared anywhere in Khulna


shows that law and order situation in the city and district has worsened during last two months in comparison committed last year.

According to official records of Special Branch of KMP and Khulna district police, 14 murders, including nine in Khulna city and five others elsewhere in the district, were committed from January to December last year.

Murder victims in Khulna city in last year are -- Jubo League activist Parvez Howlader and college girl Shuparna Saha (on January 4), vegetable vendor Shajahan Fakir (February 21), rickshaw puller Jahangir Alam (May 19), drug addict Shujon Karmakar (July 9), KCC ward councillor Shahid Iqbal Bithar (July 11), cold storage employee Noor Islam (August 2), van driver Helal (September 6), ice cream factory worker Ujjal Sheikh (September 19).

Besides, grocer Golam Rasul Mridha of Phultala was murdered on February 21, farmer Joynal Sheikh of Terokheda upazila was killed on May 22, businessman Jahangir Fakir was shot dead in Phultala upazila on June 17, Sharfuddin Biswas and his younger brother Rabiul Biswas of Terokheda upazila were shot dead at the same time on September 22.

Failure to arrest real accused and properly investigate the cases by police is seen by many as the main cause for behind the deterioration of law and order

AL men attack BCL leaders houses for share of 'booty'

At least 10 people including two Chhatra League (BCL) leaders were injured as Awami League (AL) men attacked their houses at Alampur-Biara village in Kazipur upazila on Monday night following an altercation over share of money from extortion and tender manipulation.

The attackers also damaged and ransacked four houses.

The injured have been admitted to Kazipur upazila health complex and local clinics in the area.

Police and locals said a bitter dispute bers. over share of the money from extortion and tender manipulation was prevailing between Kazipur upazila Awami

Farmers worried as urea dealers continue agitation

The farmers of Nilphamari, a major boro producing district, are in great worry as fertiliser dealers in the district have continued their agitation programme for the second day yesterday, postponing fertiliser drawing from the buffer stock at Parbotipur in Dinajpur district.

The district unit of Bangladesh Fertiliser Association (BFA) called the agitation programme for an indefinite period from Monday afternoon to realise their five-point demand.

setting up a buffer stock in Nilphamari, stopping supply of low quality fertiliser to the dealers of the district from the buffer stock, allowing them to take delivery of 40% of urea of locally made Jamuna variety from the factory gate under district's quota, giving them 60% urea of granula variety from buffer stock and end to harassment while drawing fertiliser from buffer stock.

president of the district unit of Bangladesh Fertiliser Association (BFA), alleged

that recently the authority concerned has imported low quality urea (nitrogenated fertiliser) from China.

"The buffer stock authorities compel us to receive that fertiliser although incur losses. Besides, drawing fertiliser from the buffer stock at Parbotipur causes us wastage of time as we have to wait for a long time there for the purpose," he

As the buffer stock at Parbotipur is in Dinajpur district, fertiliser dealers from the district get priority The demand includes whenever they come to take delivery and this causes delay in delivery to the dealers from Nilphamari, said the dealers.

BFA sources in Nilphamari said earlier they had made a complaint to the concern authority of Bangladesh Chemical Industries Corporation (BCIC) with an ultimatum to meet their fivepoint demand by March 7. As time expired without

solution to their problem, all the 73 fertiliser dealers of the Abdul Wahed Sarker, district stopped withdrawing fertiliser from the buffer stock for indefinite period from Monday afternoon.

"We will continue our agitation programme until the demand is met," said Abdul Wahed Sarker.

When the farmers are busy planting boro seedlings in the ongoing boro farmers are reluctant to use season, the protest it. As a result we have to programme taken by the fertiliser dealers may cause setback in boro cultivation, said local farmers.

Many anxious farmers were seen crowding at the fertiliser shops of the dealers and retailers in different markets of the district yesterday as they are eager to purchase fertiliser in advance, fearing crisis in near future.

The district unit president of BFA, however, said there is nothing to be worried as they have a good stock of urea of 3500 tonnes in hands. In the present boro season, the government has allocated 59 thousand tonnes of urea. The quota for the month of February, which is 7.5 thousand tonnes, is yet to be withdrawn fully.

Nilphamari Deputy Commissioner (DC) Farhad Alam has talked to the BCIC authorities in this connection and proper steps has been taken to solve the problem very soon, he said.

BLAST AT SK HELAL'S RALLY

CID seeks remand of 5 JMB men

Criminal Investigation Department (CID) on Monday filed a petition with a court, seeking remand of five JMB cadres in connection with a case for bomb attack on Sheikh Helal's election rally in Bagerhat on September 24,

The JMB cadres now detained in Bagerhat district jail in connection with serial blasts on August 17, 2005 are Md Kalim Molla, Abu Taleb and Hasan Ali Molla of Mollahat upazila of Bagerhat district; Anisuzzaman of Gopalganj district and Hafez Mohammad Rakib Hasan of Jamalpur district.

Judicial Magistrate Md Elias Rahman of Bagerhat has fixed March 11 for hearing on the remand prayer.

The bomb planted earlier at the meeting venue at Khalilur Rahman Degree College ground in Mollahat upazila exploded, claiming nine lives on the spot and injuring 54 others. A case was filed with Mollahat Police Station the same day.

Father of killed college girl Nasima has filed a case with Chuadanga Judicial Magistrate's Court against eight people on charge of killing her daughter. Body of Nasima, 19, a first

year student of Birshrestha Hamidur Rahman College in Khalishpur in Jhenidah, was recovered from a field at Nishikundu village in Jibon Nagar upazila of Chuadanga on Thursday. The girl stayed at her aunt's house at Nishikundu for study.

In the case filed with Chuadanga Judicial Magistrate's Court on Monday, the victim's father Abul Kashem, a poor farmer of village Marufdah of Jibon Nagar upazila, alleged that one Hasan, son of Nazrul Islam Khan of Nishikundu, was the main culprit behind Nasima's killing.

Other accused are Hasan's parents Nazrul Islam and Renu Begum, younger brother Milon Khan, uncle Nasir Uddin and his son Sharif Uddin, daughter Kajoli, and friend Bulbul.

After receiving the case, Judicial Magistrate Sheikh



Aminul Islam ordered police to submit the post mortem report and arrest the accused.

The complainant also prayed for changing IO (investigation officer) of the case for his alleged partiality.

According to the case, Nasima and Hasan loved each other. Recently, Nasima's father Kashem planned to arrange marriage of his daughter. Nasima informed Hasan of the matter and asked him to marry her. But Hasan's family did not agree to it and asked Hasan to 'remove the girl from his way'.

Afterwards Hasan told Nasima to come to his house. When Nasima was return-

ing to her aunt's house from college on Wednesday, two friends of Hasan (still not identified) stopped Nasima at Hasdah Bazar at about 3:30pm. Saying that Hasan was waiting for her, they took Naisma to an unknown place and since then the girl remained missing.

On Thursday afternoon, locals found Nasima's body at Nishikundu field and a police team led by Sub-Inspector Sazzad Hossain from Sahapur police camp recovered the body. Police also seized an empty bottle of poison, a college bag, a veil, cash Tk 17 and a 'suicide note' saying that the girl was going to commit suicide and no one was responsible for it.

Police sent the body to Chuadanga Sadar Hospital and returned it to Nasima's family after post mortem.

In the case, it was alleged that several marks of hitting were found on Nasima's body but police did not record it.

"It was a planned murder. Despite repeated request, neither police nor doctors of the Sadar hospital provided us any information about the post mortem," Sirajul Islam, maternal uncle of the victim, said.

Hunger strike for quick trial of acid throwers

Human rights and NGO activists yesterday staged a hunger strike in front of the local press club demanding quick trial of the culprits who threw acid on housewife Nasima Begum at Komorpur village under Bagerhat Sadar upazila in 2002.

They also demanded an end to harassment of the victim allegedly by the accused. Nasima came under acid attack on the night of August 21, 2002. She filed a case with Bagerhat Sadar Police Station on August 23 the same year, accusing Chhoto Sheikh, Musa Sheikh and Hafizur Rahman of the village of hurling acid at her. After investigation, police pressed charges against the three.

The case is now under trial at Bagerhat District and Sessions Judge's Court while the accused are on bail. The victim, Nasima, was also present at the venue. She claimed the

accused are putting too much pressure on her to withdraw the case. "I along with my husband and children have been staying at my parents' house at Rajapur village under Bagerhat Sadar upazila for two months, fearing further attack by the accused, she said.

The HR and NGO activists called off their programme after Additional Deputy Commissioner (General) Azam Khan assured them of taking steps to end harassment of Nasima.
