### Junior School Certificate exams in early Nov

The education ministry in a meeting yesterday decided that the first-ever Junior School Certificate (JSC) and Junior Dakhil Certificate (JDC) examinations for the students of Class VIII will start in the first week of November.

About 19 lakh Class VIII students of schools and madrasas across the country will sit for the exams under eight general education boards and one madrasa education board while the question papers will be the same all over the country.

Chaired by Education Minister Nurul Islam Nahid, the meeting also decided that the junior scholarship exams and final exams for class VIII students will not be held anymore from this year.

Scholarships will be given on the basis of the results of the public exams and the successful students will be enrolled in Class IX on the basis of results.

There will be no admission

The results of the exams will be published in December in the grade point average system, the meeting decided.

Nahid told newsmen that

the JSC and JDC exams for schools and madrasa students respectively will improve the quality of education. Such exams will also help

reduce the existing gap between the quality of education in urban and that of the rural areas, he said.

Education Secretary Syed Ataur Rahman, Director General of the Directorate of Secondary and Higher Education Prof Noman-ur-Rashid and Dhaka Education Board's Chairman Prof Fahima Khatun were also present at the meeting.

# PM unveils big defence purchase plan

Fighter aircraft, surface-to-air missiles, armaments to be procured for Air Force

Prime Minister Sheikh Hasina yesterday unveiled her government's big defence purchase plan to procure fighter aircraft, surfaceto-air missile system, helicopters, air-defence radars and armaments for Bangladesh Air Force soon.

Besides, she said, the government has already approved a development plan for constructing necessary infrastructure at Cox's Bazar for smooth operation of fighter jets and transport aircraft to ensure security of economic activities in the vast maritime territories and relief operation in remote areas to protect people during natural calamity.

The prime minister revealed the plans while addressing the Bangladesh Air Force officers on the occasion of the Air Force's annual exercises titled 'WINTEX-2010' at the BAF main fighter base at Kurmitola inside Dhaka Cantonment.

"Within just one year of assuming office, initiative has been taken to procure fighter aircraft, surface-to-air missile system, helicopter, air-defence radar, and armaments," she said.

The process is also underway to arrange necessary funds for implementing the development plans for the Air Force, she added.

"The budget allocation for the Bangladesh Air Force in the present fiscal year is the biggest in the history of the force," she told the function.

The prime minister also said various welfare projects for the mem-

#### NIKO GRAFT CASE AGAINST HASINA Hearing on petition begins

The High Court yesterday started the final hearing on a petition that seeks quashing of proceedings against Prime Minister Sheikh Hasina in the Niko graft case.

The case was filed against Hasina during the last caretaker government's rule.

The HC bench of Justice Md Shamsul Huda and Justice Abu Bakar Siddiquee yesterday adjourned hearing on the petition, filed by Hasina, until today.

The Anti-Corruption Commission filed the case with Tejgaon Police Station on December 9, 2007, accusing Hasina and six others of causing Tk 13.6 crore loss to the state exchequer and abusing power while awarding contracts of three "abandoned" gas fields in Chhatak, Kamta and Feni to Canadian energy company Niko Resources Ltd during the pervious Awami League rule.

Hasina filed the petition with the HC in June in 2008 for quashing proceedings against her in the case.

Following her petition, the HC on July 7, 2008, stayed the proceedings against her and also issued a rule asking the government and the ACC to explain as to why proceedings against her should not be quashed.

During the hearing yesterday, Hasina's counsel barrister Sheikh Fazle Noor Taposh said the case was filed against Sheikh Hasina with an ulterior motive of politically harassing her, although she did not commit any crime.

The ACC did not maintain due procedures and rules of the ACC Act, 2004 and ACC Rules, 2007 while authorising the filing of cases, he said, adding that the case cannot proceed in the trial court.

ACC counsel advocate Khurshid Alam Khan opposed the petition, saying that the ACC had filed the case following due procedures.

### 3 injured in bomb blast

A Dhaka court yesterday issued summons asking the chairman and the general secretary of Padmakuri Dance Institute to appear before it on April 8 in connection with a cheating case. The accused are Md

Shahidullah Prince, chairman of the institute, and its general secretary Abul Kashem Sohag. Metropolitan Magistrate

AKM Emdadul Haque passed the order after Shrabonti, a dance artiste and daughter of Sheikh Anisur Rahman of Rupsha in Khulna, filed the case with the Chief Metropolitan Magistrate's Court against the two yesterday. In her complaint,

Shrabonti said she had participated in a dance competition and secured the first position last year. The Baishakhi TV aired the programme. Following the programme, the Padmakuri announced an award of Tk one lakh for her. The accused gave

Shrabonti a cheque for Tk 85,000 after deducting 15 percent from the principal amount. But the cheque bounced twice after Shrabonti deposited it to the Mercantile Bank in the city on December 17 and 29, 2009.

Later, Shrabonti sent a legal notice to the institute through her lawyer on January 25 asking the accused to pay the money, but to no avail, she said.
