Ultra poor people in char areas of Lalmonirhat Sadar upazila have to bear the brunt of price hike of rice as OMS centres at union level are yet to be opened.

Ultra poor in char areas left out of OMS of rice

Several thousand ultra poor people living at different char (newly emerged landmass) areas on Teesta and Dharla river basin are yet to get the benefit of OMS of rice as five dealers are yet to get permission for running OMS centres at the union level in Lalmonirhat Sadar upazila.

OMS of rice started in Lalmonirhat town on February 25, but poor people in the char villages have to purchase one kg of low quality rice for Tk 25 to 26 in the local market, whereas rice sells at Tk 22 a kg at OMS centres.

"We, the ultra poor people in char villages are deprived of OMS facility that is available in town areas. It is difficult for us to purchase rice at government fixed price from there, as most of the char villages are about 10 to 14 kilometres off the town. So we have to purchase rice at high price from the local market," Momena Begum, 40, a resident of

Char Gokunda in Lalmonirhat permission due to unknown rea-Sadar upazila, said.

"The government opens OMS facility for the ultra poor people but those in remote villages are deprived while town dwellers are enjoying its benefit," said Salma Begum, another woman of the same village.

The authorities decided to open 14 OMS centres in Lalmonirhat Sadar upazila -- nine in Lalmonirhat municipality areas and five others in nine unions of Sadar upazila.

But the authorities concerned arranged letter of permission for nine dealers to open OMS centres in Lalmonirhat municipality on February 25, leaving out rural areas at the union level. Five dealers submitted all necessary papers for getting recruitment as OMS dealers for union areas to Lalmonirhat Sadar upazila food control office on February 24 but they are yet to get

Lalmonirhat Press Club on Tuesday noon, the five dealers -- Golam Mostafa, Umar Ali, Ayub Ali, Saiful Haque Mandol and Nazmul Haque Patwary said OMS centres in union areas could not be opened as Lalmonirhat DC is not giving permission to the dealers.

When contacted, District Food Controller Abdus Salam said there is no need to open OMS centres at the union level, as nine OMS centres in the town area is sufficient to meet the demand.

ers, Lalmonirhat DC Mohammad Ala Uddin Fakir said food office has sent a letter to his office seeking permission to open five OMS centres at the union level, but copies of any government circular have not been submitted with the application.

Two rapists get life

A Magura court yesterday awarded life imprisonment to two people for raping a teenager at Majgram village under Magura Sadar upazila in 2005. Judge Mohammad Ruhul Amin Khandaker of Women and Children Repression Prevention Court, Magura, pronounced the verdict. He also fined the convicts Tk 25 thousand each, in default, they are to suffer another three years in jail. The convicts are Jamirul Islam and Tarikul Islam. They hail from Majgram village of the upazila. According to prosecution, the two kidnapped the girl, 15, from Barunatail village on May 5, 2005 and raped her, confining to the house of Mashiur Rahman at Majgram village. On information, elder brother of the victim with the help of locals rescued her from there. Victim's family filed a case with Magura Sadar Police Station against the two.

Fire kills 3-year-old boy

A boy was killed and 16 tin-shed houses were gutted in a fire at Bamandanga village under Muksudpur upazila of Gopalganj yesterday. Police and locals said the fire originated from an oven at the kitchen of one Riju Munshi of the village in the afternoon and soon engulfed the house, killing Riju's three-year-old son Anik who was asleep inside the house. The fire quickly spread to nearby 16 houses and gutted them completely.

Hartal in Barkal upazila

The first day of a two-day hartal called by Samo Odhikar Andolan (SOA), a platform for settlers, and Parbatya Bangalee Chhatra Parisahd (PBCP) passed off peacefully in Barkal upazila of the district yesterday. Both organisations called the hartal protesting murder of SOA activist Harun, 35. Harun went missing on Friday and his body was found on Sunday. Settlers blamed local indigenous people for the killing. Educational institutions and shops at the upazila headquarters were closed while vehicles off the roads. Attendance at banks and government offices was thin during the hartal. Some pickets obstructed a few engine boats at Suvalong in the morning. They however released those after an hour. Activists of SOA and PBCP brought out a joint procession at Barkal upazila headquarters demanding arrest and exemplary punishment of Harun's killers.

Three killed in trawler capsize

Three people were killed as a trawler capsized in the Padma near Hasail Bazar in Tongibari upazila yesterday. The victims were identified as Quddus, 35, Samal, 20, and Asharful, 8, of Netrakona district. Officer-in-Charge of Tongibari Police Station Abdullah said the trawler, carrying about 100 passengers from Hasail Bazar to Padma char, sank in the river at around 7:00am due to over loading. On information, police rushed to spot and recovered three bodies from inside the trawler while the rest managed to swim ashore.

After regaining sense, he told Shahidullah to bring his son before him but he declined.

Next morning Padda Lal came to Shahidullah's house with Ward Member Pober Ali and saw some people whispering.

Shahidullah came out and told Padda that his son committed suicide at night. Then he unlocked the door of a room where Dinesh saw his son's body hanging with mosquito net.

Dinesh burst into tears. Accompanying Pober Ali, he went to "Padda Lal came to Shahidullah's Ranishankoil police station, Pober Ali

Police went to the spot at about 10:30am and recovered the body that bore injury marks on the shoulders, hands and back, said Ranishakoil police station officer-in-charge Jahedul Islam.

The victim's father filed a murder case with Ranishakoil Police Station accusing four people including Shahidullah Haji on Tuesday evening, the OC said.

The body was sent to Thakurgaon Sadar Hospital for autopsy.

Seeking anonymity, a neighbour of Shahidullah told this correspondent that at night he heard screams that seemed to be due to torture.

None was arrested in connection with the incident as Shahidullah and other male members of the family went into hiding, said the OC.

Two housewives, school student commit 'suicide'

Two housewives and a school student allegedly committed suicide in Kushtia and Meherpur on Tuesday.

According to police, Ripa Khatun, 15, daughter of Golam Mostfa of Sadaki village in Kumarkhali upazila in Kushtia killed herself on Tuesday afternoon.

Sources said Ripa, a student of class nine at Patharbaria Mozibor Rahman High School had affairs with one Tariq of the same village.

Tariq was father of a 4vear-old child.

On Sunday, Ripa left her house with Tariq and stayed at the residence of a Tariq's relative at Choraokol village in the same upazila.

The next day the family members rescued Ripa and confined her to a room.

On Tuesday afternoon Ripa hanged from the ceiling of the room locking it from inside. Her body was recovered in the evening.

In Meherpur, 22-year-old housewife Rinki died on the way to a clinic at Bamandi in Gangni upazila at about 4:30 pm on Tuesday.

Rinki, daughter of Moslem Uddin of Mohammdpur village was married to one Alauddin, son of Tenger Ali of Kumaridanga five months
