Criminals torch another betel leaf garden

A devastating fire destroyed betel leaves on seven bighas at Khorda Roygram village under Kaliganj upazila yesterday. The affected garden own-

ers are Jadab Kumar Das, Santosh Das, Ananda Das, Joydeb Das, Sudeb Das, Bijoy Samaddar and Ajit Das.

The land owners told this correspondent that a local criminal gang torched their leaf gardens destroying leaves worth Tk 35 lakh.

Sudeb Das of Khorda Raigram village said, he did not know how he would repay the loan and maintain his family now.

Uzzal Roy, an elderly farmer said, he informed the firemen immediate by after he noticed the fire but they came after 35 minutes with five fire fighting vehicles from

Kotchandpur and Sadar upazila.

Earlier a fire on February 13, betel leaves on 11 bighas were torched in the same village by criminals destroying leaves worth Tk 60 lakh, farmers said.

Garden owner Joydeb Das said, he has no other means to earn for his family. "How can we survive if this goes on?," he posed.

Hundreds of locals yesterday demanded a fire station at Kaliganj upazila. They said every upazila has a fire service office but Kaliganj. Contacted over cell phone,

Kaliganj upazila UNO Anjuman Ara said, nobody lodged any complaint mentioning name of the criminals that allegedly set fire to betel leaf gardens. She said she would take necessary action after investigation.

Depositors protest shut down of Puthia NGO, demand money back

Over a hundred depositors of Jamaat-e Islami controlled NGO--Bangladesh Chashi Kalyan Samity (BCKS)-laid siege to Puthia Police Station on Tuesday, alleging police inaction against corrupt practices of the organisation.

They also demanded that police arrange refunding of about Tk 10 lakh of some 500 depositors by the BCKS.

They alleged that police misbehaved with acting Upazila Chairman Marjina Begum when she came to help the depositors who are being harassed by the NGO

officials.

Sources said some local Awami League leaders challenged Rajshahi BCKS president and Jamaat member Hafizur Rahman while he was going to his school, Shishu Academy, at Puthia Bazar on Tuesday after some of the depositors complained to them of harassment by the NGO.

During altercation, a police team led by Sub-Inspector Mahbub went to the scene, picked up Hafizur from there and released him after half an hour.

Enraged by police acts, the depositors surrounded the police station at around 1:00pm. They withdrew the

siege programme at 5:30pm after police apologised and promised to take legal action against the NGO within the

next two days. They depositors said BCKS has shut down its offices without refunding

300 houses gutted in Dinajpur, Panchagarh

Fire incidents on Monday and Tuesday in Dinajpur, Panchagarh and Moulvibazar districts destroyed at least 300 houses and half a dozen

Our Correspondent in Dinajpur reports: At least 50 houses were gutted in two separate fire incidents in Khansama and Biral upazila on Tuesday afternoon.

Victims said a fire originated from the kitchen of one Mononrajan Roy at Managerpara under Khansama at 2:30 pm on Tuesday and spread quickly burning down at least 40 houses of 10 families.

Firemen went to the spot after about an hour and doused the fire.

Two school students kidnapped in Madaripur rescued

Two school students allegedly kidnapped from Dashar area in Kalkini in the district were rescued from Duttapara on the Dhaka-Khulna highway in Shibchar upazila yesterday.

Family sources said, three people put handkerchiefs mixed probably with chloroform on the noses of Ashikur Rahman Antu, 13, and Mehedi Hasan Raihan, 12, at Kalkini Asram stand and they fell unconscious.

Antu, a class seven student of Darshana High School and Raihan, a class six student of Atahar Ali Academy were returning home from school.

The kidnappers first took them on a tempo and later

boarded a Dhaka-bound bus. The two boys regained their consciousness when the bus reached Duttapara. As they got down from the bus and started screaming, the kidnappers fled the scene.

Antu contacted his father over cell phone and his father informed the matter to Shibchar upazila administration.

The two school students were rescued with the help of upazila nirbahi officer (UNO), upazila engineer and locals. They were later handed over to their guardians through the upazila administration.

Antu is son of Khalil Bepari of Dashar area in Kalkini upazila while Raihan is son of Babul Islam of the same area.


