The cabinet committee formed to review the anti-graft laws has finally proposed immunity only for government officials, making it obligatory for the Anti-Corruption Commission to take permission before filing cases against before the cabinet on March 15.

Ignoring ACC reservations on some points of amendment proposals, the committee has finalised its amendments curbing the commission's mandate to act unilaterally.

The cabinet committee, formed in March last year to review the Anti-Corruption

Commission Act, 2004 and recommend changes necessary to make the anti-graft body more effective and pro-people, finalised the report based on opinions given by other government institutions.

The committee is likely to place its report

Govt targets beggars

Goes for survey, plans rehabilitation in 5 years

The government has initiated a programme to make the country beggar free within five years, by rehabilitating beggars through employment and other incentives.

A core committee for the Beggar Rehabilitation Programme under the social welfare ministry was formed early this month with Gazi Mohammad Nurul Kabir as the committee's chairman.

The committee chairman is also the managing director of National Foundation for Development of Disabled Persons, a government agency which will have involvement in the

The committee is now working out an implementation

strategy for the programme, said Nurul Kabir. The social welfare ministry will conduct a countrywide survey to find out how many beggars there are, and what are their physical conditions are like, as thousands of physically challenged poor people take up begging as a profession, he said.

"We might seek cooperation from the NGOs to conduct the survey which will be completed by the end of June. The Bureau of Statistics will also help us," he said adding that six years ago the country had an estimated 7,00,000 beggars, but the number has increased since then.

"We will also find the causes that drive people into begging, and will find the section of the population who are more susceptible to taking up begging in future," he said.

Niko graft case against Hasina quashed

ACC asked to amend rules of filing cases

The High Court yesterday quashed all proceedings in the Niko corruption case against Prime Minister Sheikh Hasina filed by the Anti-corruption Commission during the caretaker government.

The court also directed the ACC chairman to amend its rules regarding filing and proceeding of any case.

It observed in the verdict that the ACC had filed the case against Hasina at the instigation of a vested quarter in order to politically harass her and damage her image and popularity.

The court has not found any criminal offence in the first information report and charge sheet of the case against her, it said.

The HC bench of Justice Md Shamsul Huda and Justice Abu Bakar Siddiquee pronounced the verdict following a writ petition filed by Hasina for quashing the proceedings against her.

Hasina's barrister Sheikh Fazle Noor Taposh yesterday told The Daily Star that there are five separate cases pending with trial courts.

Separate petitions are pending with the HC challenging proceedings of those cases, and hearing of the petitions will be held soon, he
