## Constitutional reforms to be tabled in Pak Parliament

PTI, Islamabad

A significant legislation to transfer sweeping powers to appoint three service chiefs from President to the Prime Minister will be tabled this week in Pakistan's Parliament as part of a major constitutional reforms package.

The package which includes returning the powers to dissolve the national assembly or lower house to the Prime Minister has been finalised by a panel of Parliamentarian headed by senior Pakistan People's Party leader Raza Rabbani.

The bill also seeks to remove constitutional bars preventing a person from becoming a lawmaker if that person is found to have commented against the judiciary or the army.

The package also includes a proposed amendment envisaging the trial of judges who validate any future military coup on charges of high treason.


## Clarify stand on Modi

Court asks Gujarat

riot probe panel INDO-ASIAN NEWS SERVICE, Gandhinagar

A division bench of the Gujarat High Court yesterday directed the Nanavati-Mehta commission probing the 2002 communal riots to clarify by April 1 whether its decision not to summon Chief Minister Narendra Modi and others was tentative or final.

The direction by the bench, headed by Chief Justice SJ Mukhopadhyay, came on a plea of the Jan Sangharsh Manch (JSM), which has been representing the 2002 riot victims before the judicial panel. The Nanavati-Mehta panel in September last year turned down the plea for summoning Modi, other ministers and officers for deposing before it.

# Karzai holds talks with key militant group

AFP, Kabul

Afghan President Hamid Karzai has met a delegation from the country's second-biggest militant group, his spokesman confirmed to AFP vesterday.

"I confirm that a meeting between the Hezbe-Islami delegation and the president took place a couple of days back," saidWaheed Omar.

Karzai had yet to respond to a peace plan offered him by the Hezb-e-Islami delegation, the presidential spokesman added.

"They brought with them a peace plan, a proposal, and the president is studying it," he

Hezb-e-Islami, one of the biggest anti-Soviet resistance groups during the 1980s, is headed by warlord and former prime minister Gulbuddin

Hekmatyar. The group had once said they would enter into peace talks with Karzai's government only once all foreign forces left quit Afghan soil.

The US State Department designated Hekmatyar as a terrorist in 2003, accusing him of taking part in and supporting attacks committed by al-Qaeda and the Taliban. He is also on a UN blacklist.

The group's spokesman, Haroon Zarghon, earlier told AFP that a delegation of senior Hezbe-Islami members had handed Karzai a 15-point document they hoped would form the basis of peace talks with the Kabul government.

"A delegation comprising senior members of Hezb-e-Islami is in Kabul with a 15-article peace

plan to discuss with the government," Haroon Zarghon told AFP. "Our peace plan has 15 points -- one of them is to set a clear timeline for the withdrawal of

foreign forces and another the formation of an interim administration," Zarghon told AFP by telephone from an undisclosed location. He spoke after Karzai's deputy spokesman confirmed that a series of reported arrests in Pakistan had a "negative impact" on efforts to broker a peace deal with the Taliban, the main

group behind a nearly nine-year insurgency. Analysts say Karzai is walking a knife-edge in efforts to bring peace to his war-ravaged country, balancing the interests of his neighbours and

the Western countries supporting him. Hezb-e-Islami was passive during the 1996-2001 Taliban rule, but regrouped to launch a separate armed resistance, albeit with shared goals, alongside the Taliban after the extremists

were overthrown in a US-led invasion. The delegation currently in Kabul is headed by Qutbuddin Helal, Hekmatyar's deputy and also a former prime minister, Qaribul Rehman Sayeed, Ghairat Baheer and

other prominent figures who formed Hezb-e-Islami, Zarghon said.

# Gunmen kill Pakistani college principal

US drone strikes kill 8 in N Waziristan

Gunmen yesterday assassinated a renowned Pakistani educationist in Baluchistan while eight militants were killed in US missile strikes from drone in North Waziristan.

Fazle Bari, principal of private boys' college Tameer-e-Nau, was killed in the drive-by shooting as he travelled to work in his car through the Baluchistan capital Quetta, senior police official Tariq Manzoor told AFP.

"Bari died on the spot and his driver was wounded," Manzoor said, linking the attack to a recent wave of unrest and "targeted killings."

Some 250 students blocked a main road during a march towards the residence of the Baluchistan governor to protest against the killing, prompting police to fire tear gas to disperse the crowd, an AFP reporter said.

A bomb planted under a rickshaw later

exploded near a paramilitary checkpoint in Quetta, killing a pedestrian and wounding three others, senior police official Hamid Shakeel told AFP.

"A nearby Frontier Corp checkpost could have been the target," he said.

Earlier an unmanned US predator attack killed at least eight terrorists in an al-Qaeda and Taliban hideout in North Waziristan on Sunday, Pakistani intelligence officials have said.

The identity of killed militants in Inzar village of the North Waziristan is not known.

"The targeted compound belongs to a relative of a Taliban commander. Taliban have not started removing bodies yet," the Daily Times quoted a Pakistani official, as saying.

Meanwhile, airstrikes killed 15 Taliban in restive Pakistani northwestern tribal areas on Sunday as militants beheaded three tribesmen accusing them of spying for the United States.

The tribunal will be comprised of serving and retired judges of the High Court or district judges who are eligible to be appointed as the HC judges, sources said, adding that the chairman of the tribunal will be an incumbent judge. One of the members will be a retired judge.

A law ministry source yesterday said they had a proposal to appoint three incumbent HC judges to the tribunal and another proposal to appoint two HC judges and one incumbent district judge.

One will have to appeal against the tribunal's verdict with the Appellate Division of the Supreme Court because the status of the war crimes tribunal would be equivalent to the HC.

The investigators will be appointed from serving and

Investigation Department. They must have good track records. An additional inspector general of police, incumbent or retired, will head the investigation agency, sources added. "We won't keep any dis-

puted people in the investigation agency to ensure fairness," said a home ministry official. The officials also added that

all the members of the tribunal, prosecution team and investigation agency would be competent enough to maintain international standards of the trial. Meanwhile, the cabinet

yesterday ratified the Rome Statute to give the trial an international standard. Bangladesh signed the Rome Statute of the International Criminal Court on July 17, 1998, the first South Asian country to do so.

"The ratification will prove

to follow international standards to prosecute crimes against humanity," Prime Minister's Press Secretary Abul Kalam Azad told reporters after the cabinet meeting, which was presided over by Prime Minister

Sheikh Hasina. The government has also arranged all the necessary logistic support for the trial to be held at the old High Court building.

The government will ensure security to witnesses, accused, prosecution and defence lawyers, investigators, journalists

Talking to The Daily Star Agriculture Minister Matia Chowdhury said, "Our move to trythewar criminals is for justice, not for vengeance and we won't do anything excessive."
