# college teacher sparks protests

Teachers, students and crosssections of people took to the streets in Sylhet city yesterday demanding immediate arrest of the killers of Sylhet Government Women's College teacher.

Harun-ur-Rashid, associate professor of philosophy department, was stabbed to death by a gang of criminals near Gourgovinda Tila in the city while returning to his residence from the college at around 4:00pm.

Thousands joined a protest rally and human chain near the Central Shaheed Minar in the morning while all college teachers in Sylhet division observed work abstention and wore black badges protesting

Members of BCS (education) Association also gave a three-day ultimatum to arrest the killers of Prof Harun-ur-Rashid.

Harun's brother-in-law Al Amin Sarker yesterday filed a murder case with Sylhet Kotwali Police Station. But police could not unearth the motive for the killing as of filing of this report at 7:00pm yesterday.

Parvez Ahmed, landlord of the teacher, said his tenant had rebuked some local youths for teasing girls a few days back.

Sylhet Metropolitan Police (SMP) Deputy Commissioner (North) Ahsan Habib Polash told this correspondent that police would nab the killers very soon.

## Murder of Sylhet PCJSS demands traditional land right of hill people

### Warrant for arrest of Ilyas Ali, wife

A court in Sylhet yesterday issued arrest warrant against former BNP lawmaker M Ilvas Ali and his wife Tahsina Rushdi in a case for ill-gotten wealth filed by the Anti-Corruption Commission two and half years ago.

District and Sessions Judge Md Momin Ullah passed the order and fixed May 10 for framing charges against the accused, as they failed to appear before the court yesterday.

The then ACC assistant director of Sylhet Khandaker Enamul Basir filed the case on July 21, 2008 with Sylhet Kotwali Police Station against the couple for accumulating wealth worth Tk 91 lakh beyond their known sources of income and hiding information of wealth.

and his wife's names.

After investigation, the ACC found Ilyas and his wife had concealed information of their illegally amassed wealth worth Taka 91 lakh in the statement.

## GK project starts water supply for irrigation

GK (Ganges-Kobadak) project yesterday started supplying irrigation water for Irri-Boro cultivation in Kushtia, Faridpur, Jhenidah, Magura and Chuadanga dis-

The project will cover 1.16 lakh hectares of land in the five south-western districts with a target to produce 3.13 lakh tonnes of paddy in the current season, sources said.

Earlier on several occasions, the project failed to ensure smooth water supply due to fall in the water level of Padma River.

Uninterrupted supply will be maintained if water is available in the Padma and it depends on discharge of water at Farakka in the upstream, project officials said.

The project authorities repaired its main intake channel and dredged its drains at a cost of Tk5 crore.

Bangladesh was supposed to get 43,996 cusec of water during March 1-10 and 41,251 cusec during March 11-20 at Farakka but got only 28,000 and 27,798 cusec of water respectively, sources said.

The quantity of water sees decline every year due to withdrawal of Ganges water at Farakka point in the upstream, said a high official of Water Development

Board (WDB) in Kushtia.

The GK project had totally failed to supply water during 1992-1996 due to low flow in the Padma.

The project became operational again after signing of the water sharing treaty with India in 1996.

The GK project started in 1961 with a target to irrigate 4.88 lakh hectares of land in five south-western districts but it could not cover the targeted area due to unavailability of water.

"We are now hopeful of supplying uninterrupted water round the season,' Kushtia WDB Executive Engineer Nazrul Islam said over cell phone yesterday.

# 27 houses, 8 shops gutted in Ctg

Twenty-seven houses, eight shops and assets worth around Tk 30 lakh were reduced to ashes in two sepa-Chittagong early yesterday.

Firefighters said the flames originated from an electric short-circuit at a grocery store at Abu Torab Bazar under Mirersarai upazila around 3:30am and spread rapidly to seven more adjoining shops including a grocery store, a cosmetics shop, a barber shop and a tea stall.

Two fire engines rushed to the spot and extinguished the fire after a two-and-a-half-

According to sources in the Fire Service and Civil Defence, the damage was estimated at Tk 25 lakh.

Meanwhile, 27 homes, rate incidents of fire in the port including 17 shanties and 10 city and Mirersarai upazila in semi-puccas houses, were reduced to ashes in a fire at the port city's Aman Bazar.

Firemen suspected that an electric short-circuit might have caused the blaze at Badsha Mia Colony of the area around 3:15am that spread fast engulfing the neighbouring houses causing an estimated property loss of Tk 5 lakh.

#### 15 injured in clash

Fifteen people, including three women and a police official, were injured in a clash between two groups of people at Kawrakandi ferry ghat in Shibchar upazila on Sunday afternoon. At one stage, two groups equipped with lethal weapons attacked each others, leaving 15 people injured from the both sides. Police sergeant Asad, who went to pacify the feuding groups, was injured during the clash. Nine of the injured were admitted to upazila health complex while six others sent to Dhaka Medical College and Hospital (DMCH) in critical condition.

The decision was taken at an emergency meeting at BAU under the banner of BAU Shikhhok Parishad.

A group of outsiders attacked BAU assistant proctor Prof Alamgir Hossain, students and employees on March 17 night as they opposed a programme marking Bangabandhu's birth anniversary on the campus without prior permission of the university authorities.

At least 50 people including the assistant proctor were injured in the incident.
