\$1.165m grant for CHT dev

ADB and Japan will provide financial support

Bss, Dhaka

The Asian Development Bank (ADB) and Japan will provide financial support for rural development in Chittagong Hill Tracts (CHT).

The Japan Special Fund and Multi-Donor Trust Fund of the Water Financing Partnership Facility will jointly provide 1.165 million US dollar as grant to explore opportunities for small-scale water resources, infrastructure and investment in CHT.

The grant would be administered by ADB, said a statement of the bank in the city yesterday.

An agreement to this effect was signed between the government and ADB at the Economic Relations Division (ERD) in the city.

The technical assistance will examine the potential for small-scale water resources infrastructure and improved rural access to investments with community participation. Besides, skill development training will be given to com-

munity groups so they can be fully involved in the planning, implementation and operation of rural infrastructure. Special emphasis would also be given to strengthen and build up the capacities of the CHT affairs ministry,

Chittagong Hill Tracts Regional Council and three hill district councils. The assistance will pave the way for the Second CHT Rural

Development Project which the ADB is expected to support. The first phase of the project, carried out with ADB assistance from 2003 to 2009, helped improve rural roads and other basic physical infrastructure.

CHT PEACE DEAL HC verdict on April 12

The High Court (HC) yesterday fixed April 12 for delivering verdict on the long pending writ petitions that challenged the Chittagong Hill Tracts (CHT) Peace Agreement and its provisions.

After holding hearing on the petitions for more than 30 working days, the HC bench of Justice Syed Refaat Ahmed and Justice Moyeenul Islam Chowdhury set the date of judgement.

In 2000 and 2007, Badiuzzaman, a Bangalee settler in CHT, and Tajul Islam, a pro-Jamaat lawyer, filed the writ petitions.

The HC following the writ petitions had issued separate rules asking the government to explain why the CHT peace deal and its provisions should not be declared illegal and unconstitutional.

On December 2 in 1997, the previous Awami League government led by Prime Minister Sheikh Hasina signed the peace agreement with Parbatya Chattagram Jana Sanghati Samity (PCJSS) leader Jyotirindra Bodhipriya Larma, popularly known as Santu Larma, ending an over two-decade-old insurgency.

Bangla-Nepal cooperation Change of attitude among stressed

The High Court (HC) on Monday directed the police not to harass or arrest over 200 activists of Bangladesh Jamaat-e Islami and its student front Islami Chhatra Shibir in the cases filed on charge of killing Rajshahi University student Faruk

Hossain. The HC bench of Justice MA Wahhab Miah and Justice Md Abdur Razzaque, however, directed the first information report (FIR) named accused of the case to surrender before the Sessions Judge's Court in Rajshahi within eight weeks in the cases.

The bench passed the orders following 19 bail petitions filed by the accused.

The accused Jamaat-Shibir activists appeared before the HC bench on Monday afternoon seeking bail in the cases.

Some separate 13 cases were filed after the Bangladesh Chhatra League (BCL) activist and RU student Faruk was hacked to death during the RU rampage on February 8 this year.

Barrister Abdur Razzag appeared for the petitioners.

27TH BCS EXAM

HC verdict stayed

The Supreme Court (SC) yesterday stayed for six weeks a High Court (HC) verdict that directed the government to appoint 197 candidates who qualified the first viva voce for 27th Bangladesh Civil Service (BCS) examination, to the services.

Chamber Judge of the Appellate Division Justice SK Sinha passed the order upon a petition filed by the government against the HC verdict.

The judge also fixed April 25 for hearing the regular leave-toappeal petition against the HC verdict at the regular bench of the

apex court. The government has recently filed a regular leave-to-appeal petition with the SC against the HC verdict. In response to three separate writ petitions filed by 197 candi-

dates, the HC on November 11 last year, pronounced a verdict directing the government to appoint them to the services. In another verdict, the HC on January 26 this year directed the

government to appoint 652 other similar candidates. Candidates' lawyer Salahuddin Dolon yesterday told The Daily Star that the government would not be able to appoint the candidates to their services following the apex court order.

On May 30, 2007, the last caretaker government cancelled the viva voce result alleging irregularities in holding examinations. A total of 1,154 candidates, including the writ petitioners, were disqualified in the fresh viva.
