### Avalanche kills 35 in Afghanistan

An avalanche struck a remote mountainous area of northern Afghanistan two weeks ago, killing 35 people and burying homes beneath the snow, a provincial official said yesterday.


The disaster struck in Badakhshan province in the far north, but harsh weather and the remoteness of the province bordering China, Pakistan and Tajikistan meant local officials had to travel for weeks to seek help.

"An avalanche swept through five civilian houses in Arghanj Khowa district killing 35 people including men, women and children," said Marouf Rasikh, the spokesman for northern Badakhshan province.

"Two representatives of the district got to the provincial capital after travelling for 13 days on snow-blocked roads and they informed us of the incident last night," he added. Rasikh told AFP that the area was covered in about three

metres (ten feet) of snow, hampering any rescue efforts and attempts to bury the dead. "Snow closes roads and leaves many villages isolated every

winter in Badakhshan province," he said. "An emergency committee is meeting here tomorrow with the Nato forces to see if we can offer any help via air and helicopters."

## Suu Kyi against party joining polls

Myanmar's opposition leader Aung San Suu Kyi said yesterday she will "never accept" her party registering for elections this year because laws governing the polls are unjust, according to her lawyer.

Myanmar's highest court yesterday refused to accept a lawsuit by Aung San Suu Kyi's political party seeking to revoke laws that bar the detained leader and other opposition members from taking part in the country's first election in two decades.

Lawyer Kyi Win said the Supreme Court refused to accept the lawsuit, saying it did not have power to handle such a case.

It was unclear what steps if any the party would next take in its efforts to quash five election-related laws the ruling military enacted earlier this month that set out

rules for this year's vote. One law prohibits anyone convicted of a crime from being a member of a political party and instructs parties to expel convicted members or face de-registration.

The lawsuit was largely symbolic since Myanmar's courts invariably adhere to the junta's policies, especially on political matters.

Under rules laid down by the ruling junta, the detained democracy icon faces exclusion from her National League for Democracy (NLD) if it registers for the polls, because parties with serving prisoners in their ranks will be dissolved.

Suu Kyi "says she will never accept registration under unjust law, but her personal opinion is not to give orders nor instructions to the NLD," her lawyer Nyan Win said after visiting the Nobel peace laureate.

The new UN mission chief in Afghanistan said yesterday that he backs the Afghan government's peace talks with a major Taliban-linked militant group.

"The talks are helpful and should be supported," said Staffan de Mistura, who added that he is confident that Afghan President Hamid Karzai was working to reform the election process so that parliamentary elections in September will not be a repeat of last year's fraud-stained presidential ballot.

In meetings with the Karzai government during his first week on the job, de Mistura said he was given strong assurances that a "major and constructive reshuffle" of the Afghan-run election commission was imminent. He said Karzai told him that the UN would choose the international members of the Electoral Complaints Commission, which oversees the Afghan elections and rules on the validity of votes cast.

The makeup of both commissions was widely contested in the presidential ballot that led to Karzai's re-election.

"Let's be frank," de Mistura said. "We are not in Switzerland. We are in Afghanistan so the elections are likely to be still imperfect, not perfect. But they need to be credible and inclusive for the sake of Afghans feeling that they are really part of it."

### UN envoy backs talks Indian Maoists blast tracks to derail train

#### Protest against crackdown in six states

Maoists targeted railways - the nation's lifeline - blasting tracks to derail the Rajdhani Express and throw train services haywire in vast parts of eastern India on the second and final day of a shutdown in six states yesterday.

The Maoists have called the protest in Bihar, Jharkhand, Orissa, West Bengal, Chhattisgarh and Andhra Pradesh besides three districts of Maharashtra - Bhandara, Chandrapur and Gadchiroli - to oppose a sweeping crackdown on them.

The guerrillas also killed a policeman and a Communist Party of India-Marxist (CPI-M) leader besides abducting four traders.

The Pakistan government has filed a review petition in the Supreme Court against the National Reconciliation Ordinance (NRO) verdict to reopen the Swiss cases against President Asif Ali Zardari, saying that doing so would be tantamount to a trial of former premier Benazir Bhutto's

"An order to reopen cases abroad would be tantamount to putting Benazir Bhutto's grave on trial, which is against all norms of justice, decency, morality and the law," the petition said while adding that the apex court had made several mistakes by declaring the NRO 'unconstitutional.'

### Evidences depict India's involvement: Malik

Pakistan Interior Minister Rehman Malik has once again blamed India for fanning insurgency in Baluchistan, saying the federal government has 'undeniable' evidence that New Delhi was involved in nefarious activities in the region bordering Afghanistan.

Addressing the Senate, Malik said he would disclose the details regarding India's involvement to parliamentarians during an in-camera meeting and said militants were being provided arms and financial support from foreign countries.

Commenting on the issue of hundreds of missing Baluch people, Malik claimed that the list of missing persons has many 'dubious names', including some people who were in Afghanistan to receive militant training and others who were involved in anti-Pakistan activities in Dubai.
