Our Correspondent in Satkhira reports: A teenage schoolgirl was abducted by a gang in broad daylight yesterday. Victim Kalyani Ghosh, 15,

is daughter of Uttam Kumar Ghosh of village Tulshidanga in Kalaroa upazila. She is a student of class ten at Kalaroa Pilot High School. Quoting locals police said a

gang led by Nasim, son of Azibar Sardar of the same village, used to tease Kalyani on her way to school regularly. Yesterday morning, while she was going to school, Nasim

and his accomplices abducted the girl and took her to an unknown place by a private car. Victim's father Uttam Kumar Ghosh filed a case with Kalaroa police accusing

Nasim and four others. Contacted, officer-in-charge (OC) of Kalaroa PS Enamul Haque said, they are trying to rescue the girl and arrest the culprits.

Our Correspondent in Kushtia reports: Police failed to rescue schoolgirl Shakila who was abducted from Gangni in Meherpur 29 days ago.

On Monday the family members blamed police for inaction at a press conference held at Gangni upazila press club.

They alleged that police did not arrest any of the culprits despite filing case against them soon after the incident.

Sources said, Shakila Khatun, 14, daughter of Raisul Islam of Jorapukuria was abducted by one Aiytal alias Nayan. She was a student of class ten at Jorapukuria High School.

According to police, Nayan, son of Joulush Ali of the same village and his accomplices intercepted the girl when she was returning home from school at about 3:30 pm on February 24. The gang picked up the girl on a microbus and took her to an unknown place.

Bhutto, elder brother of the girl, filed a GD with Gangni police station. In the written statement read out at the press conference, the family alleged that police did not take necessary steps to rescue the girl.

Sylhet shop owners keep shutters down for 6 hrs

Demand release of two employees

Shop owners at malls and in other areas of the city kept shutters down for six hours yesterday demanding immediate release of two employees of a shop at Al-Hamra Shopping City.

The employees, Sayedur Rahman and Shabbir, were arrested along with three shop owners on Monday night following a clash with police at the shopping mall.

The agitating shop owners and employees also blocked the road from court point to Chouhatta intersection for one and a half hours from 11:30am. They withdrew the road blockade after city Mayor Badar Uddin Ahmed

Kamran and AL central Organising Secretary Misbah Uddin Siraj assured them of taking immediate measures to free the two shop employees on bail.

Addressing a rally in court point area with AL-Hamra Shopping City Baybosayee Samity President Abdus Salam in the chair, the speakers demanded withdrawal of the police assault case against shop owners and employees of the mall. City Mayor Badar Uddin Ahmed Kamran and AL central Organising Secretary Misbah Uddin Siraj also

spoke. Fifteen people, including three cops, were injured during a clash between police and shop owners and employees at Al-Hamra

Shopping City on Monday night.

The trouble began at around 8:00pm when a customer and the employees of a cosmetics shop at the mall exchanged heated words

over price of an item. The customer went out of the mall and returned to the mall with a patrol police team at around 8:30pm. Seeing two people with knives in hands with the policemen, the shop owners and employees swooped on them, leading to a clash between the two sides.

After the incident, police arrested three shop owners and two employees of the mall. They (police) later released the shop owners and produced the employees in a court that sent them to jail.

Two get life for murder

A Bogra court yesterday sentenced two people to life imprisonment for killing a man in Kahalu upazila of the district in 2007. The convicts are Afsar Ali Mondol, 35, of Dhekra village, and Musa Paramanik, 35, of Niamatpur village under the upazila. Judge Nitai Chandra Saha of the Additional District and Sessions Court-3 also fined the convicts Tk 20,000 each, in default, they are to suffer two more years in jail. According to the prosecution, Afsar Ali Mondol and Musa Paramanik borrowed Tk 40,000 from Mojahar Ali of Niamatpur village three years ago. As Mojahar pressed for return of the money, Afsar and Musa abducted Mojahar on August 13, 2007. Mojahar's wife Moslema Begum filed an abduction case with Kahalu Police Station on August 17 the same year. Mojahar's body was found in the septic tank of an abandoned house at the village on August 19.

BAU teachers' fresh ultimatum

A group of outsiders attacked Assistant Proctor Prof Alamgir Hossain, students and employees on the night of March 17 as they opposed a programme organised by the outsiders, marking the birth anniversary of Bangabandhu Sheikh Mujibur Rahman on the campus without prior permission of the university authorities.

59 hurt in Sirajganj clash
