A Dhaka court yesterday asked Shawkat Mahmud, BNP chairperson's adviser, to appear before it on April 11 in a case filed against him on charges of calling State Minister for Law Advocate Qamrul Islam "a Battalar

Metropolitan Magistrate Mohammad Shahadat Hossain passed the order after Advocate Moshiur Malek, president of Bangabandhu Foundation, filed the case against Shawkat for making derogatory remarks about

Qamrul. In his complaint, Malek said Shawkat Mahmud, also president of National Press Club, at a rally organised by local BNP at a hotel in Cox's Bazar on March 20 called Qamrul Islam a low quality lawyer that had tarnished image of the state minister at home and abroad. It also hurt the complainant as an Awami League leader, he alleged.

Hearing on Hasina's petitions on April 4

The High Court yesterday adjourned till April 4 the final hearing on the petitions filed by Prime Minister Sheikh Hasina for quashing the proceedings of four corruption cases against her. After hearing on a petition yesterday, the HC bench of Justice

Md Shamsul Huda and Justice Abu Bakar Siddiquee fixed the The cases were filed against Hasina on charges of corruption

in setting up of barge-mounted power plant and Meghnaghat power plant, in the appointment of consultants at the Bangladesh Export Processing Zones Authority and in procurement of frigates.

The barge-mounted power plant graft case was filed by the Anti-Corruption Commission during the previous caretaker government, and three other cases were filed by the nowdefunct Bureau of Anti Corruption during the rule of BNP-Jamaat-led alliance government.

Upon petitions filed by Hasina, the HC earlier stayed the proceedings against her in the cases and issued rules upon the government, Bac and ACC to explain why the proceedings of the cases should not be quashed.

Barrister Sheikh Fazle Noor Taposh appeared for Hasina, while advocate Khurshid Alam Khan stood for the ACC.
