# Drone attack issue to be discussed: Pakistan

Giving drones would change US image

ANI, AFP, Lahore/ Washington

Pakistan's Interior Minister Rehman Malik has reiterated that the US drone attacks in the lawless tribal areas along the Afghanistan border are being carried out without Islamabad's consent and the issue would be raised with Washington during bilateral discus-

Talking to media persons outside the Lahore High Court, where he had appeared in connection with an accountability court's conviction, Malik claimed the US has assured Pakistan to provide it drone technology.

Responding to a question on the recent series of blasts in Lahore, Malik said: "No one should accuse foreigners for such incidents without evidence.'

Malik said that the probe into the incident was underway and a report would come out soon, The Daily Times reports.

Meanwhile, Foreign Minister Shah Mehmood Qureshi said Thursday that the

United States would improve its public standing if it let Islamabad spearhead drone attacks.

Mehmood Qureshi, in Washington for highlevel talks, acknowledged in a CNN interview that drone attacks by US forces against Islamic extremists on Pakistani soil have "taken out some valuable targets."

But he said: "The issue of sovereignty is there. People of Pakistan feel strongly about it.'

"We want the ownership. We make the decision when to operate," he said. "It will help improve the feelings in Pakistan."

Asked if the United States had agreed to his request, he said: "I don't think so."

The United States has carried out nearly 100 attacks with unmanned drones in Pakistan since August 2008, killing more than 830 peo-ple. Figures range widely on how many civilians have been killed.

US authorities have given Pakistan surveillance drones but have hesitated at giving them lethal drones, which are run remotely by Americans.

The Pakistani Government's invitation to some Hurrivat Conference leaders to come for talks to resolve the Kashmir issue has evoked a mixed reaction in Jammu and Kashmir.

Hurriyat leader, played down the invite asserting that a resolution of the Kashmir issue would come only through talks.

The demolition of Babri mosque 12 years ago has returned to haunt senior BJP leader L K Advani when a lady Indian Police Service (IPS) officer yesterday told a court that he had given a provocative speech in Ayodhya, moments before the demolition of the mosque.
