Titas office besieged for gas in N'ganj

Townspeople yesterday laid a siege to Narayanganj office of Titas Gas Transmission and Distribution Co Ltd at Chashara Balur Math to press their demand for resolving gas crisis in their areas.

Agitated people from Isdair, Masdair, Gabtoli, Paschim Masdair, Uttar Masdair and Al Aminbagh areas went to the office in processions in the morning and besieged the office.

Addressing a rally in front of the Titas Gas office, speakers threatened to announce a tougher agitation programme if the gas crisis was not solved immediately.

The agitators withdrew the siege programme after Sheikh Abu Raihan, manager of the Titas Gas regional office, assured them of quick solution to the problem.

They said the residents of different areas, including Bholail, Kashipur, Golachipa, DN Road, Paschim Deobhog, Shitalkahhya, Paikpara, Baburail, Masdair, Paschim Masdair, Uttar Masdair, Bhuiyar Bag, Isdair, Khanpur, Amlapara, Gabtoli and Nitaiganj, do not get gas from morning to midnight.

The residents of these areas filed complaints with Titas Gas authorities several

time, but to no effect, the agitators said.

They alleged that gas crisis became acute in their localities as connection was given to industrial units from the line of residential subscribers.

Amir Hossain, deputy general manager of Titas Gas Transmission and Distribution Co Ltd Narayanganj office, said they are not getting gas supply as per demand. He said they are getting only 75,000 million cft gas against the demand for 1,44,000 million cft gas.

He said work on setting up of regulator controlling station to put an end to gas crisis is under process.

Implement peace deal to stop unrest in hills

PCJSS leaders urge govt

Leaders of Parbattya Chattagram Jana Sanghati Samity (PCJSS) yesterday reiterated their demand for full implementation of the CHT peace agreement and urged the government to curb all sorts of anti-peace activities in the hills.

They said due to delay in implementation of the peace deal, various anti-peace forces are spreading extremism, militancy and fundamentalism in the hills.

The PCJSS leaders were addressing a rally on the premises of Rangamati gymnasium in the town organised on the occasion of 9th national council of PCJSS.

Inaugurating the threeday council, the PCJSS chief and CHT Regional Council chairman Jyotirindra Bodhipriya Larma, popularly known as Santu Larma, said the ethnic people in CHT are passing their days in extreme insecurity.

He blamed the indifference of security forces for the recent killing and arson attacks on indigenous people at Baghaihat and Khagrachhari.

Calling upon the government to take immediate steps for proper execution of the CHT deal, Larma said, "We do not want to see any further delay. Implement the accord fully and as early as possible."

Presidium member of Gono Forum Panka Bhattacharya, secretary of Workers Party Anisur Rahman Mollik, member of Communist Party of Bangladesh Shah Alam, information and publicity secretary of PCJSS Mongal Kumar Chakma and Pahari Chhatra Parishad (PCP) president Udayan Tripura also addressed the meeting.

Pankaj Bhattacharya said militancy, fundamentalism and extremism are spreading allover the CHT as full implementation of the treaty is being delayed.

Pankaj said those who failed to keep peace in CHT must be reprimanded for deaths of two indigenous people during the recent ethnic violence.

Prisoner dies in Barisal

A prisoner serving life term imprisonment for murder at Barisal central jail, died at Sher-e-Bangla Medical College Hospital early Sunday. Prayer for pardoning his conviction on medical grounds was rejected by home ministry recently and he was admitted to the SBMCH on March 25 after his condition deteriorated. His body was handed over to his relatives Sunday afternoon after autopsy, the jail super informed.

Youth's body recovered

Train derails in Bogra

Police said Kona Akter, 16, a student of class IX and daughter of Abdul Halim of Payla Village took poison at 10am Sunday as her mother rebuked her for watching TV at the time of study. In another incident, Rozina Akter, 25, wife of Arif Hossain of Uttar Khan Village allegedly committed suicide by hanging herself at her bedroom on Saturday night following a quarrel with her mother-in-law.

Students study under open sky as police occupy classrooms

Teachers, students and members of managing committee of Baniakhali High School in Dumuria upazila of Khulna district have demanded intervention of the education minister for early shifting of police camp that has occupied three classrooms of the institution

for seven years. After a meeting held on last Saturday, school managing committee Chairman Moni Mohan Chakravarty and Headmaster SK Nasir told this correspondent that

they will go for movement if shift the camp have so far the police camp is not gone unheeded. So, we have removed from the school no other alternative but to within the next month. go on movement against ten complain from anyone

Students and teachers have to suffer much, especially during hot weather, as classes seven, eight and nine are held on the school ground under the open sky.

Number of dropouts, particularly among girl students, is gradually increasing as guardians feel embarrassed amid allegations of teasing and taunting remarks from some of the police personnel of the

camp, the headmaster said. "Our repeated requests to

presence of police camp at the school building since 2003," said chairman of the managing committee.

Number of students has now come down to 478 from earlier 600, showing a rising trend of dropout, he said.

The school that was established in 1966 has nine rooms in two buildings but three big classrooms have been used for the police camp since 2003.

2 sued on charge of killing 52 during '71 war
