Resolve immediately gas-power-water crisis

Lawmakers demand at pre-budget discussion

Lawmakers in pre-budget discussion yesterday pointed to immediate resolution of the public utility service issues like gas, power and water and containing the prices of essentials.

They said it will be difficult to seek support from voters in the next elections if the issues are not addressed.

Held at the National Economic Council auditorium, the discussion was chaired by Finance Minister AMA Muhith.

The parliament members proposed imposition of wealth taxes on houses and cars of the affluent community. They also criticised implementation of the Annual Development Programme (ADP) and the move to ban the use of air-conditioners during peak hours.

The finance minister advised the MPs to raise these issues in parliament and urged them to make the ministries accountable.

"These matters do not arise in a discussion on budget," Muhith said.

Formal handover of local ship to Dutch buyer today

Ananda Shipyard and Slipways Ltd, the country's leading shipbuilding company, is going to formally handover its oceangoing ship Stella Moon to Dutch buyers Stella Shipping tomorrow.

On the eve of the handover function, a press conference will be held at the Chittagong Press Club auditorium today, says a press release.

The company has already set a milestone in the country's shipbuilding industry, exporting its first oceangoing ship Stella Maris to the same company on May 15, 2008.

Ananda Shipyard was the first local company

to receive orders for ocean-going ships a couple of years ago, opening a new era in the country's shipexport sector.

India to give Rs 625cr stimulus for exports of four specific items

India has announced a Rs 625 crore fresh package of incentives for exporters of garments, engineering, electronics and agro products to select markets where the demand for the goods is yet to pick up.

The sops, available from yesterday, will be in force for six months even as official estimates project that India is expected to end the 2009-10 fiscal year (which ended on March 30) well below the \$189 billion exports achieved in 2008-09.

Announcing the new package of stimulus, Commerce and Industry Minister Anand Sharma said here on Wednesday that there were sectors which required continued support as their demand have not yet picked up in key markets.

"We're extending help to some sectors which are still in the red, which include garments, electronics, jute and carpet. Out of the Rs 625 crore incentives, more than Rs 400 crore will go to export of about 300 garment items to the United States and Europe," Sharma said.

The balance will go to engineering, elec-

tronic and agro-chemical goods to 15 countries, including Japan, China, Australia and New Zealand, Nigeria, Algeria and Mexico, he added.

Exports to these countries will get the

benefit of market-linked focus product scheme under which exporters will get dutyfree scrips which can be used to import dutyfree worth two percent of the value of exports. The scrips can also be sold in the market. Welcoming the new stimulus package to

the export sector, the Federation of Indian Export Organizations (FIEO) said it would lend competitiveness to sectors, which are still in the red. Sharma said the export target as set out in

the government's Foreign Trade Policy for 2010-11 is \$200 billion. Official statistics show export of elec-

tronic, jute and carpet goods fell by 28.6 percent, 22.4 percent and 96 percent respectively in February.

Meanwhile, while total exports registered a 34.8 percent increase in February, imports too rose by 66 percent during that month.

Growing import figures show the domestic economy is picking up, Sharma said.



Luxury giant to buy former fashion editor's web venture

Global luxury giant Richemont said on Thursday it was buying up a pioneering 10year-old web-based women's fashion retailer, Net-a-Porter, founded by a former editor and valued at 350 million pounds.

The Swiss group already owns one third of the business, which was created by Frenchwoman Natalie Massenet and employs 600 staff in London and New York.

But its wholehearted venture into Internet fashion retailing would turn the website into one of the luxury goods company's hallmark "maisons," alongside standalone brands such as Cartier, Dunhill, IWC, Piaget and Van Cleef & Arpels.

Massenet would remain as chief executive and will invest in a Richemont unit being created to own the online business, the Swiss group said in a statement. "Richemont announces that it has made

an offer... to acquire all of the shares in Neta-Porter," the Swiss company said in a statement.

"The offer values the equity of Net-a-

Porter at 350 million pounds." Richemont said that it had already received firm acceptances for its offer to buy outstanding shares in Net-a-Porter from owners of stock representing more than 80 percent of the voting rights.

The total valuation given by Richemont, equivalent to 395 million euros or 533 million dollars, amounts to about three times the website's annual sales last year of about 120 million pounds.

Net-a-Porter has adopted the lively style lion pounds. of a chic fashion magazine to sell collections from more than 300 well-known designers, selling to customers in more than 170 countries.

It offers some 300 brands including Jimmy Choo, Stella McCartney and Givenchy, delivering clothes and accessories from an 18 euro (24 dollars) triple pack

of socks up to a 16,600-euro handbag with a few clicks of a mouse.

It defied the recession in the 12 months to January 2009 after notching up a 234 percent rise in pre-tax profits to 10.1 mil-

Massenet used to work for fashion publications Tatler and Women's Wear Daily. In November 2009 she was awarded an MBE honour by the Queen of England.

"Natalie has created a superb, customer-oriented business at Net-a-Porter in a relatively short period of time,"

Massenet commented that her team was proud of what they had built up in the 10 years since the business was founded.

"Richemont has completely embraced our vision and strategy since they came on board as a shareholder and together we are going to continue to build the 21st century model for luxury fashion retailing," she

Massenet reportedly held an estimated 18 percent stake in the website before the deal and stands to make a substantial profit, estimated in some news reports at

50 million pounds. The luxury goods industry in general has traditionally been wary of online retailing.

But a Richemont executive also pointed to recent web sales ventures by Cartier in Japan and the United States.

"The 'maisons' in the Richemont Group are not afraid of the net," he said.

Alessandro Migliorini, an analyst at Helvea bank, described the acquisition as "a surprise," pointing to limited synergies with the rest of the group, although Richemont would gain expertise in Internet sales, he added.

Richemont's share price gained 1.9 percent by lunchtime (1155 GMT) trading on the Swiss exchange.

The Net-a-Porter transaction would be booked for Richemont's 2010-2011 finan-Richemont chief executive Johann Rupert cial year, which began on April 1.
