Trick works for forest gobblers

They take out bark, put salt and copper sulphate into roots to get trees dead; then none sees wrong in felling them

They usually don't fell green trees. It raises questions. Instead, they take out the bark of the Garjan and put salt and copper sulphate into the roots. No immediate harm is done. After three months the trees are dead and there's nothing wrong in felling a dead tree!

A few hundred trees were felled using such tricks in Medhacachhapia reserve forest in Cox's Bazar, one of the 'protected' forests in the

trading the blame for this. The locals think without the help of the officials no-one could enter the forest and take out the bark.

But for the owner of Nahar Tea Garden in Moulvibazar, it is a different case. The Department of Forest itself permitted him to

fell over 3,500 trees.

For the last one month the timber trader who bought the trees from Nahar Tea Garden is cutting hundreds of trees. They are ignoring repeated urges by environmentalists and Khasia people, who cannot grow betel leafs, their main crop and main way to earn a living, without the trees.

By the time the Supreme Court on Sunday imposed a stay for one week on felling trees, the timber trader had already cut down 2,000 trees around the Khasia settlements. The trees are The forest officials and local people are not timber to the Khasia people, who traditionally live on growing betel plants that climb up on these forest trees.

510 trainee BDR men dismissed

The Bangladesh Rifles authorities have dismissed 510 riflemen who were on training during last year's BDR mutiny on charge of carrying firearms and shooting on the second day of the mutiny.

Official sources say the 510 soldiers were recruited in the 76th batch before the February 25-26 mutiny and posted at different battalions. During the mutiny they were on a common training at Rifles Training Centre and School in Chittagong.

The soldiers were discharged from service in phases and the BDR investigations launched after the bloody mutiny found their involvement in the

mutiny. The sources add 528 soldiers were recruited in the 76th batch, but 18 of them were sacked before the Pilkhana

HC gives govt 4 weeks to explain why his takeover, actions not illegal

The High Court yesterday directed the government to explain within four weeks why the seventh amendment to the constitution, which legitimises HM Ershad's takeover and the acts under his military rule, should not be adjudged illegal.

The bench of Justice Md Mamtaz Uddin Ahmed and Justice Naima Haider came up with the rule after hearing a writ petition. Siddique Ahmed, who was convicted of murder and sentenced to life in prison by a martial law court in Chittagong in 1986, filed the petition on January 24.

The seventh amendment ratified the proclamation of martial law and other regulations, orders and instructions by Ershad between March 24, 1982, and November 10, 1986.

Ershad, then chief of army staff, declared himself chief martial law administrator and imposed martial law on March 24,

Legality of Ershad US consulate, rally attacked in Pakistan

45 killed, around 100 hurt

Militants armed with guns, grenades and suicide car bombs targeted the US consulate in Pakistan's north-western capital yesterday and hit a political rally, killing 45 people.

The attacks in quick succession were among the deadliest so far this year in Pakistan, where insecurity has raised concerns in the US as Washington steps up the fight in Afghanistan and against al-Qaeda.

Pakistan's Taliban claimed responsibility for the consulate attack, claiming it was to avenge a US drone war targeting top militants in Pakistan's border areas with Afghanistan, and threatened further assaults on Americans.

The ability of heavily-armed militants to get

so close to the US mission and other military installations, such as the provincial headquar ters of Pakistan's premier spy agency, will likely rattle the US and Pakistani governments.

At least four militants armed with explosives and two cars rigged into bombs targeted the heavily guarded US consulate in Peshawar, a city of 2.5 million on the edge of Pakistan's lawless tribal belt, setting off multiple explosions.

The United States condemned the "terrorist" attack, saying at least two Pakistani security guards employed by the consulate were killed and a number of others were seriously wounded.

SI Kamrul Hossain of Gulshan Police Station said Shahinur succumbed to his injuries on the way to a nearby hospital while Parvez was released after first-aid.

A 210-megawatt capacity power-generation unit of the Ghorasal thermal power plant at Palash upazila of Narsingdi was shut down yesterday following a fire accident that left a security guard severely injured.
