# Quality medical education draws more foreign students

An increasing number of foreign students is coming to study medical education in Bangladesh.

In recent years, 500 to 550 foreign DGHS sources said. students entered the medical education every year, which was only 150 five years back.

In under graduate public medical institutions, there are some 50 seats for foreign students under the South Asian Association for Regional Cooperation quota and 45 seats under non-Saarc

"But, more students are coming Bangladesh. nowadays beyond the quota for receiving quality medical education from Bangladesh that would boost the image of the country and at the same time it earns huge foreign currency," said Khondhaker Mohammad Shefyetullah, director for medical education of the Directorate General of Health Services (DGHS).

A total of 173 foreign students saidthe experts. from 16 countries applied for admis-

sion in MBBS course at the public medical colleges here in 2009-10 session. And except the 95 students, all are going to the country's different private medical institutions,

Students are coming from Malaysia for the last three years, which is a very good sign as previously students were used to come from Nepal, Sri Lanka and other Saarc countries only.

But, in the last session students from Germany, Australia, New Zealand, Iraq and Italy also got admitted to different medical colleges in

The course fee for a foreigner student in public medical institutions is \$US 15,000, which varies from \$25,000 to \$30,000 at the private medical colleges that is cheaper than many other

But the main important thing here is the field for practical education is really vast in this populous country,

The DGHS officials said the govern-

ments from different countries have been trying to increase their quota in the medical system here. A team from the health ministry of Malaysia came to Bangladesh last year and visited some of the private and public medical colleges to test the feasibility to send more students here.

"Malaysia thinks of sending one hundred medical students here in Bangladesh. In recent past, they used to produce health professionals from Egypt," said Dr Shefyet.

While talking to The Daily Star, Dr MA Zaman, principal of Bangladesh Medical College, said the number of foreign students got admitted in the medical colleges has been doubled this

"The number of students from Canada, USA and Nepal are increasing day by day. Last year some seven students got admitted to the different colleges. But, this year the number rose to 14," he said adding that along with the quality, the cost of medical education is relatively cheap here especially comparing with those of Indian medical colleges.

All the medical institutions in Bangladesh are following the same curriculum that was prepared in assistance with the World Health Organisation (WHO). The comprehensive course curriculum 2001-03 is also followed in the South East Asia Regional Office (SEARO) countries including India, Pakistan, Sri Lanka and Nepal.

Abul Hossain Ansari, a foreign student who got admitted to Mymensingh Medical College in 1999, said at that time the number of private medical colleges was very limited.

"With the increase of private medical colleges, there is a significant increase in the number of foreign students," said a Nepali doctor, who is now working as a lecturer of Public Health at Atish Dipankar University. "From the quality side, Bangladesh is second in the Saarc region after India."

The petitioners are Badiul Alam Majumder of Shujon, columnist Syed Abul Maksud, former IGP ASM Shahjahan, AQM Shafiq Ullah, Manoranjan Mandol, Rasheda Akter and Suria Begum.

They filed the petition on Sunday challenging the legality of the failure of the EC and government in framing any rules for the candidates of union parishads to disclose their personal antecedents.

The EC and the secretaries to the EC secretariat and the ministry of law, justice and parliamentary affairs have been made respondents to the rule.

#### Biharis for arrest of land grabbers

### Mojaheed blames caretaker govt for power crisis

Jamaat-e-Islami Secretary General Ali Ahsan Mohammad Mojaheed yesterday blamed the previous caretaker government for severe electricity crisis.

Both the Awami League government of 1996 and the BNP-led four-party alliance government had increased power generation, but the caretaker government did not add a single megawatt to the national grid during their twoyear period, he said at a meeting at the National Press Club.

Mojaheed also said that former army chief Moeen U Ahmed along with his old friends is pulling the strings behind the scene regarding the trial of war criminals.

Quoting from Power Development Board's statistics, he said the previous Awami League government took over in 1996 when electricity generation capacity was around 2100 MW and the capacity increased to 3,300 MW at the end of its tenure in 2001. Later, the four-party alliance government increased the capacity to 4150 MW, but the caretaker government did not add a single megawatt to the national grid.

After revealing the statistics, Mojaheed said, "The fourparty alliance government added more electricity to the national grid than the previous AL government." But the figures show that the fourparty alliance government added 850 MW while the AL government added 1200 MW to the national grid.

The Jamaat leader also threatened to launch onepoint 'oust government' movement if a ban is imposed on their party politics.

Dhaka city Jamaat Ameer Rafiqul Islam Khan presided over the meeting addressed by Jamaat Assistant Secretary General Muhammad Kamaruzzaman, ATM Azharul Islam and Abdul Kader Mollah.

## ACC decision on questioning Khaleda today

The Anti-Corruption Commission (ACC) will decide today its next step regarding investigations into two allegations of corruption against former prime minister and BNP Chairperson Khaleda Zia.

The ACC has already issued three notices on Khaleda but failed to get proper response from her with regard to a date for questioning her.

In reply to the third notice issued on March 25, Khaleda said she would not face any questioning before going through documents and papers concerning the allegations, ACC sources said.

Khaleda also wanted the ACC to provide her with

detailed questions in advance of the questioning. The ACC received her reply on Sunday.

The commission issued its first notice on February 14 and the second one on March 3 seeking appointment with her for questioning. In reply to these two

notices, Khaleda had also said she needed to go through necessary documents before being questioned. Top ACC officials yesterday

said there must be an end to this issue of sending and resending letters and that the commission would sit today to decide its next step.

ACC sources also pointed out that the law does not permit them to send documents and papers to Khaleda.

The allegations against Khaleda include laundering of about Tk 7.5 crore of public money for purchasing land for Zia Charitable Trust and misappropriation of funds for construction of Bhairab Bridge, which caused a loss of Tk 100 crore to the state exchequer when she was the prime minister, the sources said.

The money laundering probe also involves Khaleda's sons Tarique Rahman and Arafat Rahman Koko, as they are also trustees of the charitable trust.

Once the ACC inquiry finds sufficient information about an allegation, it files a case and conducts a fully-fledged investigation, ACC officials
