Buriganga Grabbing

Cleanup begins, resistance follows

The Dhaka district administration yesterday started an eight-month long demolition drive against illegal structures by the river Buriganga at Nawabchar in Kamrangirchar.

A total of 28 illegal structures have been knocked down on the first day of the drive.

Bangladesh Inland Water Transport Authority (BIWTA) along with police, Rapid Action Battalion (Rab), Fire Service and Power Distribution Company Ltd assisted the district administration to carry out the three-hour drive.

Over 70 labourers, BIWTA tugboat Agrani and a bulldozer were used in the drive to reclaim the river area as earmarked by the cadastral survey.

Hundreds of panic-stricken landowners and local Awami League leaders of Nawabchar descended on

the streets clasping land documents to confront the district officials.

Magistrate Mohammad Al Amin told the crowd that his team was there to execute an order issued by the High Court (HC) on January 24 to reclaim the river.

"We shall not demolish an inch more than what our survey report points out," he assured the crowd.

While many broke into tears, an elderly woman burst into wailing on the road saying that she had only one katha of land and she would defend it with her life.

Last December, as per a directive by the HC, the deputy commissioners of Dhaka, Narayanganj, Munshiganj and Gazipur submitted survey reports on the rivers Buriganga, Turag, Balu and Shitalakkhya.

Syed Mannan Ali, officer-in-charge of Tarail Police Station, said the girl had killed herself.

4 firms short-listed for expressway

The government has short-listed four companies for the Dhaka Elevated Expressway project at an estimated cost of Tk 8,617 crore.

The Bridge Division yesterday informed the cabinet committee on economic affairs about the matter at a meeting at the Cabinet Division with Finance Minister AMA Muhith in the chair.

The Bridge Division asked the committee to give it Tk 2,500 crore allocated for publicprivate partnership (PPP) in the current budget to meet the primary expenses including con-

sultants' fees.

The meeting, however, did not take any final decision in this regard. If needed, the Bridge Division will be given more than Tk 2500 crore for the purpose, meeting sources said.

The four companies are Italian-Thai Development Public Company Ltd (Thailand), Sikder Real Estate KCC JV (Bangladesh-Korea) Gammon Infrastructure Projects Ltd. Bouygus Travaux Publics SA Consortium (India-France) and China Railway International Ltd (China).

Khulna University was closed for an indefinite period yesterday after a group of students confined a photojournalist to a room that led to clashes between police and students.

In a meeting around 1:30am, the university syndicate made the decision with Vice-Chancellor Prof Mohammad Saifuddin Shah in the chair. The syndicate asked residential students to vacate the dormitories by

6:30am yesterday. Trouble began when 20-25 students of architecture department, mostly loyal of Islami Chhatra Shibir and Jatiyatabadi Chhatra Dal, picked up Shahnewaz, staff photographer of Bangla daily Prothom Alo, and confined

The government's socio-political campaign to uproot extremism has apparently lost all enthusiasm thanks to leadership problem in the home ministry and reluctance of the ministries and agencies concerned in performing their duties.

The home ministry, after a five months' gap, is holding a fresh meeting to discuss progress of the campaign and assess the latest situation, said Home Secretary Abdus Sobhan Shikder.

State Minister for Home Shamsul Hoque Tuku heads the Jongi Protirodh and Protikar Committee [Committee for Resistance and Correction Militancy] that held its last meeting on October 28 last year. But the committee -- originally formed under the leadership of former state minister for home Tanjim Ahmed Sohel Taj -- was supposed to hold its meeting every month.

The committee comprising representatives from various ministries and agencies took various innovative initiatives to make people aware about extremism.

A Dhaka court yesterday sent Shahina Yeasmin, wife of detained businessman Giasuddin Al Mamun, to jail after she surrendered to it in a graft case in which she was earlier jailed for three years in absentia.

Judge (in-charge) Jesmin Anwar of the Special Judge's Court-7 passed the order after rejecting her bail petition in the case filed for acquiring wealth illegally and concealing wealth statement to the Anti-Corruption Commission.

Shahina along with her lawyer Masud Ahmed Talukder appeared before the court to seek bail.

The court also directed the jail authorities to give her first class division if she is entitled to it as per the Jail Code.
