AL MP, 13 others sued on war crime charges

Fourteen people including advocate Muslem Uddin, an Awami League (AL) lawmaker from Mymensingh-6 (Phulbaira) were sued here yesterday for their alleged involvement in war crimes during the War of Liberation in 1971.

Labour secretary of Phulbaria upazila AL and freedom fighter Jalal Uddin filed the case with Cognizance Court No-2.

The accused are -- advocate Muslem Uddin, MP, 76, Fayzal Bari, 61, Abdus Samad Master alias Tikka Khan, 75, Abdul Jabber, 60, Abdul Mandal, 80, Mofiz Uddin alias Mofi, 80, Reaz Uddin Fakir, 72, Abdul Jabber, 68, Mukshed Ali, 70, Amjad Ali Haji, 75, Ebadullah, 70, Mukshed Ali, 80, Wahed Ali Munshi, 80, and Sohrab Ali, 78. They all hail from different localities of Phulbaria upazila.

There are 14 witnesses in the case including ANM Nazrul Islam, ex-MLA from Phulbaria and principal Motiur Rahman, an AL lawmaker from Mymensingh Sadar and Md. Khondaker Adul Malek Shahidullah, an ex-MP from Muktagachha upazila here.

According to the allegation, the plaintiff and his two brothers took part in the liberation war in 1971. Muslem Uddin, then elected MPA, joined the Razakars (an anti-liberation force), and held many meetings with Razakar chief Abdul Hannan in greater Mymensingh.

alleged that Muslem supplied many secret documents of the freedom fighters in Phulbaria to the Pakistan occupation forces and helped them set the freedom fighters on fire. The accused also outraged the modesty of several women.

The accused in collaboralooted the houses of the plaintiff and set those on fire on June 27 in 1971, it was also alleged.

They also looted and set on fire five houses of freedom fighters Abdur Razzaq, Abdus Salam and Abdul Mannan in Phulbaria.

Dike collapse worsens flood situation in Netrakona

With inundation of more haor areas in Kalmakanda and Madan upazilas, flood situation in Netrakona further deteriorated yesterday,

According to sources in Water Development Board (WDB), the situation in the haor areas is getting worse as flood protection embankment at Huldharia in Kalmakanda upazila collapsed early yesterday due to rise in water level in the river Dhanu.

The fresh affected areas are

Sunadhubi, Jangalia, Bishorpasha, Nagdohor, Harindhara, Kalaikandi, Ragurampur and Gujakulia haors (water bodies) in Kalmakanda upazila and Gobindashree, Gogda, Uchidpur and Uluhati haors in Madan upazila.

Netrakona Agriculture Extension department sources said, 1,76,000 hectares of land have been brought under boro cultivation in the district this year. Of them, 69 hectares are in haor areas of Khaliajuri, Mohonganj, Madan and Kalmakanda upazilas.

Flash flood caused by onrush of hill

water from across the border has so far damaged Irri-boro crops on 35 thousand hectares of land in the haor areas of the four upazilas, sources added.

Malaka Begum, mother of six children of Mandarbari village under Mohonganj upazila, broke down in front of local journalists, saying that she cultivated boro on five acres of land by taking 20 thousand taka in loan, but flash flood damaged the plants. She posed a question how she will maintain her seven-member family as she has lost everything.

Majnu Mia, 55, of Lepsia village under Khaliajuri upazila cultivated boro on six acres of land by taking loan from an NGO, but flood water damaged his all boro plants. He said, "How I will repay the loan and maintain my family."

Chairman of Khaliajuri Sadar Union told the correspondent that 50 percent boro plants had gone under floodwater in the last two days while the rest will damage if the situation aggravates further.

They felled 11 eco-friendly trees worth about Tk one lakh and took them away, they said.

Alamgir Hossain, headmaster of the school, was on leave on the day. He submitted a written complaint to the upazila education officer against Alauddin, also a former member of local union parishad, and his men yesterday. Didarul Islam, chairman of the school

managing committee, said Alauddin and his men cut down the trees and took them away in the name of renovation of a nearby mosque.

They also took away pipe of a dysfunctional deep tube-well from the school ground by digging soil recently, Didarul added.

When contacted, Baufal Upazila Education Officer Mostafa Kamal said, "We shall go for legal steps against the tree plunderers after proper investigation".

Jubo League leader held on rape charge

The members of Rapid Action Battalion (Rab) yesterday afternoon arrested a top Tangail Jubo league leader, the main accused in NGO worker rape case, along with contraband phensidyl and liquor.

Acting on a tip off, a team from Crime Prevention Company-3 of Rab-12 led by its deputy additional director Salek Uddin, raided the brickfield of Robi Khan, 45, vice-president of Tangail district Jubo league in Taratia area under Sadar upazila and arrested him from the

The accused offered to drop her by motorbike at her office on the way to his brick field. Instead, he took her to a room of his brickfield in Taratia area and raped her there, according to the complainant.



HSC examinations

At least 126 of the 1,080 HSC candidates from Koira upazila in Khulna district could not appear at the ongoing examinations as cyclone Aila last year turned their families homeless and pauper, making them unable to prepare for the examinations.

They did not even get any financial support to fill up their forms for the examination, said several candidates and teachers.

The candidates hailing from Bagali, Maharajpur and Uttar Bedkashi unions under Koira upazila could not continue their study as they also lost their books and study materials, said Koira upazila parishad chairman GM

Mohsin Reza. The remaining 954 candidates are appearing at the HSC examinations from three centres in Koira upazila amid manifold odds.

The institutions have remained inundated since Aila and accompanying tidal surge on May 25 last year caused embankment collapse and massive flooding. The candidates have been

provided with lodgings in different hostels and houses for the examination period but crisis of safe drinking water and severe power outages are making them suffer, said Principal SM Aminur Rahman of Zobeda Khanam Mahila Degree College. Several candidates said

they have to start for the examination centre after taking very little food and wade through knee-deep water to reach there.

"Many candidates are suffering from water borne diseases including skin diseases as they have to come in contact with polluted water. Communication in the upazila has collapsed after flooding due to embankment breaches," said Koira UNO
