All 29 accused jailed

A special court of Bangladesh Rifles yesterday sentenced all the 29 accused of 25 Rifle Battalion to different terms of rigorous imprisonment for their involvement in February 25-26 BDR mutiny in 2009.

BDR Director General Maj Gen Mohammad Mainul Islam delivered the first verdict of BDR mutiny case in Panchagarh. After the arguments from the defendants and prosecutors on Tuesday, the Special Court-2 delivered the judgment yesterday around 4:00pm.

Thirteen jawans were sentenced to seven years' term while one to six years', one to four years', six to three years', two to two years', five to thirteen months' and another to four months'.

The same court on Sunday framed charges against the 29 accused.

The court awarded lesser punishment to seven of the 29 accused as they sought mercy confessing to their guilt at the beginning of the trial, which saved time in

The president of the court said this day and the verdict would remain as an example in the history of BDR. All legal proceedings were maintained during the trial and the accused were given 57 days' time instead of 27 days.

EC for DCC polls on May 31

Govt wants it in winter

The Election Commission decided to hold the overdue polls to Dhaka City Corporation on May 31 but the government policymakers do not want the election now.

In a letter, the EC Secretariat yesterday informed the LGRD ministry about its preparation and decision to hold the polls on May 31, around three years after expiry of the current DCC's tenure, EC officials said.

The policymakers and ruling Awami League leaders believe the ongoing crisis of power, water and gas and high prices of essentials might go against ruling party's mayoral candidate in the battle for ballots.

Talking to The Daily Star yesterday they said holding election to the DCC at this juncture might benefit the opposition's candidate, as they will certainly try to cash in on the ongoing crises. They favoured holding the polls in winter as they believe the

power situation will improve then and prices of essentials would come down. The EC has decided to announce schedule for the polls some-

time in the middle of this month, around 45 days ahead of the polling day, EC officials said.

Top outlaw killed in 'shootout'

A top leader of outlawed Gono Bahini Ashraful Islam alias Mandar was killed in a shootout with Rab in the district town yesterday.

An accused in 50 criminal cases, including 17 killings, Mandar was claiming responsibility to police and local journalists from the spots after the killings.

Rapid Action Battalion officials said their team raided a field of Khordobakhail village in Sadar upazila at 8:15pm when Mandar and his cohorts were holding a secret meeting.

Kyrgyzstan govt

president flees capital

Opponents of President Kurmanbek Bakiyev took control yesterday of Kyrgyzstan after a day of spectacular violence that ended with Bakiyev fleeing the capital of the strategic Central Asian state. Opposition protesters seized the presidential administration

last night and announced on state radio that they had formed a provisional government with former foreign minister Roza Otunbayeva at its head. A worker at Bishkek's international airport told AFP that the

60-year-old Bakiyev had fled the capital aboard a small plane as his opponents consolidated their grip on key national institutions.

Opposition leader Temir Sariyev said on Kyrgyz radio that Prime Minister Daniyar Usenov had signed a letter of resignation and Otunbayeva vowed that the new leadership in the country would move quickly to normalize the situation.

"Power is now in the hands of the people's government," Otunbayeva said in an address on state radio.

"Responsible people have been appointed and are already working to normalize the situation."

The fast-moving events in Kyrgyzstan capped a day of ferocious clashes in Bishkek and other cities that quickly turned into a nationwide revolt against Bakiyev that was believed to have left scores dead.

FOREST GOBBLERS' TRICK

Ministry's clarification

In a clarification of a story published in The Daily Star on April 6 titled "Trick Works for Forest Gobblers", the Ministry of Environment and Forests said it permitted Nahar Tea Garden to chop down only dead trees in Khasia settlements.

The explanation says Nahar Tea Garden and others got a High Court order in favour of chopping down all the trees, which the Supreme Court recently stayed.

Regarding poisoning of Garjan trees at Medacchapia Reserve Forest, the ministry said actions were taken against the offenders. It, however, also claimed "no incidence of poisoning took place because of the strong vigilance on the part of forest guards".

Prime Minister Sheikh Hasina yesterday sternly admonished the water resources ministry for failure to repair flood protection embankments in cyclone Aila affected coastal districts of Satkhira and Khulna even 10 months after the storm.

She directed the authorities to finish the job within this month before the monsoon arrives.

She said rehabilitation of Aila affected people, and the repair work should have started by October last year and completed by January this year.

The Water Development Board (WDB) got Tk 115 crore from the food and disaster management ministry in July last year for the repair work.

The High Court yesterday rejected an appeal from Bashundhara Group Chairman Ahmed Akbar Sobhan alias Shah Alam, who challenged a police move to interrogate him with links to Ahmed Hossain murder case.

He now has to appear before the Detective Branch of police at its Minto Road office on April 11 to face the grilling.

The HC also refused the prayers for court directives on police to quiz Shah Alam at his residence or any other "neutral place" in presence of his counsel and issuance of a rule seek-
