# Organised gang steals drugs, sells in market

12 arrested in last three months

An orgainsed gang in collaboration with some employees steals costly medicines from Rangpur Medical College Hospital (RMCH) and sells them to different private clinics, medicine shops and rural medical practitioners.

Kotwali police sources said 12 people were caught red-handed in the last three months while stealing medicines from RMCH.

Acting on a tip-off, law enforcers from Sadar Police Station raided the house of one Abdur Rahim in Dhap area of the town on Friday last and recovered a huge quantity of medicines meant for Rangpur Medical College Hospital (RMCH) from there.

Police arrested Abdur Rahim on charge of keeping government medicines in his possession. After preliminary interrogation, they produced Rahim in a court that sent him to jail.

On the night of March 31, police arrested a RMCH employee named Nuruzzaman on the college campus while he was taking away some medicines. Nuruzzaman was later released on requests from some leaders of Bangladesh

Medical Association (BMA) Rangpur unit and RMCH Director Anisul Karim, police sources

One Sabiha Begum of Dhap area was arrested in January while he was stealing 50 bags of intravenous saline from the hospital. A case was lodged with kotwali Police Station in this connection.

Police said Rahim told them that a number of nurses, peons and ward boys of RMCH supply medicines to them. They also sell the stolen medicines to different private clinics, hospitals and rural medical practitioners. Some medicine traders from Midford, Dhaka, also purchase costly medicines from them, police quoting Rahim said.

Rahim said they are so influential that RMCH authorities dare not take action against

When contacted, RMCH Director Anisul Karim said a three-member committee is investigating the theft of medicines from RMCH. The committee will submit its report by April 11 and necessary actions will be taken on the basis of the report, he added.

# BCL now threatens to lock VC's house

Academic and administrative activities at Chittagong Veterinary and Animal Sciences University (CVASU) were held peacefully yesterday.

The university reopened on Sunday following a 46-day closure.

The university authorities also decided to take internship board final examination today, campus sources said.

Vice chancellor Dr Nitish Chandra Devnath who was confined to his residence for the last couple of days went to the capital yesterday morning.

"I have come to the capital to join a conference. I will meet the government high ups and discuss current university situation," the VC told this correspondent over phone from Dhaka.

BCL convener of the university unit Kamol Kanti Majumder said they would lock the vice chancellors' residence soon.

"The VC is no more wanted to play any role in the academic and administrative activities,"

he said. Meanwhile, an anonymous caller allegedly threatened University Teachers' Association convener Prof Goutam Buddha Das over phone

the organisation. It wasn't expected," Prof Goutam said quoting the caller.

However, BCL CVASU convener Kamol denied the allegation of threatening Prof Goutam by anyone of his organisation.

The authorities closed the university sine die on December 14 last year following an indefinite strike enforced by General Students Forum and BCL to realise 21-point demand including resignation of the VC on charge of corruption and nepotism.

The authorities in an emergency syndicate meeting on March 31 decided to reopen the halls on April 3 and resume classes the next day. But the BCL leaders staying in the hall defy-

ing syndicate orders demanded removal of the VC and decided to bar him from all administrative activities.

They put the VC office under lock and key

confining him (VC) to his residence. The university teachers' and officers' associations and employees union also observed work abstention on Monday and Tuesday protesting alleged manhandling of teachers, officials and staff of the university by the agitating students.

Besides, the teachers also gave a three-day ultimatum to the university authorities on Tuesday to punish the students who manhandled the teachers and threatened them over phone.

# Transport workers block road, rail to protest Rab action

Transport workers blocked rail and roads in Narayanganj for about three hours after Rab personnel allegedly beat up a bus driver at central bus terminal here yesterday morning.

The sudden blockade caused immense sufferings to school and college going students and more than one lakh people who attend their offices in Dhaka everyday from the district in buses and

Aids of a Jubo League leader attacked Ghorashal municipality office, assaulted a female

councillor, employees and looted Tk 30,000 yesterday, allegedly for delay in payment of bill.

Witnesses said at least 15 Jubo League activists led by one Hossain went to the place around noon and beat up ward councillor Suraiya Mofiz, accountant Shahidul Islam and office staff Akter Faruk and Gulzar Hossain Swapon.

Hossain is reportedly an aide to Javed Hossain, general secretary of Jubo League's Palash upazila unit and a construction contractor.

The gang destroyed documents, ransacked furniture and took away Tk 30,000 by breaking a steel almirah.

Moniruzzaman, secretary of the municipality, said Upazila Nirbahi Officer Shaila Yasmin of Palash administers the municipality, which currently has no elected mayor.

He said payment of some development bills to SJS Enterprise of Javed have been delayed, as the UNO has to
