Teachers stage class boycott as BCL locks VC's residence

Chittagong Veterinary and Animal Sciences University (CVASU) unit of BCL yesterday locked the vice-chancellor's office-cumresidence on the campus on Wednesday night prompting teachers yesterday to announce boycott of classes from tomorrow.

The university reopened on Sunday after 46 days of closure. Classes and administrative works could not be held until Wednesday due to agitation by BCL backed students and protest programme by employees, officers and teachers of the university.

As the university resumed academic and administrative activities on Wednesday and the authorities fixed Thursday for internship board final examination, VC Dr Nitish Chandra Devnath went to Dhaka on the day to attend a conference and inform the government highup about the latest university situation.

In absence of the VC, the BCL men locked the evening office-cum-residence of the VC at teachers association also gave a three-day around 10:30pm.

It prompted the teachers association to hold an urgent meeting yesterday morning.

The meeting strongly condemned and protested the incident. They demanded immediate inquiry into the act and punishment to the culprits.

They also announced boycott of classes as a token protest tomorrow.

Tipu Sultan, an assistant teacher of Government Laboratory High School in the town, received a 'stand release' order yesterday on charge of mercilessly beating up two students of the school over a trivial matter on Monday.

Earlier on August 5 last year, the same teacher beat up a class nine female student of the school, making her get admission into director of Secondary and Higher Secondary Mymensingh Medical College Hospital with hearing problem and headache a day after.

"As the allegation of merciless beating against Tipu Sultan were proved, the authority took action and he was transferred to Government Joyhori High School in Kendua upazila of Netrakona district this morning," Amena Khatun, headmaster of the school, said vesterday.

Tipu Sultan has a tendency to behave in an aggressive way when he becomes angry, said a few teachers and guardians.
