Toxic ships to sail in smoothly

Ship-breakers now to produce toxic free certificates as import policy changed; HC directive ignored

Bypassing the court's clear directives to ensure import of toxin-free ships, the government yesterday altered an import policy order, which will help ship-breakers import toxic ships.

Without considering the country's environmental aspects and workers' safety, a certain quarter within the government allegedly changed the policy order in a way that exporters themselves will now certify their ships as not toxic.

Commerce Minister Faruk Khan told reporters that the change in the import policy order for ships to be scrapped was decided at an inter-ministerial meeting considering the development of the country.

Following a High Court directive dated March 17, 2009, the commerce ministry incorporated a condition in its Import Policy Order 2009-2012 that an exporter has to submit a precleaning certificate from a state agency of its

country saying the ship is cleaned before export. The importer will have to submit that certificate to the authorities here.

But now the company that sells the ships will provide this certificate saying all toxic substances are cleaned, Faruk said.

Shipyard owners were reluctant to go by the old policy since pre-cleaning of toxic substances including asbestos involves huge cost and reduces their profit.

They allegedly lobbied with some high officials and ministers for changing the policy.

Before the policy was formulated, the exporter still had to provide this clearance certificate, but that was not legally binding and no one could be sued for providing false information.

The High Court in its directive ordered the government to make the policy as per the Basel Convention 1989, which says no country can export or import toxic waste or ships containing toxic substances.

BCL goes berserk

Beats up RU proctor, provost, house tutors to 'protest' hall raid

Rajshahi University unit Chhatra League cadres on Wednesday night beat up its proctor and his two assistants, a hall provost and two house tutors while police raided Shaheed Samsuzzoha Hall.

BCL cadres also vandalised the proctor office and an office room and the guest room of the hall. Resident students of the hall said police

along with the help of hall authorities and the proctorial body raided the hall around 11.30 pm on Wednesday night to pick up illegal residents.

Hearing the news of raid, BCL workers led by its president Awal Kabir Joy rushed to the hall. Joy asked hall provost Dr Mortuza Khaled as to they conducted the raid without his permission.

At one stage, they drove Mortuza out of the hall by holding his neck and beat up him and his two house tutors in front of police, resident students said. They said BCL cadres also beat up Proctor

Prof Chowdhury Zakaria and his two assistants while they were trying to resist the attack. Later, they vandalised proctor office and the

hall rooms. Provost Mortuza Khaled admitted the mat-

ter but Proctor Zakaria declined to say anything to the reporters. RU unit BCL president Awal Kabir denied the allegation.

Meanwhile, Provost Council, an association of provosts from sixteen halls, at a meeting yesterday announced their work abstention for Saturday and demanded punishment to the attackers.

Water crisis cripples life

Persistent water crisis accompanied by random power outage has put the citizens of the capital into a real-life endurance test.

Kanchan, a resident of Uttar Para in West Kafrul, was yesterday seen in a long queue since 6:00am for a bucket of water from a Wasa lorry. Around 200 families of the locality are not having supply water for the last one week.

"Buying water from these lorries has become impractical because it takes Wasa three days to provide water if you pay for it today. There is a long queue they have to deal with first," said Kanchan, who finally managed to get two buckets of water after a five-hour wait.

Wasa has started distributing water in lorries twice a day from Wednesday, which is far too little to meet the demand of the area, said Kanchan, adding, "My family is going without bath for the last one week.'

The situation at Gulshan-1 to Azad Mosque area is even more severe as they are going without supply water for the last 17 days. These days they are buying drinking water in jars. "Since Wednesday, we are buying a lorry of water from Wasa

for Tk 1,400 which is officially Tk 400. Still that is not getting us any near to having regular supply of water," said Ekram Kabir, a resident of road-29 in Gulshan-1.

He said they have been taking bath at offices, clubs or even at

US, Russia agree to cut nuke arms

Obama, Medvedev sign landmark treaty

US President Barack Obama and Russian leader Dmitry Medvedev signed a landmark treaty Thursday committing their nations to major nuclear arms cuts.

Under the new Strategic Arms Reduction Treaty (START), the former Cold War foes will be allowed a maximum of 1,550 deployed warheads, about 30 percent lower than a limit set in 2002.

It also imposes limits on the air and submarine-borne intercontinental ballistic missiles that carry warheads.
