Acting Civil Surgeon Abu Md Khairul Kabir said the contractor con-cerned will be showcaused and the contract will be cancelled, if necessary, to improve the situation.

As the couple did not come out of their room in the morning, family members broke open the door and found Manju's slaughtered body lying on the floor while Shamsuddin hurriedly fled the scene. On information, police recovered the body and sent it to Sadar hospital morgue for autopsy.

### Houses, shops gutted

At least nine houses and four shops were gutted in separate fire incidents in the district yesterday. Fire brigade sources said a fire that originated from the kitchen of Ambia Begum at Dhalat village in Sadar upazila burnt down three adjacent houses at noon. In Lalpur upazila, five houses were damaged in a fire at Walia East Shahapara village. Locals said the fire originated from the kitchen of Shaker Ali of the village at about 12:30pm and soon engulfed four other adjoining houses. Besides, four shops were gutted as a fire broke out at Walia Bazar in Lalpur upazila early yesterday.

# Wife killed Belal, cut body into pieces, say police

Sufia Begum confessed to killing her husband Ahsanul Huq Belal, a trader of Mahiganj area of Rangpur town, by giving him poisonous fruit juice on Sunday night.

She said she cut the body into pieces, kept them in a sack and carried the mutilated body to Porshuram on Monday night by an autorickshaw for burial.

Police said Sufia disclosed details of the murder during her three-day remand that expired yesterday. She was yesterday produced in the Judicial Magistrate's Court where she gave her confessional statement.

Investigation officer of the case said Sufia's son Shishir denied his involvement in the killing.

Sufia was placed on a threeday remand while her son Shishir on one day in connection with the murder.

# 3 housewives killed in Nabinagar of B'baria

# Villagers clash for control of new land mass: 20 hurt

At least 20 people including four policemen were injured during a fierce clash between people of two villages over taking control of a newly emerged land mass at Charvatera village in Daudkandi upazila on Friday

Police said residents of Chengrakandi village of Daudkandi upazila and Charvatera village of Meghna upazila were at loggerheads over taking control of the land for long.

Daudkandi upazila nirbahi officer (UNO) and officers-incharge (OC) of both police stations at a meeting with the feuding groups on Friday morning decided to settle the dispute on Sunday.

But at noon, the musclemen of Mohiuddin of Charkathalia village of Meghna uapzila and Shahjalal of Chengrakandi village of Daudkandi upazila equipped with lethal weapons attacked each other leaving 20 people including four policemen injured. Some 10 houses were also ransacked by the feuding

groups. The injured were rushed to different hospitals and clinics. Another report from Pabna adds: At least 15 people were injured as villagers and police

clashed at Arambaria village in Ishwardi upazila on Friday. Police said the villagers caught Muktar Hossain, 23, suspecting him a human trafficker and gave him a good

beating.

When police rushed to the spot to rescue Muktar, villagers attacked them. A scuffle between police and villagers left 15 villagers injured. Villagers claimed that police at one stage opened fire on them leaving two young men -Ripon and Masum - injured.

Ripon was later sent to Rajshahi Medical College and Hospital in critical condition while others were admitted to upazila health complex and

Outraged by the police firing, agitated villagers blockaded the Pabna-Lalpur road and vandalised 10/15 vehicles. Later, police cleared the barricade and restored traffic movement.

Ishwardi police station OC Shamiul Alam, however, claimed that none was hit by bullet. He said police fired only once to bring the situation under control.
