Putting the poor in the soup

Feud over listing beneficiaries set to deprive 15,000 of jobs in lean period

Government's employment generating programme meant for ultra poor people is yet to start in *monga*-prone Jaldhaka and Kishoreganj upazilas of the district although the period of the 40-day programme expires on April 20. Feud among selection committee

members belonging to different political parties in the unions and factional feud of ruling Awami League men over compiling lists of beneficiaries has created the deadlock, depriving 15 thousand extreme poor of getting employment opportunity in the lean period.

The project funds may have to be returned if the April 20 deadline expires without implementation of the programme, said the upazila nirbahi officers (UNO) of Jaldhaka and

Kishoreganj. After successful completion of a 60day employment generating programme in November-December last year, the government initiated second phase of the programme to create employment opportunity for about 50 thousand ultra-poor people in six upazilas of the district

for more 40 days, said District Relief Officer (DRO) Amzad Hossain.

The period of the second phase is from March 10 to April 20.

There are 9.5 thousand prospective beneficiaries in Jaldhaka upazila and 5.5 thousand in Kishoreganj upazila. Under this programme a beneficiary is supposed to get Tk 120/ a day for working in various rural development fields.

A nine-member committee comprising local body representatives, elite, social workers, women and members of professional groups is supposed to make lists of beneficiaries for finalising by the upazila selection committee headed by UNO, the DRO said.

In all the unions of Jaldhaka upazila, activists of four political parties were included in selection committees as the lawmaker from Jaldhaka is from Jatiya Party, upazila chairman is from Jamaate-Islami, upazila vice chairman is from Jatiya Samajtantrik Dal while different factions of ruling Awami League men try to dominate the committees.

Almost in all unions, the number of

committee members exceeded nine.

insist inclusion of the names of their men in lists of beneficiaries while there are allegations that several committee members took Tk 10001500 as bribe from poor people on condition to include their names in the list, sources said.

The programme could not start in the upazila as the 12 union selection committees could not submit lists of beneficiaries as of vesterday, said Jaldhaka UNO Shahidul Islam Bhuiyan.

There is often dispute among committee members from different political parties over including names of their men in the list of beneficiaries and dissatisfied members refrain from putting their signature in the final list, creating deadlock in launching the programme, he said.

In Kishorganj upazila, the programme could not start in nine of the ten unions as the committees concerned failed to prepare lists of beneficiaries.

Internal feud among different groups of local Awami League is almost open over inclusion of their men in the lists of prospective beneficiaries.

Chairmen and councillors of the The committee members usually respective union parishads also show

interest in the matter.

"On April 4, I served a 'final notice' asking for submission of lists of beneficiaries immediately as the programme expires on April 20," said Kishoreganj UNO Dr Ziauddin.

It is difficult to reach consensus as members of four political parties are included in the union selection committees, said Khutamara union parishad Chairman Abu Sayeed Shamim, also general secretary of Jaldhaka unit union parishad chairmen's forum.

He said pro-Jamaat selection committees, chosen by the upazila chairman, who is a Jamaat leader, are refraining from putting signature on the list of beneficiaries as the lists are not up to their satisfaction.

Jaldhaka upazila Chairman Sayed Ali, on the other hand, said problems are not with Jamaat men but with those from Awami League and Jatiya Party.

Several thousand ultra poor people recently staged demonstration in front of Kishorganj UNO office protesting cor-ruption of a section of selection committee members and demanding early implementation of the programme.

2 Jubo League men placed on remand

Earlier, investigation officer of the case on Saturday submitted prayer for their five days remand.

A Bangladesh Chhatra League activist was killed and

10 others were injured in a clash between BCL and Jubo League activists over tender dropping at Panchagarh UNO office on Thursday.

Victim Faruk Hossain, 17, son of Akbar Ali of Mithapukur village in Panchagarh municipality area was organising secretary of Ward No-1 BCL unit.

Faruk died in the clash while 11 others were injured.

Early Saturday police arrested Liton, 24, Koshai Monju,28, Mohsin,32, and Mostafizur Rahaman, 28, from different places of Panchagarh town.

The indigenous people yesterday floated flowers on

Garjantali, seeking divine blessings for peace and prosperity. Besides, the ethnic people, who live in different hill areas, floated flowers on rivers or fountain water. Today (Tuesday) is 'mul

biju (main function), the

indigenous people prepare 'pachan' a kind of mixed vegetable curry, this day to feed the guests. They also make pithas (cakes) and sweetmeats and take locally made liquor to mark the day. The third day is "Gojjya

Pojjya Din" or the first day of Bangla new year. The indigenous people host each other at their respective houses on the day.

Marmas celebrate 'water festival' on the first day of Bangla new year. State Minister for CHT Affairs Dipankar Talukder is expected to inaugurate a 'water festival' at Betbunia in Rangamati on the day.

Meanwhile, United Democratic Front (UPDF) anti-peace accord organisation, are boycotting 'Biju Utsab" in Rangamati and 'Boishabi Utsab' in Khagrachhari districts in protest against recent violence in the two districts.

The UPDF leaders have urged the indigenous people to boycott all programmes of ' Biju' and 'Boishabi' festivals and stay united to protect their rights.

Pirates abduct three

Pirates on Sunday night abducted three fishermen from Porakatla canal of the river Malancha in the Sundarbans and demanded Tk 45,000 ransom. The pirates held the three hostage in the deep forest and asked the family of each for Tk 15,000, police said. Nineteen fishermen with three boats went to the Sundarbans on Thursday taking permission from the Kaikhali Forest Office in the Sundarbans. While they were asleep the pirates swooped on their boats and abducted the three out of 19 for ransom. The victims are Mongal Kumar Mondal, Bimal Kumar and Subhas Chandra of village Munshiganj in Shyamnagar upazila.

Charge framing deferred

Sylhet Divisional Speedy Trial Tribunal Judge Md Mahbubul-Islam yesterday deferred charge framing date in the case for bomb attack five years ago on veteran Awami League (AL) leader Suranjit Sengupta MP's public meeting. The court set the new date on April 29. Police said, some of the accused including Mufti Hannan from Dhaka could not be brought to Sylhet as their presence was needed in some other cases in the capital. However, they would be produced on the next date. An activist of the AL, Abdul Wahid, 45, was killed while 30 others received injuries as the bombs were hurled on dais at the fag end of the public meeting held at Derai upazila headquarters in Sunamganj on June 21, 2004. However, Suranjit escaped unhurt as he along with other leaders got down from the dais minutes before the attack.

30 hurt in B'baria clash

At least 30 people were inured in a clash between two rival groups at Shilaur village under Sadar upazila yesterday. During the clash, they also damaged at least 40 houses there. The clash that lasted for two hours took place between Ladu group and Sadu alias Sadat group of the locality. The injured people were admitted to Brahmanbaria Sadar Hospital. Seriously injured are Abul Kalam Azad, 35, Munna, 18, Manir, 20, Ripon, 28, Murshid, 32, Muhammad Hossain, 18, Uzzal, 20, Tahmina, 30, Anwar Mia, 25, Anwar Hossain, 28. On information, a team of riot police rushed to the spot and fired 15 times from guns and lobbed seven rounds of tear gas shells. Police also arrested seven from the spot.

Abducted boy rescued

Meherpur police on Saturday rescued abducted Kushtia school student Nayeem Hossain from Mothmura village under Gangni upazila. Police also arrested five people on charge of their involvement in the incident. According to police, a group of criminals abducted Nayeem, son of Bozlu Biswas of Bus Stand area under Mirpur upazila in Kushtia on April 8. Nayeem is a student of class nine at Rifles Public School in Mirpur in the district. The gang picked up the boy into microbus when he was going to a local bazaar at about 4:30pm and later phoned his father Bozlu, a businessman of the upazila for Tk 25 lakh ransom. However, Bozlu filed a case with Mirpur police station and police arrested two friends of Nayeem. On the basis of their confessional statement, a police team raided a house at Mothmura village in Gangni upazila in Meherpur at about 6:30pm and rescued Nayeem. Police also arrested three other captors from the spot.

Hapless examiness protest 'misdeeds' of principals

One hundred and six examinees of Gour Bangla Syeda Maria Moumuna Krishi College in Shibganj upazila of Chapainawabganj put up blockade at Pukuria on Chapainawabganj-Sonamasjid road yesterday demanding chance for appearing at the examinations that they could not attend due to alleged corruption of the principal.

As the students took to the street from 10:30am to 12:00pm, hundreds of vehicles remained stranded on the busy highway, much to the sufferings of passengers.

Later Shibganj Upazila Nirbahi Officer Abu Taher Mohammad Masud Rana and Shibganj police station Officer-in-Charge Anwar Hossain persuaded them to withdraw the blockade. Earlier on Thursday, the

106 students under Bangladesh Technical Education Board submitted a memorandum to the education minister through the deputy commissioner of Chapainawabganj demanding punishment of the principal for 'misappropriation of a total of Tk 3,70,000 from them'.

They said that they were the first, third, fifth and seventh semester examinees under Bangladesh Technical Education Board this year. The examinations started on March 22 but they could not attend it as they did not get admit cards.

They alleged that college Principal Ranaul Alom

Shamim took Tk 3,500 from each of them for filling up forms but just a day ahead of the examination they knew that their forms were not sent


