Seawater damages watermelon on 1,500 hectares in Patuakhali

Watermelon on over 1,500 hectares of land in different upazilas of the district have been damaged due to flooding by salty water from the Bay and adjoining rivers during new moon last week, much to the worry of farmers.

Under the influence of the new moon, tidal surges from the Bay and its adjacent rivers flooded over 1,500 hectares of watermelon fields from April 7 to 9, said sources at Agriculture Extension Department (AED).

The huge salty water has damaged various green crops including watermelon. Even after receding of water from those fields watermelon on the fields has continued rotting due to the effect of salty

water. Local farmers said the area of damaged watermelon fields would be 1,500

hectares as salty water entered the fields. AED sources, however, said water-

melon on 377 hectares of land has been damaged fully and on 580 hectares partly. This year watermelon was cultivated

on 6,276 hectares of land in seven upazilas of Patuakhali district -- 4,500 hectares in Galachipa upazila, 1,346 hectares in Kalapara, 275 hectares in Baufal, 70 hectares in Dashmina, 50 hectares in Sadar upazila, 20 hectares in Mirzaganj and 15 hectares in Dumki, said sources of AED.

During recent visits to different areas under Kalapara and Galachipa upazlias, this correspondent saw many watermelon fields, especially those in low areas, are still under water. Watermelon is rotting on those fields although water receded.

"I cultivated watermelon on 1.80 acres of land at a cost of Tk 30,000. I planned to sell watermelon after 10/12 days later but sudden tidal surge flooded it. Although

water has been removed from my fields. watermelon is rotting due to bad effect of salty water. I have sold it for very low prices as most of it has already rotten," said Abu Bakar, 50, a farmer of Dhulashar village in Kalapara upazila.

He said he had hoped to earn Tk about one lakh but the amount would be hardly Tk 25,000.

Nasir Howlader, 40, Mosharef Hossain, 42, Bellal Howlader, Joynal Abedin, 45, Eunus, 35, Zafor, 38, and Eusuf, 36, of the village also told similar stories.

Most of the farmers cultivated watermelon with the money received as loan from banks or NGOs but all their hopes are

now nipped in the bud, said several farmers. When contacted, AED Deputy Director Nikhil Ronjon Mondol said they have already made a damage list in the district and sent it to higher authorities recommending take necessary step in this regard.

Rangpur trader Belal's body exhumed

Police yesterday exhumed the body of murdered trader Ahsanul Huq Belal, a resident of Mahiganj in Rangpur town.

After digging up the body in presence of Executive Magistrate Anjuara Begum at about 10:00am, it was sent to the morgue of Rangpur Medical College Hospital.

The body was exhumed to detect any poisonous ingredient in it, said Kotwali Police Station Subinspector Noor Alam, also investigation officer of the

As the question of involvement of people in addition to Sufia Begum in the killing has been raised, police decided to exhume Belal's body, said Kotwali | Police Station Officer-in-Charge Abdur Rashid.

Police recovered and arrested Sufia Begum at Moyenakutti on April 5 night when she was going on a CNG-run scooter with the mutilated body of Belal.

In a confessional statement under Section 161 to a judicial magistrate, Sufia Begum said she alone killed Belal by having him take poison-mixed fruit juice and later cut the body into pieces.

Three outlaws arrested in two dists

Three members of outlawed Purba Banglar Communist Party (PBCP) were arrested in Sirajganj and Satkhira districts yesterday and on Tuesday night.

The arrested outlaws are Abdul Mannan, 35, Abdul Hannan, 32 of Uttar Shyampur village under Tarash upazila of Sirajganj, and Bidyut Kumar Bachchu, 38, of Maguradanga village under Tala upazila of Satkhir. According to our Sirajganj

correspondent, law enforcers arrested Mannan and Hannan, raiding Uttar Shyampur village at around 3:30am. The outlaws were later

produced in a Sirajganj court that sent them to jail.

Police said the two were wanted in a number of criminal cases.

Our Satkhira correspondent reported that detectives arrested Bidyut Kumar Bachchu, a regional leader of the outlawed PBCP, in Maguradanga area under Tala upazila on Tuesday night.

Bachchu was released from jail three weeks ago and was reorganising the party in Tala upazila.

Acting on a tip-off, the law enforcers raided Maguradanga village and arrested

Pahela Baishakh reminds them of the tragedy

Nine years after the heinous grenade attack at Ramna Batamul in the capital during Pahela she threw the question. Baishakh (Bangla New Year) celebrations, found crying, remembering the untimely departure of their near and dear ones.

Talking to The Daily Star, they demanded exemplary punishment to those who were involved in the attack. The horrifying memories of the incident are still fresh in their mind.

Al-Mamun, 23, Reazul, 22, and Shilpi, 20, three cousins and college students in Baufal upazila of Patuakhali, went to Ramna Batamul together to join the Pahela Baishakh celebration but all of them were killed in the grenade attack.

They were among the 10 people who were father of Reazul. killed in April 14, 2001 grenade attack that also left over 100 others injured.

"When Pahela Boishakh comes close every year, my pain increases as I lost my son on this day. I buried all my hopes here nine years

back," said Al-Mamun's mother Nur Jahan, showing his grave.

"Can you tell me why my son was killed?"

"We want to know the names of masterfamily members of three slain victims were minds behind the cowardly mayhem and see their punishment," Kashem Gazi, father of Al-Mamun, said when this correspondent visited his house at Kachipara in Baufal upazila.

> Parvin, sister-in-law of Shilpi, said she rushed to the spot immediately after hearing the news of the blast. Doctors declared all of them dead at BSMMU Hospital, said Parvin who was living in Dhaka during the time. Shilpi stayed at her house to celebrate the programme on Bangla New Year.

"I forbade my son to join any gathering but he didn't listen," said Shamsul Haq Gazi,

Every year the family members arrange milad mahfil and special prayers for salvation of the departed souls. The New Year now brings tear for them instead of joy after the death of their near and dear ones, they said.

Fraud 'pir,' accomplices remanded
