# 20 hurt as rival Pabna BNP men clash

Twenty people were injured as rival groups of BNP in Pabna yesterday locked in a clash when Opposition ChiefWhip Zainal Abedin Farroque went to appear before a court to seek bail in a defamation suit.

Farroque appeared in Pabna District and Sessions Judge's Court for bail in a defamation case filed by a local leader of Bangladesh Chhatra League for passing 'derogatory remarks' against Sajib Wazed Joy, son of the prime minister.

Rival party men attacked each other with brickbats and sticks during the BNP leader's entry into the court and also during his departure after gaining bail from the court, said witnesses and Pabna BNP leaders. Supporters of expelled district unit leaders

of Farroque's vehicle at Traffic Moar near the court. They demanded withdrawal of expulsion of Kamrul Hassan Mintu, the former organis-

chanted slogans, lay down on the street in front

ing secretary of district unit BNP, also mayor of Pabna municipality, and Anisul Haque Babu, former secretary of Pabna Sadar upazila BNP.

Some party men and police escorted the Opposition chief whip to safety.

Police also charged batons on the fighting groups to bring the situation under control.

Pabna Sadar upazila BNP President KM Musa, Organising Secretary Salim Sardar, Pabna district unit JCD Secretary Siddikur Rahman Siddik and activist Nur Mohammad Masum were seriously injured during the clashes.

Sixteen other leaders and activists also sustained injuries.

Secretary of Pabna district unit BNP Habibur Rahman Tota and expelled leader Anisul Haque Babu later blamed each other for the violence.

There has been feud in Pabna BNP over expulsion of a few leaders after the last upazila elections and non-inclusion of some leaders in the district committee, said party sources.

#### Kuet BCL demands VC's removal

Bangladesh Chhatra League (BCL) Khulna University of **Engineering and Technology** (Kuet) unit has threatened to go for movement if their fivepoint demands including resignation of Kuet vice chancellor are not met within seven days.

Addressing a press conference at Khulna Press Club yesterday, the BCL leaders of the university also accused VC Prof Md Nausher Ali of harbouring vested groups loyal to BNP and Jamaat.

The BCL demands include fair investigation into the incident of assaulting director of students' welfare of Kuet and exemplary punishment of those who were involved in it, withdrawal of suspension order against the president and secretary of Kuet BCL unit, opening of the institution and arrest of Chhatra Dal cadres and their exemplary punishment by conducting a fair probe into the Sunday night's incident on the campus.

Kuet was closed for an indefinite period from Monday after a clash between Chhatra League and Chhatra Dal Sunday night over forma-tion of a committee to celebrate Pahela Baishakh.

#### Workers, security men clash at Benapole port

At least five people were injured in a series of clashes between security personnel and agitated workers of Benapole port who were being deprived of their wages on time.

Unloading of goods at the port remained suspended for one hour as the workers refrained from their duties during the period.

According to port authorities, a discord was developed when workers demanded payment of their arrear wages from the port authorities on the eve of Pahela Baishakh. But the port authorities disagreed to fulfill workers demands.

## 10 sued for war crimes in C'nawabganj, Satkhira

Ten alleged collaborators of Pakistani occupation forces have been sued for war crimes in Chapainawabganj and Satkhira districts.

Six alleged collaborators of Pakistani occupation forces were sued yesterday for killing a man at Rehaichar in Chapainawabganj town in 19 71, According to our correspondent, The accused are Nazrul

Islam, 80, Saidur Rahman, 60, Fazlur Rahman, 85, Latifur alias Luka, 75, bishu, 85, and Nazrul Islam Fuka, 80. They all are from Rehaichar area of Chapainawabganj town.

Rahima Begum, 68, wife of late Giasuddin filed a petition case with the Chief Judicial Magistrate's Court, accusing

the six of killing her husband in on September 15, 1971.

In the petition, the complainant stated that the accused picked up her husband Giasuddin from their house, took him to Mohononda Char near the town and shot him dead.

The court ordered the officer-in-charge of Sadar Police Station to investigate the matter and take necessary legal steps. Our Satkhira correspon-

dent reported that a petition case was filed with the Judicial Magistrate's Court here on Sunday against four alleged razakars for killing, looting and arson in Debhata upazila during Liberation War.

The accused are Jabed Ali Sana, 65, son of Sobed Ali Sana of Nazirergher village, Aziz Moral, 62, son of Alam Moral of Shanta village, Badar Ali Moral, 67, son of Madar Ali Moral of North Parulia and Abdul Hannan, son of Taraf Ali Moral of Garerdanga village in Debhata upazila, court sources

Nurul Islam Shahji, son of martyred freedom fighter Nur Ali Shahji of Uttar Parulia village in Debhata upazila filed the case with the court, accusing the four of killing his father at Naihati village on

October 22 in 1971. In the petition, the complainant stated that on the fateful day when his father came to house to meet his family members, the accused attacked their house, looted cash and other valuables and set the house afire.

They, later, took his father to a nearby bush and shot him dead, the complainant added.

#### HABIGANJ SERIAL BLAST CASES

### Charge-framing against 7 JMB men on May 25

A Habiganj court yesterday deferred chargeframing against seven JMB men in four of the five cases for serial blasts in Habiganj town as operative Salah Uddin alias Salehin of the banned outfit could not be produced before the court from Kashimpur Jail.

Additional District and Sessions Judge Md Awlad Hossain Bhuiyan fixed May 25 for framing charges against the accused.

Public Prosecutor Akbar Hossain Iitu told this correspondent that the court deferred charge-framing in the four sensitive cases due to absence of Salehin. "I have submitted a petition to the judge, urging him to send a letter to the inspector general of prison for producing Salehin in the court on May 25 as the case trail is being delayed," the PP said.

Cases were filed against the seven JMB men following serial blasts at five places in Habiganj town on August 17, 2005.

#### AL activist murdered

An Awami League activist was hacked to death in Noapara industrial area on Monday night. The dead was identified as Zahid Hossain Tarafdar, 42, of Akterpur village under Abhoynagar upazila of Jessore district. Police arrested two people--Suman and Surat Ali-- of the same village suspecting their involvement in the murder. Police quoted locals as saying that five unidentified men came to Zahid's mobile phone shop at Taltola at around 10:00pm and stabbed him. The gang left the scene, leaving him critically injured. Zahid was rushed to the upazila health complex where the doctors declared him dead. A murder case was filed with Avhoynagar Police Station.

#### **Extortionist arrested**

Army personnel arrested an extortionist at Gorgojjapara under Laxmichhari upazila of Khagrachhari district yesterday. The arrestee is Amol Jyoti Chakma, 45, son of Robidhon Chakma of Patachhara area under Manikchhari upazila of the district. Police said, the army men, acting on a tip-off, raided Gogojjapara area and arrested Amol while extorting money from local traders. On Monday, army personnel of Sindukchhari zone arrested an illegal toll collector. He was identified as Jano Kumar Chakma, son of Ananda Kumar Chakma of Goiyapara village under Ramgarh upazila.

#### Abducted fisherman freed

A fisherman, abducted by a gang of pirates from Sundarbans on April 6, was released on Tuesday. Pirates abducted the fisherman, Rabiul Islam, 17, son of Saheb Ali of village Mathurapur under Shyamnagar upazila while he was catching fish in Chelakata canal. The gang then demanded Tk 20,000 ransom from the victim's family for his release. Sources said Rabiul 's relatives reached Dudli area in the Sundarbans in the afternoon and gave Tk 7,000, batteries, rice and ten litres disel to the gang to get him back.

#### Four deer poachers jailed

A court here on Monday sentenced four deer poachers to rigorous imprisonment. Senior Judicial Magistrate Md Mahruf Hossain also fined the convicts Tk 10,000 each, in default, they are to suffer six more months in jail. The convicts are Sripada Sardar, Shahidul Sheikh, Masum Gazi and Lakkhon Sardar, Police arrested the four in Koira upazila while they were slaughtering two spotted deer in February this year.

#### Engr held on bribery charge

A case was filed against the engineer with Sadar Police Station. Contacted, Rafiqul Islam, executive engineer (sales and distribution) of Tangail PDB, confirmed the incident and said departmental action will be taken against the engineer.
