

Fence can't always stand as a barrier

Pahela Baishakh, the first day of Bangla New Year, presented a different scene on Omarkhana border in Panchagarh Sadar upazila as thousands of Bangla speaking people living on two sides of the border got a unique opportunity to meet their relatives.

Standing on both sides of the barbed wire fence on Omarkhana border between pillars No 743 and 744, people of Bangladesh and India exchanged greetings and talked heartily with their near and dear ones.

A large number of people in both countries, especially those who cannot afford the expenditure to visit their relatives through legal

procedure, eagerly wait for this special day. People from different districts of the two countries were seen exchanging various things including biscuits, chanachur, pens,

clothes and towels. Seeing near and dear ones after a long time, many of them could not check their tears.

Several people who came here on Wednesday to meet their relatives said they and their ancestors had been related in various ways for long but the 1947 partition made it hard for those living on two sides of the border to meet.

Nelwashar Barman, 70, of Gobindaguru village under Boda upazila in Panchagarh, came here to meet his daughter Bashonti, who lives in Shiliguri in India. It is 11 years that they met last.

Nurul Haque Prodhan, 60, of Jhotiakhali village of Shiliguri sub-division in India met with his nephew Golam Rabbani, 45, living at Notun Bosti village in Panchagarh. Each year on the first day of Bangla New Year they come to the border to meet with their relatives.

Ananta Roy, 35, of Shiliguri in India came here to meet his father while Ananta Bala, 32, of Farabari village came to meet her brother and sisters.

"Every year on the first day of Bangla New Year people from both sides come here to meet with their relatives. We make the arrangement through discussion with BSF," said Major AKM Hasibul Hossain Nabi, deputy commanding officer of 25 Rifles Battalion.

Company commander of Khalpara BSF Battalion Arun Lal said they unofficially allow people to meet with their relatives on the special occasion considering emotional issue of people.

BSF opens the door of barbed wire fence to facilitate people to come to the border after 11:00am and keeps it open for three hours.

Tendons of BNP leader severed

Criminals cut off tendons of hand and legs of a sexagenarian BNP leader at Jorapukur village in Gangni upazila in Meherpur on Wednesday night.

Police said the incident took place following a dispute over a piece of land between two influential persons of the

According to police, Reaz Uddin Ahmed, 60, former BNP vice-president of Sholokata Union unit and some of his aides occupied five bighas of khas land in the area during the tenure of his party in 2005.

After the change over of power, another group of the same area led by one Tara Alam alias Biscuit, 45, took control of the same land ousting Reaz and his men and distributed it among his followers one year ago.

Recently, Reaz Uddin made documents of land in his favour and filed a case with Gangni police station.

The incident angered Tara Alam.

On the fateful night, Tara Alam with his men went to the house of Reaz at about 11:30pm. They dragged the old man out of his house and chopped him indiscrimi-

the tendons of Reaz's two legs and two hands.

Reaz was rushed to Meherpur General Hospital yesterday, and later sent to Dhaka Medical College Hospital.

Officer-in-charge (OC) of Gangni police station Sagir Mia said they could not arrest the criminals as none filed any case in this regard.

In another incident, at least 20 visitors were injured at historical Mujibnagar mango orchard in Meherpur yesterday as a group of criminals allegedly led by a Jubo League cadre attacked them for not paying illegal toll.

According to sources, a group of visitors went to Mujibnagar mango orchard by a bus at about 1:30pm.

One Menta, 32, known as a Jubo League cadre of the area appeared at the scene with around 10 of his cohorts and stopped the bus at the main gate of the complex.

Menta asked the visitors to pay Tk 200 for visiting the memorial complex.

As the visitors refused to pay the amount Menta and his accomplices attacked the visitors leaving at least 20 injured.

Of the injured, Hasan, 25, Laltu, 23, Yamin, 29, Noyeem, 30, Razzak, 22, Bona, 18, Yasef, 23, have been admitted to The criminals also cut off Meherpur General Hospital.

Police station besieged to free arrestees

Hundreds of people laid a siege to Baya Bazar police outpost and blocked Rajshahi-Naogaon Road under Shah Makhdum police station in the city for five hours yesterday protesting arrest of three family members of a local who was killed over a land dispute.

Angry locals put up barricade by placing the body of Ekram Hossain, 35, of Baliadanga village and logs at different points on the road at around 8am.

Women protesters sat on the road in front of the police outpost while their male counterparts held processions demanding release of the three family members of Ekram.

As police asked them to free the road, the protestors pelted brickbats on the police. They withdrew at around 1pm when senior police officials rushed to the scene and assured them of releasing the

Later a Rajshahi court freed the three on bail at around 3pm and Ekram's body was buried in the evening.

According to police, Ekram's neighbour Deen Mohammad along with his goons mercilessly beat him up on Wednesday morning over a piece of disputed land.

Traders protest leasing of Nagarbari port terminal

Loading and unloading of goods at Nagarbari river port came to a halt yesterday as traders kept shutters of their warehouses down alleging that the authorities concerned leased the port terminal (ghat) to a Jamaat man.

They also decided not to pay toll to the lessee and demanded immediate cancellation of the lease.

They alleged that the district administration leased the port terminal to Ilias Ali, brother of Puran Varenga union Jamaat chief Iman Ali, ignoring the highest bidder.

Bera Upazila Chairman Md Azizul Haque said though a bidder offered Tk 22 lakh to use the terminal, the district administration leased it to Ilias Ali, also a leader of pro-Jamaat traders' association at Nagarbari, for Tk 20 lakh.

4 get life for murder

Four people were sentenced to life term rigorous imprisonment (RI) in a murder case yesterday. ATM Mezbauddoula, special and sessions judge delivered the verdict against Tomser Ali and his son Shajahan Miah and Tomser's cousin Jarina Begum and Rahima Khatun of Katulee in Sadar upazila. The judge also fined them Tk 5,000 each, in default, to suffer six months' more RI. According to prosecution, the convicts attacked Naosher Ali of the same village with lethal weapons and injured him seriously on November 25, 2001. Severely injured Naosher succumbed to injuries on the same day. Victim's brother Nazrul Islam filed a murder case with Tangail police station against 10 people including Tomser Ali.

1 killed in boat capsize

One person was killed as a boat carrying 7 to 8 passengers sank in the Dakatia river at Chandpur after a passenger launch hit it at around 10:30 pm on Wednesday. All the passengers but boatman Hashim Khan, 40, managed to swim ashore. Witnesses said, MV Al Walid, which left for Hularhat from Dhaka, hit the boat at Bhuiyar Ghat area. Seriously injured boatman Hashim Khan was rescued and taken to Chandpur Sadar Hospital where he died. Hashim hailed form Tarabunia in Shariatpur district.

8 Pabna criminals held
