The two leaders of Gapalachipa AL also brought allegation of bribery from different development works including Test Relief and Food for Work programmes, appointment and transfer of government officials and employees in different offices, special projects on rehabilitation of Sidr and Aila victims in the area with the help of his brother-in-law Makbul who was a BNP leader during last BNP-led four-party alliance

government. Besides, Roni ignores the party men in all the activities, the upazila AL leaders said.
