

ALLEGATIONS OF ANTI-PARTY ACTIVITIES IN PATUAKHALI-3

Dist AL for action against Roni

Patuakhali district unit of Awami League (AL) has decided to send its recommendation to the central committee for taking organisational action against Golam Mawla Roni, lawmaker from Patuakhali-3 (Galachipa-Dashmina), for his alleged anti-party activities.

An emergency meeting presided over by district AL Senior Vice President Ismail Hossain Miridha at the district AL office on Sunday night took the decision, said a district AL leader who was present at the meeting.

Roni was absent from the meeting although he was invited there as a member of the district committee, meeting sources said. The meeting discussed

written allegations against Golam Mawla Roni, which were submitted by Galachipa upazila unit AL President Harun-or-Rashid, also the chairman of upazila parishad, and upazila AL Secretary Golam Mostafa Tito.

Earlier on April 8, an extended meeting of district AL held at Patuakhali Circuit House auditorium formed a four-member probe committee headed by district AL President advocate Shahjahan Mia, also state minister for religious affairs, to probe the allegations against Roni.

Six central leaders were present at the meeting. Other members of the probe committee are ASM Feroz, whip of the Jatiya Sangsad and lawmaker from Patuakhali-2 (Baufal), Mahbubur Rahman Talukder, lawmaker from Patuakhali-4

(Kalapara), also state minister for water resources ministry, and Khan Mosharrar Hossain, secretary of district AL.

The probe body had reached a unanimous opinion about taking organisational action against Roni, sources said.

At the meeting on Sunday night, AL leaders criticised Roni for his absence in the public meeting organised by district unit AL at Patuakhali town on April 8.

According to the containing allegations against lawmaker Golam Mawla Roni, which was submitted by Galachipa unit AL president Harun-or-Rashid, and

Secretary Golam Mostafa Tito, Roni's men are harassing party men by filling false cases and torturing them in different ways.

Over 30 false cases were filed against party men at Roni's instructions, goes the statement.

Roni instigated criminals to launch an attack on upazila AL leader Harun-or-Rashid and Galachipa municipality mayor Abdul Ohab Khalifa, it said.

On the National Mourning Day on August 15, Roni did not place wreath on Bangabandhu's portrait while no flags were raised at his local residence on that day, it

added.

The two leaders of Galachipa AL also brought allegation of bribery from different development works including Test Relief and Food for Work programmes, appointment and transfer of government officials and employees in different offices, special projects on rehabilitation of Sidr and Aila victims in the area with the help of his brother-in-law Makbul who was a BNP leader during last BNP-led four-party alliance government.

Besides, Roni ignores the party men in all the activities, the upazila AL leaders said.

DOWRY VICTIMS IN MEHERPUR
 Housewife allegedly commits suicide, two 'tortured'

A housewife allegedly committed suicide yesterday while two others were tortured allegedly by their husband and in-laws in Meherpur on Sunday.

Both the incidents were related to dowry, police and family sources of the victims said.

According to police, Arfa Afroz Pipasa, 20, daughter of Abul Bashar of Boshpara in Meherpur town was married to Haru Mia of Hatbolia in Alamdanga upazila in Chuadanga about a year ago.

Lately Pipasa was staying at her father's house and giving HSC examinations.

Sources said a feud was brewing as Haru demanded Tk 2 lakh from Bashar for 'boosting his business.'

Bashar alleged that Haru often tortured Pipasa and on Sunday night, he phoned Pipasa using abusive words. At about 6:00 am, Pipasa poured kerosene on her body and set afire.

Severely burnt Pipasa was rushed to Meherpur General Hospital.

Doctors sent her to burn unit in Dhaka but she succumbed at Rajbari on the way at about 8:30 am.

In another incident, Shefali Khatun, a 21-year-old victim of torture by husband and in-laws, is now fighting for life at Meherpur General Hospital.

Police said Shefali, daughter of Golap Mollah of Bhoberpara in Mujibnagar upazila in Meherpur was married to Firoz of the same village one and half years ago.

Family members of Firoz did not accept the

marriage and often tortured her as Sefali's father refused to give any dowry.

In January, Shefali was forced to leave her husband's house over the issue and since she was living with her father.

On April 17, Firoz went to Shefali and asked her to go with him saying his family had agreed to accept her.

Shefali told police that bringing her home, Firoz along with his brother Aliboddi and Khoka, tortured her at night.

At one stage, Shefali fainted and presuming her dead, Firoz and others took her to a nearby bush. There they tied a gamchha around her neck to show the incident as 'suicide.'

But after about 17 hours, locals found Shefali and rescued her alive. She was rushed to Mujibnagar upazila health complex and then shifted to Meherpur General Hospital where she is undergoing treatment.

Firoz and his brothers went into hiding while father of the victim Golap Mollah has filed a case.

In another incident at Jhoudia village in Sadar upazila, one Hafizul, 30, allegedly chopped his wife Nazma Khatun, 23, on Sunday evening.

Police said, Hafizul married Nazma of the same village two years ago. He demanded Tk one lakh from Nazma's father. But Nazma's father Karim Hossain, a poor farmer, could not arrange the amount.

At this Hafizul started to torture Nazma and on Sunday he chopped her with a Sharp weapon and fled home.

Nazma is now being treated at Meherpur General Hospital.

Rejoinder

The deputy commissioner and the superintendent of police of Bogra in separate rejoinders have denied issuing orders for arrest of four political leaders in Bogra as reported on page 13 of The Daily Star on April 7 headlined "Bogra DC finally orders arrest of four leaders."

It was stated in the report that Bogra DC had ordered arrest of four leaders of the ruling Awami League's associate bodies as they brought 'corruption' charges against him.

In the rejoinder, the DC denied ordering police to arrest the leaders and stated that no case was filed against them.

Bail prayers of six Shibir men rejected

District and Sessions Judge of Sylhet Md Momin Ullah yesterday rejected the bail prayers of six Shibir leaders and sent them to the jail hajat in a case filed in connection with clash with BCL men. The court, however, granted bail to 38 others.

The court rejected bail prayers of MC College unit president-Yasin Khan, Sylhet Government College unit president-Asaduzzaman Shahin and general secretary-Khairul Islam, MC College hostel unit president Manzur Alam, city unit's organising secretary-Mahmudur Rahman Delwar and finance Secretary Manzur Ahmed.

The aforesaid 44 earlier got bail from High Court. As the bail period ended they appeared before the district judge court yesterday and sought fresh bail.

The clash between BCL and Shibir took place on the Sylhet Government College on February 18 this year, leaving around 30 injured.
