## Notice on CCC for filling up Laldighi

City corporation making swimming pool and building stage

Bangladesh Environment Lawyers' Association (Bela) yesterday served a legal notice on Chittagong City Corporation (CCC) as it is making a swimming pool by filling up Laldighi, the historic water body, in the port

The CCC authorities are filling up Laldighi partially to make a swimming pool and a stage. They are also building a retaining wall to separate the swimming pool site and the

The notice sent to the CCC authorities said Laldighi is a witness to a number of historic events. People who visit Chittagong from

outside take a rest on its bank and mosquegoing Muslim people perform their ablutions using its water.

Besides, the water body plays an important role in maintaining biological diversity of the second largest city of the country, it added.

Laldighi bears testimony to a number of protests, including the anti-British movement, historic language movement and the liberation war.

Copies of the notice were also served on secretaries to environment and forests and land ministries, chairman of Chittagong Development Authority, department of environment, Chittagong and a concerned CCC ward councilor.

### SC stays HC order

The Supreme Court (SC) yesterday stayed for a week a High Court (HC) order that directed the government to allow former Islami Oikya Jote lawmaker Mufti Shahidul Islam to go abroad.

Chamber judge of the Appellate Division Justice Md Muzammel Hossain passed the order upon a government petition seeking stay on the HC order.

The judge also asked the government to file a regular leave to appeal petition with the SC against theHCorderwithinaweek.

During the hearing yesterday, Additional Attorney General MK Rahman told the court that Mufti Shahidul is a listed war criminal suspect.

If he is allowed to go abroad, the investigation into the allegations against him will be hampered, he said, praying to the court to stay the HC order.

## Enact law to ensure rights | Salam Pintu | War heroines demand of women with disabilities

Urge rights activists

Rights activists have called for enacting a new law in the light of UN Convention on the Rights of Persons with Disabilities to ensure rights of women with disabilities and their full participation in the mainstream activities.

They pointed out that women with disabilities face extra threats to personal security because of their vulnerable condition.

Women with disabilities are easy target of physical, sexual and psychological abuse, neglect and many other forms of discrimination, which often go unreported for lack of social and legal support, they added.

According to a study conducted by Action on Disability and Development (ADD), there were about 70 cases of violence against persons with disabilities in the last two years. Of the total number, 66 victims were women with disabilities who faced violence, including rape and murder.

Mentally challenged women face toughest consequences, they study

The rights activists said this at a seminar organised by National Council of Disabled Women at the National Press Club in the city yesterday.

They called on the government not to treat the issues of persons with disabilities on the basis of charity.

Dr Akbar Ali Khan, former adviser to a caretaker government, said neglect of society and attitude towards women with disabilities lead to their immense suffering. If women are termed as marginalised, women with disabilities are at the bot-

Issues of women with disabilities are now addressed by three ministries -social welfare, women's affairs and education. The government needs to coordinate these three ministries and increase allocation for this sector, he added.

There are no recent data available on challenged women in the country. According to a survey conducted by World Health Organisation, persons with disabilities constitute about 10 percent of the population in Bangladesh, which is about 15 million.

Different non-government organisations have mentioned that there are roughly 7.5 million women with disabilities in the country. Only two percent of these women get the opportunity of education.

The speakers stressed the need for education for women with disabilities linking with education ministry instead of social welfare ministry, introducing special stipend for them, including issues of women with disabilities in the curriculum and conducting training for teachers on special education, especially Braille and sign language.

Mosharraf Hossain, country director of ADD, also spoke, among others.

# trial of war criminals

Women who were repressed by the Pakistani occupation forces during the liberation war in 1971 have demanded trial of the war criminals. Locally known as Biranganas, the women also demanded dignity in society and means to

survive. They raised the demands in a documentary titled 'Cries of Birangana Women and Demand

for Justice' directed by Shafiqul Islam Kajal. "Is our duty finished after liberating the country? When would trial of the collaborators be held?" questioned Birangana Achhiya of

Kobdaspur village in Sirajganj. Surya Begum, 52, Bahatan Begum, 70, Noorjahan Begum, 50, Rahela, 52, Rahima, 72, and Acchiya, 50, demanded trial of the war collaborators in Sirajganj who are responsible for mishaps in their (women's) lives.

They questioned why they would be neglected in the society. Have they really committed any sin? Why the collaborators - Quddus of Kobdaspur, Sayeed of Sayadhangara, Badsha of Rahmatganj - were not punished even after committing heinous crimes?

Birangana Ayesha said, "The freedom fighters had fought with arms, but we had sacrificed our dignity and happiness. The freedom fight-

but we do not even get funeral." The Biranganas do not want families, hus-

ers get allowances and state honour after death,

bands, children, but meals twice a day and recognition from the state. The cries and sorrows of the Biranganas

have been reflected in the documentary by Shafiqul Islam Kajal. Kajal told BSS in Mujibnagar recently that he got inspiration to make the documentary from

the life of a Birangana, Manjura. He saw the struggling life of Manjura from his childhood and heard from his mother and

neighbours about Manjura's sacrifice during the Liberation War. Manjura died on May 19, 1998, but there was none to conduct her funeral. Even the progres-

sive people did not come forward to take part in

her funeral prayers. Later, she was buried on the evening of May 19 with the help of a local Kajal said trial of the war criminals should be held quickly. Holding trial of the culprits would

be showing honour to the Biranganas, he observed. He also stressed the need for rehabilitating

the Biranganas. This will not require a large amount of money, he said.

Bangladesh Occupational Safety, Health and Environment Foundation (OSHE) formed a human chain yesterday demanding a national policy on occupational health and safety. The programme was held

in front of the National Press Club in the city. Speakers gave an account

of total deaths and injuries of the workers in their respective jobs across the country. A study conducted by OSHE said in 2009, some 1,639

workers died and 1,858 were left with injuries in several accidents related to their jobs. It was carried out based on the newspaper reports. Again, 394 workers died and 479 workers got injured at their workplaces in incidents like

explosion, fire, electrocution and falling from height while 367 died and 883 got injured overworkplace violence. The speakers said though Bangladesh Labour Law 2006 has different provisions securing health and safety of work-

ers, it requires an immediate formulation of rules to implement the law for their interests. Saki Rezwana, chairperson

of OSHE, Mamunur Rashid, general secretary of Bangladesh Free Trade Union Congress, Omar Faruk, programme officer of OSHE, and Mina Pande, project coordinator of Building and Woodworkers International (BWI), were present at the programme.
